San Jose: Moved into a new home we're proud of, at 760 Emory St. Work is exceptionally


North Bay: In high gear on highways and housing.

FREEWAYS, BAY JOBS SPARK S. F.

New contracts for work in the San Francisco area are steadily increasing. The congestion of traffic travelling in and about the city calls for speedy relief in the way of new freeways. Shoreside projects are also in the news this month.

M. & K. Corp., was the low bidder (\$21/2 million) for widening and realignment of upper Market moved from the location of the Street to the end of Portola Drive. Southern Freeway it is expected This job is expected to start in about thirty days.

Theo Meyer & Sons was the succesful bidder for the excavation of Civic Center Park, A new Civic Center exhibit hall, and garage, will be constructed underground and the park replaced in its present form. The bid was \$3,711,315.

Utah Construction Company's job of a 200 acre industrial subdivision is making good progress. More than two million cubic yards of dirt is being dug up and hauled across a special one mile road to the new park site where it is dumped on the mud flats to bring it up to an average level of five feet above mean high tide. A hill consisting of 80 acres will be dug away to provide the fill dirt.

On Guy F. Atkinson's job at Sierra Point they are filling over the last piece of water to connect the two ends.

Another large job to be let for bids is the Yacht Harbor expansion to cost about five million dollars. Construction of additional breakwaters and extension of present harbor to boost mooring capacity from 232 boats to an estimated 1,000 is planned.

Pacific Pavements Company have numerous street 'resurfacing jobs going on. The newest street job is Westwood Park Street for a sum of \$110,780.

Hary & Hynding, Inc., have a \$509,654 job for construction roads and parking areas at Laguna Honda Home.

Pacific Bridge Company has started a big project at the San Francisco Naval Ship Yard at Hunter's Point, the building of a submarine keywall to replace the existing timber dock that, incidentally was built by Pacific Bridge in 1943.

Building of this keywall, 660 feet long by 60 feet wide, will cost many engineers. approximately \$1,300,000.

At a special meeting on Tuesday, August 7th, the Technical Engineers membership of Operating Engineers Union Local No. 3 voted unanimous approval of the 1956-57 Master Agreement with the Bay Counties Civil Engineers & Land Surveyors' Assn. The new contract calls for across the board increases of 15 cents per hour for Party Chief, Instrument Man, Senior Inspector, Inspector, and Field Assistant, Class II. Field Assistant, Class I (Head Chainman) received an increase of 27 cents per hour. Other additions are time and one-half pay for time spent traveling over a 40-mile round trip. Per diem for 7 days: \$6.50 per day. This agreement runs for one year with the expiration date August 6, 1957. New wage scales are as follows:

Chief of Party \$3.35 Senior Inspector 3.35 Inspector _ 3.075 Instrument Man 3.075 Field Assistant (Class I) 2.67 Filed Assistant (Class II) 2.45

Marysville Area Busy; Gold Pact is Approved Sacramento Area

The dirt is flying throughout the Marysville area at present and we hope this favorable situation will continue for the rest of the season.

This month we want to write an article on transportation or how to get to a tunnel or tunnels. This mostly concerns Utah, Bates & Rogers Const Co. on the Poe job.

To get to Adit No. 2, you drive your car off the highway about five miles, down into Feather River Canyon and then ride a highline cableway car about 14 miles across the canyon about 200 ft. above the river bed. To get to the Surge Chamber, you drive about one mile further and over the W. P. tracks; then take an incline car and go about 700 feet up a 70% grade, but you ain't heard nothing yet . . . to get to Tunnel No. 15 at Storrie, Calif., you walk up 222 steps, and Brother, when you get there, you are certainly short of breath. Then on the Utah Keddie job, they send a motor car in and haul you about three miles to see the men on that job. So you can see by this, you use everything but mule back to visit the jobs.

All of them are progressing very well and Bro. Paddy O'Dowd is doing a real good job at Adit No. 2.

Walsh Const. Co. is doing the best they can to get Caribou and Butt Valley Tunnels started. They are having a little trouble with road and other conditions but will be going good in a day or two. Darkenwald Co. just about through on the access roads at Caribou, but will start putting on the gravel real soon and it will be a lot better for the men who must travel that road.

Granite Const Co. is starting their 17 miles of paying on 40A near Quincy. Halverson Co. is just about to wind up their road job at Spring Garden. It has been a tough one, too. Utah Const. Co. is trying to rush the tunnel lining job near Keddie and get ready to move to Tunnel No. 15 at Storrie, which is a new one with 3,100 ft. to line with concrete. This job, we hear, has No. 1 priority.

GOLD DREDGING COMPANIES:

A satisfactory agreement has been reached with the Yuba Consolidated Gold Fields, which has been submitted to the membership employed by that firm, and accepted by a substantial majority in secret balloting.

Before this article reaches you, according to the Company, back pay checks, retro-active to June 1, 1956, including the difference in vacation pay, will have been out and should be in your hands.

The matter of the Welfare Insurance has been straightened out. there were a few minor details that required meeting upon, and the agreements have been signed in accordance with your instruc-

In the very near future, we hope, the agreements will be printed in booklet form as has been the custom, and a copy mailed to each member. Also before long the booklets on the Welfare Insurance should be available by the insurance companies and ready for distribution.

As we do each year we are advising you to read both and familiarize yourself with the contents. A working knowledge of both, especially of the insurance provision, may mean money to you and a working knowledge of the agreement may protect your job, besides making you money if the Company does not comply with it.

If you have any questions about either, remember your representative is always available to advise you and if he doesn't have the information you want at his fingertips he has the means of ascertaining and getting it to you.

Occasionally a member has a grievance about a violation to the agreement or an insurance claim and waits an unreasonable length of time before reporting it. Sometimes this is because he doesn't run into the representative at the seven day operation, weeks or longer may go by before he runs into you.

So either have your committeeman report it for you or you report it to the office by telephone or in person. In this way we can immediately, while the matter is still fresh in everyones minds, make an investigation and see that the proper adjustments are made. We haven't lost any cases over the timeliness of the grievance, but there is always the first time. DUES, INITIATION FEES:

You are hereby notified that effective July 1, 1956, for the members employed by the Natomas Company and August 1, 1956, for the members employed by the Yuba Consolidated Gold Fields, the dues and initiation fees will be as follows:

Dues-\$4.00 per month. Initiation Fee-\$25.00.

All the above members after they have paid these dues for six months will be blanketed into the Burial Benefit Fund and at time of death, if they are in good standing as provided by the Constitution of the of the International Union, their beneficiaries will be entitled to the payment as provided by the Burial Benefit Fund By-Laws. (This is in addition to the International Union Burial Benefit.)

Initiation Fees collected through the check-off will be collected in two equal monthly installments.

A hot problem, and we mean literally a hot problem, has arisen time. Remember on a three shift, in the new tunnel kiln area. SWEDISH HYDRAULIC JACKED SLIP FORMS

The first Hydralically jacked slip forms used in California is now currently being used at the Carquinez parallel bridge project at Crockett, California. Two contractors Peter Kiewitt & Sons and Mason, Hanger, Silas Mason and Rolandi joint venture, are using the new system for which world patents are controlled by a Swedish Engineering Firm.

Exclusive Licensing Authority in the United States is controlled by B. M. Heede, Inc., Long Island, New York.

Peter Kiewitt & Sons have finished six large piers using this new system and plans to use the same method in erecting 40 more piers of various sizes and heights. Mason, Hanger, Silas Mason and Rolandi used this same method of constructing a large abutment pier on the south or Crockett side of the Carquinez Straits.

The piers Peter Kiewitt & Sons are erecting are to be used for construction of the bridge approaches and inter-change structure on the Crockett side. The 40 piers vary in size from 8x70 ft. to 4x33 ft. The most frequent sizes are 8x37 ft. and 6x22 ft. All of the piers are hollow with the exception of the 4x36 ft. and 4x22 ft. piers which are solid. These piers vary in height from 18 ft. to 121 ft.

All jacks in the system are controlled automatically. However, other controls are also important. Alignment is checked hourly by Engineers of the California Division of Highways. Speed of pour is controlled by the hardening rate of the concrete which is checked frequently by thrusting a steel rod into the pour to determine the depth of hard concrete. The speed varies from 10 in. per hour in warm weather to 4 to 5 inches at night. The operation of these pours are on a 3 shift, 24 hour basis. The concrete is being furnished by Sugar City Building Materials of Crockett, and hauled in transit-mix trucks to the piers. It is than hoisted to the forms in a Gar-Bro bucket by a Northwest 95 crawler crane with a 133 ft. boom plus a 20 ft. jib. The completion date for this job is November 1958. The project manager for Kiewitt is Homer Olson, Brother Sailor Hamby is master mechanic on this job. On the Northwest 95 we have Brother Rex Richardson operator with Jack Mauser as his oiler, Brother Loren rig runs three shifts around the clock with the shifts rotating every three weeks,





NLRB Needlessly Restricts Jurisdiction, Members Charge

sistence of the Eisenhower-appointed majority of the National Labor Relations Board in rejecting jurisdiction in many labor disputes, the Truman-appointed minority has demanded a sweeping revision of present jurisdictional

The minority—Abe Murdock and Ivar H. Peterson—has just issued one of its most sharply worded dissents in a case involving Local 549 of Teamsters and the Dixie Coca Cola Bottling company in Bristol, Va. The majority refused to order a representation election on the grounds that the company's business was not large enough to satisfy the Board's strict standards laid down in 1954.

After pointing out the "intrinsically illogical and indefensible standards which are productive of such absurd results as found" in the Dixie case, Murdock and Peterson declared:

"As we have observed in the recent past, the existing machinery of the Board is undeniably geared to handling a larger number of cases than have been produced by the 1954 standards. Many employers, employees and unions are being needlessly denied the facilities of this Board contrary to the Congressional policy.

"Unless a majority of the present Board is irrevocably committed for doctrinaire reasons to

Labor Asked to Help In Vaccine Program

The U.S. Public Health Service has asked the AFL-CIO to alert its membership to make "the prompt and fullest use" of Salk polio vaccine as it becomes increasingly available.

With supplies of the vaccine expected to catch up with demand in the near future, the service said, the use of the increased supply "will be a real challenge to medical and community leaders."

By expanding immunization programs even during periods of rising polio incidence it should be possible to protect many more children and pregnant women-the groups at greatest risk --- before the peak poliomyelitis season of late summer and early fall. Vaccine given in July and August will prevent paralytic cases and even deaths in August and September."

Obviously angered by the per- and more parties are remitted to the law of the jungle, an 'early general liberalization of the 1954 standards is indicated as well as the elimination of the inconsistencies and anomalies.'

Murdock and Peterson were particularly incensed because the majority's standards, when it will and will not take jurisdiction, are stricter for interstate corporations than it is for companies doing business in one state only. Thus it will take jurisdiction if a company does \$50,000 worth of business in a single state, but rejects jurisdiction over a company doing business in more than one state unless it does \$250,000 worth of business.

This, declared Murdock and Pe-Peterson, is absurd because it lays down the principle that a small company in one state is more important to commerce than a large company that does business in more than one state.

\$5 Billion Calif. **Works Program**

Governor Goodwin J. Knight last week unfolded the broad outlines a of long range building program -a five-year, five billion dollar plus public works program to be financed jointly by the State and federal governments.

The program, the governor revealed, will involve the expenditure of almost six billion dollars during needlessly restricting the scope of the next 60 months-an average of \$100.000,000 every 30 days betw now and 1961.

The construction program outlined by the governor covers the following eight points:

1. \$870,000,000 in expenditures for the state for the Feather River

water project. 2. \$70,000,000 in state expendi-

tures on flood control projects. 3, \$440,000,000 by the Army

Corps of Engineers and

4. \$340,000,000 by the Federal Bureau of Reclamation on the Trinity Dam, the Central Valley projects, and various other federally-sponsored projects.

5. \$500,000,000 in state expenditure for construction of colleges, mental hospitals, penal institutions, veterans' homes, forestry honor camps, state office buildings and other state requirements.

6. \$500,000,000 in state aid for new school construction.

7. \$1,000,000,000 for the State Veterans' Farm and Home Loan Purchase program.

8. \$1,500,000,000 in state outlays. for construction and maintenance of highways, to which will be added more than \$500,000,000 in federal assistance under the President's highway program just enacted by Congress.

These headquarters will be located in Lewiston about 10 miles down the stream from the main dam site. This will be quite a project-and includes 45 two-bedroom houses, 45 three-bedroom houses, office buildings, dormitories, shops, warehouses, etc. On August 30, the Bureau will also open bids on approximately six miles of access roads and bridge approach for the Trinity River Bridge situated near Lewiston. About 150,000 yards of rock excavation and close to one million yards of earth excavation will be called for.

J. W. Briggs, of Bend, Oregon, was the low bidder on the U.S. Forest Service road, at Salt Creek. His bid was for \$645,000. There are 95 acres of clearing and grubbing to be done here and 861,000 cubic yards of roadway excavating. A lot of this is rock, rough and rugged.



Housing Starts At 104,000 in June

Nonfarm housing starts declined a little more than seasonally in June to 104,000 units, the U.S. Labor Department reported.

The total, which included 1,700 publicly owned units, was 4,000. less than in May, and 30,000 below the June 1955 figure, the Department's Bureau of Labor Statistics said.

Private starts were at a seasonally adjusted annual rate of 1,-070,000 units. The average rate for the first 6 months this year was about 1,120,000 units.

Some 570,000 public and private units were started in the first half of 1956-18 per cent less than the 695,000 begun during the same period of 1955. The decline was greater in metropolitan than in non-metropolitan areas, reflecting in part an especially sharp drop, 30 per cent, in housing begun under FHA-VA programs. Such housing tends to be concentrated in larger places, BLS pointed out.

Final estimates for the first quarter of this year indicate curtailment of homebuilding in each of the four broad regions of the country compared with January-March 1955, Decreases ranged from 8 per cent in the North Central region to 18 per cent in the West, with 13-per cent declines in the Northeast and South.

Teachers to Seek **Bargaining Right**

A Nation-wide drive to secure collective bargaining rights for public school teachers with its Locals as bargaining agents, will be signaled at the Fortieth Anniversary Convention of the AFL-CIO American Federation of Teachers in Pittsburgh, Pa., this month.

Carl J. Megel of Chicago, A. F. of T. President, announced that the collective bargaining plan will be "top agenda" at the convention which will run through the week of Aug. 20 in the Penn-Sheraton Hotel in the Steel City.

"While collective bargaining is basic in other AFL-CIO affiliates, it is generally a formula new or recent to teachers," Megel said. "It has been pioneered successfully in some school districts, however, to improve teachers salaries and working conditions.

"Generally, it is going to mean teachers' representatives sitting across the table from school boards or board committees to reach agreements that can be put into written contracts with the teachers' union."

The Department of Labor has released a new publication designed to present a nontechnical, comprehensive account of the Department's work during the past year.

This publication, entitled "The United States Department of Labor . . . Today," discusses such subjects as income insurance, safety and health, migrant labor, law enforcement, child labor, employment problems of older workers, problems relating to the skills of our work force, international labor legislation and the 1955 econ-

ROSA AREA HAS MAJOR JOBS

Construction started this week on the first four "wheel spoke" wings of the Santa Rosa Inn. Street grading is under way. The swimming pool which will be in the center of the Inn "spokes" will be started next week and the main Inn building, lobby and activities center, will come next. The Inn will be on a scenic 30 acres on Fourth Street at Farmers Lane. The City Council has taken

steps to create a Planned Community District for the area which will provide architectural and land use control over new construction. Discussing the proposal, cial corporate interests which wield flexibility should be maintained in the district, due to changes which might be made in the developer's plans as construction progresses.

The exact re-location line of Highway 12 (Fourth Street) which is to be improved to a four-lane highway by the state are not yet determined.

The fourth of five major sewer trunklines designed to serve areas of Santa Rosa expansion-the Los Alamos Trunk - will cost an estimated \$201,059.

The city ha sold \$2,225,000 worth of those bonds to pay for the engineering and construction of the first two trunklines (the Crosstown Trunk and the North Trunk point and pumped through the -now being built) and the engineering of the other three.

Both the Rincon Trunk and the Los Alamos Trunk will serve portions of Rincon Valley. Effluent collected by those two lines-along with that of the fifth line, the Bennett Valley Trunk-will be dumped into the Crosstown Trunk to the treatment plant west of town.

It has been recommended that the construction contract be the contract for the Rincon

The Los Alamos Trunk will consist of approximately 14,500 linear feet of pipe ranging in diameter

It will tie into the Rincon Trunk east of the confluence of Brush Creek and Santa Rosa Creek, and go east and south along a routegenerally north of Santa Rosa Creek and south of the Sonoma Highway, to a terminal point at Los Almos Rd.

It is designed to serve, generally, areas south of Sonoma Highway, plus areas north of the highway in the section east of Calisto-

Under the laws regulating the type of bond-financing being used by the city for the sewer projects, the lines may be built only to incity areas. Anyone getting service from the lines-direct or indirect -must annex to get it, and must pay the required connection fees. RUSSIAN RIVER

Construction of the \$2,350,000 Russian River Aqueduct No. One, which will move Coyote Valley Dam water from the river as far as Santa Rosa, might begin this

Sonoma County officials agreed they will shoot for a start on the river intake works in September instead of late next spring.

Starting the gravel-bed intake works this year would result in a faster and better co-ordinated construction schedule.

Overall county objective is completion of the aqueduct in time to deliver Coyote Dam water to Santa Rosa in May, 1959.

Labor has always had a vital interest in the field of industrial injuries and the benefits provided for and payable under the Workmen's Compensation Laws. Occasionally, it will take note of the gains and progress made in this field in order that it may assess its position and determine its future aims and pro-

California has now progressed, in this field, to the point where benefits payable under this law for onthe-job injuries are, generally speaking, as extensive as those provided under the laws of any other state. Recent legislative enactments have added to these benefits and revised the techniques of their administration. These advances include:

1. An increase in the statutory wage-base upon which the amount of weekly compensation benefits are determined; from a \$9.75 minimum to \$15.

2. An increase from \$35 to \$40 in the amount of weekly indemnity payable for temporary disablement caused by on-the-job injuries.

3. An increase from \$30 to \$35 in the amount of weekly indemnity payable for permanent disability caused by on-the-job injuries.

4. An increase from \$30 to \$35 in the amount of weekly indemnity payable in cases of permanent disability for on-the-job injuries in those cases where the probable earnings of an injured minor at age 21 years cannot otherwise reasonably be ascertained.

5. An extension to all earnings basis of the aggregate limit of 240 weeks of temporary benefits.

6. An increased death benefit: (1) in the case of a surviving widow from \$7,000 to \$10,000, and (2) in the case of a surviving widow with one or more dependent minor children from \$8,750 to \$12,500.

7. An extension of partial dependency benefits payable to a maximum of \$10,000 based upon an increased wage-base formula; and

8. An extension of the presumption as to hernia, pneumonia and heart disease compensability to certain public (police) officers.

In these changes labor has reaped substantial gains. Credit for their enactment must be given to Governor Goodwin J. Knight for his sympathetic consideration of labor's interests in the bills carrying these extended benefits and to around Salinas.
