A LETTER FROM THE GENERAL PRESIDENT.

General President's Order invoking International Supervision over Local Union No. 3 and Its Branches

Dear Sirs and Brothers:

In accordance with the power and authority vested in me as General President, by the Constitution of the International Union of Operating Engineers, I hereby place Local Union No. 3, its Branches and the officers and members thereof under the direct supervision of the International Union, effectively immediately.

To fulfill the purpose of this action, I hereby appoint and designate General Vice President Newell J. Carman as my deputy and as the International's Supervisor over Local Union No. 3, its Branches, and the officers and members thereof. In administering the affairs and business of Lolunion No. 3 and its Branches, General Vice President Carman will be acting solely for the benefit of Local Union No. 3, its Branches, and members and shall at all times be under my direct supervision and control. To this end General Vice President Carman is specifically instructed to conserve the funds and assets of Local Union No. 3 and its Branches, and is further instructed to permit no expenditure of funds and assets of Local Union No. 3, its Branches, for any purpose other than to satisfy the expenses of normal operation.

There is also, attended upon the responsibilities of General Vice President Carman, as Supersor of Local Union No. 3, its Branches and officers and members thereof, the duty of restoring to Local Union No. 3 and its Branches, whatever status as a respected labor organization they may have lost due to the conditions which have existed within Local Union No. 3 and its Branches, and to take whatever other action he deems necessary, subject to my approval, in causing Local Union No. 3 and its Branches to accomplish the purposes for which they exist.

General Vice President Carman has the complete authority, subject to my approval, to appoint such assistants and officers as may be necessary for the proper conduct of the business and affairs of Local Union No. 3 and its Branches. In this connection, he is granted the authority to remove from office or employment any person presently holding any office or position within Local Union No. 3 or its Branches, or presently employed by Local Union No. 3 or its Branches.

The present officers, representatives and employes of Local Union No. 3 and its Branches, are directed not to interfere with or impede the administration and business of Local Union No. 3 and its Branches, and are directed to render full cooperation and assistance to General Vice President arman. Further, any member, representative employee or officer, presently in possession of property, funds or other assets belonging to Local Union No. 3 or its Branches is directed to forthwith turn such property, funds or other assets over to General Vice President Carman. General Vice President Carman is instructed, upon assuming control and supervision over Local Union No. 3 and its Branches, to immediately procure an audit, by a Certified Public Accountant, which will disclose the funds and assets of Local Union No. 3 and its Branches.

This imposition of International Supervision over Local Union No. 3, its Branches, and the offirs, representatives and members thereof, has been deemed necessary, and is being done, as a result of evidence adduced before the General Excutive Board of this International Union at its meeting held on the 4th, 5th and 6th days of September 1957, when that body conducted the trial of Victor C. Swanson, former Business Manager of Local Union No. 3 and its Branches. This evidence disclosed that the affairs of Local Union No. 3 and its Branches were not being administered in a manner consistent with the best interests of the membership; that the affairs of Local Union No. 3 and its Branches appear to have been carried out in an incompetent and negligent manner; lat its former Business Manager, Victor S. Swanson has, and some of its other officers and representatives may have violated the Ritual, Obligation, Laws, Rules and Decisions of the Organization and the Constitution of the International Union; and that the best interest of Local Union No. 3 and its Branches and the International Union requires this immediate imposition of Supervision.

With this imposition of International Supervision, you are hereby notified that a hearing, to determine whether this emergency supervision will be terminated or continued, has been set for Tuesday, the first day of October, 1957, at 10 a.m. in the St. Francis Hotel, San Francisco, Cali-

rnia, before deputies appointed by me, at which time full opportunity to be heard will be given to any member or officer of Local Union No. 3 or its Branches. Upon the conclusion of the hearing the deputies will make their report to me of the facts ascertained, together with their recommendation as to termination or continuance of the supervision imposed, with the decision, however, as to such termination or continuance being made by me. General Vice President Carman shall and is hereby instructed to notify the officers, representatives and membership of Local Union No. 3 and its Branches of the time and place of this hearing.



After a slow start in employment this year we are happy to Ironworkers foreman told him report that equipment operators are again in demand. We are short of operators in several classifications.

The San Francisco Chamber of Commerce has asked the California Highway Commission for \$34,900,000 for major San Francisco Freeway Projects. Twentynine million for full development of the Southern Freeway from Orizaba Avenue along the S.P. tracks and Alemany to the Bayshore Freeway junction. Another six million was requested to add two lanes to the Golden Gate Bridge approach from Richardson Avenue.

Work has started on the second leg of the Central Freeway one mile from South Van Ness Avenue to Turk Street. Peter Kiewit Sons & Company has this \$7,800,000 contract. Fay Improvement Company will do 90 per cent of the grading and clearing. Raymond Concrete Pile Company have a sub-contract for driving 2800 piles. Judson, Pacific Murphy have a contract for all steel work on this project.

The "Sidewalk Superintendents Club" watching the construction of Crown Zellerbach's 22-story building at Sansome and Market Streets was officially opened and a ceremony was held with Mayor Christopher in attendance. A row of bleacher seats have been erected along the Pine Street side so the "Sidewalk Superintendents" can watch the job in comfort.

The three-week strike against the Ready-Mix Concrete firms ended last week. Substantial gains in wages and health and welfare premiums were obtained. We were glad to see this settled as the work stoppage caused several jobs in the downtown San Francisco area to shut down.

Barrett Construction Company was awarded the contract (\$3,817,000) for construction of a seven-story office building for the Department of Finance, State of California.





Just who is it that is advocating this misnamed union busting legislation, called "right to work" in the Marysville area: Is it working men or women or members of labor unions anxious to escape the shackles of the "labor bosses"?

Not so that we have been able to ascertain. As far as we can find out there is not one working man or woman or union member who is to be found among the proponents of this measure, unless they have them hid so far in the background that we can't find

Now it would seem to us, and we believe also to reasonable people, as it is the working men and women who are so desperately in need of this protection, according to the proponents. that it would be the workers themselves who would be advocating this so-called "protection" that this law is supposed to accord

Just who are these people whose hearts are bleeding for our rights in this area. It is a committee who have adopted for themselves a high sounding and clever name. The Committee for Voluntary Unionism. A title which like their proposal and their purpose is misleading.

On this committee are a cannery owner, a half dozen owners of big "factory farms." and a few local business men who have been pressured, according to reports to us, in giving their support. Back of them stands their inspiration, the California Employers Association, whose love for labor has pretty generally soured. But no working stiffs.

The money being used isn't local money cheerfully donated by the workers either, but according to pretty authentic reports to us, comes in a big check from Los Angeles, the heart of the antilabor forces in California. And we have a sneaking hunch that back of the whole rotten movement stands the N.A.M., which has more fronts than the Commies.

Their purpose, if they told the truth, is to destroy your union or at least make it ineffective. And by this means lower your wages, decrease your working conditions, lengthen your hours and, not incidentally, increase their profits.

Oh no, they say, we are not against unions. Sure they're not as long as they are ineffective or, in other words, on their knees, but it is a different story when they are strong enough to stand on their own feet. And so they want to make it easy for the "free rider" or the chisler to create dissension in our ranks, and make it easier for the chisling employer to chip away at our strength until we can no longer effectively protect our members.

So if you want to keep your wages up, your working conditions, your welfare insurance, pensions and your community economically sound let your County Board of Supervisors know, and have your neighbor do likewise, that you oppose this vicious anti-labor ordinance.

New Jobless Benefit Scales Now Provail

A new scale of unemployment by the provisions of the Califorinsurance benefits will go into nia Unemployment Insurance effect September 11th under legislation passed by the 1957 State Legislature and signed into law by Governor Goodwin J. Knight.

The present scale of benefits ranges from \$10 to \$33, depending on the amount earned during the highest-earning quarter of the "base period." The new scale ranges up to a maximum benefit amount of \$40 for highquarter earnings of \$1120 and

The increase will apply only to new claims filed on and after Sept. 11th. The 1957 session also nacted legislation fixing at five weeks the disqualification period for a worker quitting employment without good cause or for discharge for misconduct connected with his work. The present disqualification period is a two-to-five-week period.

Specifically, workers covered by either the state plan or a voluntary plan of disability insurance will be egilible for a scale of benefits ranging from \$10 to \$50 (compared to the present \$10 to \$40) - the maximum based on high-quarter earnings of \$1125 and over.

The new scale of hospital benefits provides for \$12 a day up to 20 days, compared with \$10 a day up to 12 days.

Wage-earners also will pay more for the increased coverage. Present law provides for worker contributions of 1 per cent up to the first \$3000 earned in the calendar year. Starte ing in 1958 the new maximum will be \$3600.


