The year in review

There's not enough space in this entire month's magazine to give you the full depth of what's gone on this year for our membership, so consider this my best summary. Between political opposition, record floods and one of the worst fires in national history, many of us don't have time for much reflection. Some of us are just trying to catch a breath, whether it's because we've worked overtime for months on the Oroville Dam spillway, or we're living in tight quarters with family because our homes were destroyed in the North Bay fires. Whatever your story is, it's important to look back and learn from the past, so we can be as strong, effective and united as possible in the coming year.

Big projects like the new phases of High-Speed Rail (HSR) (Fresno District 50) and a giant residential/commercial building boom in San Francisco (Burlingame District 01) kicked the year off with good hours, as did the emergency work resulting from massive storms, flooding and slides throughout our jurisdiction. The Truckee River flooded downtown Reno in District 11, the big Hwy. 299 French Creek slide in Redding District 70 closed that road for months and Pfeiffer Bridge and several patches along Hwy. 1 were shut down in Morgan Hill District 90 and Rohnert Park District 10, respectively. Operators provided cleanup, repair and demolition in countless storm-ravaged areas to get the roads, bridges and bypasses safely open to travelers as soon as possible.

The storms caused major damage to the Oroville Dam and spillway this year, as a huge chunk of the spillway eroded in early February. Oroville residents were eventually evacuated, and operators were called-in for around-the-clock emergency repair, which resulted in a more than \$275 million repair/rebuild project that is ongoing. Hawaii District 17 enjoyed a rise in noncommercial repair work, as many of their larger commercial projects were completed. The 75-year-old Antlers Bridge across Lake Shasta was removed by detonation (operators built the original) and the new one was completed. Another big demo included the historic Sutter Memorial Hospital in Sacramento District 80, while giant builds included the Golden State Warriors stadium in Mission Bay, which is ongoing, the Salesforce Tower in San Francisco and the Graton Casino and Resort in Rohnert Park District 10. Districts like Stockton District 30 and Oakland District 20 enjoyed major growth in subdivision work, which created huge needs for operators.

Districtwide, our dispatchers reported openings in nearly every kind of position this year. To fill these orders, we organized giant recruitment fairs in Livermore and Sacramento, signing up over 100 new members, who expressed thanks for the opportunity to gain lucrative, life-long careers. As I reported earlier this year, we had a nearly 218,000-work-hour increase over last year (from January to June) and have seen a continuous increase in new employers signed during this same timeframe.

As more and more Operating Engineers retired, we recruited, organized and got the word out across our jurisdiction, resulting in huge increases in journey-level upgrades and apprenticeship classes at our union-wide training centers. California's Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC) held one of its largest apprenticeship graduations, while Nevada's Training Center apprentice enrollment more than doubled in size. These fine operators graduated with an understanding of the importance of their union, as several of our apprentices and new graduates have been featured as activists for their careers and the legislation that impacts them. Standout Meg-Anne Pryor, for instance, spoke with House Minority Leader Nancy Pelosi during a news conference recently on local apprenticeship programs.

This year was a big one for contracts. Thanks to an overwhelming turnout of membership and participation, we

secured one of the best Crane Rental agreements in this union's history. After several targeted rallies, countless bargaining sessions and communication campaigns, our state Unit 12 members also effectively negotiated their bargaining agreement with the state of California. Utah District 12 also enjoyed the ratification of two big agreements, Wheeler Machinery and Smith Power Products. (This is just a sampling.)

Regarding our membership, we made great strides in communication, as we geared-up for the outcome of the ongoing Janus vs. AFSCME case with the Supreme Court, including territory-specific e-mail blasts, contract wins and greater involvement in our bargaining sessions, as more money is freed up in the county coffers. We also won several arbitrations this year, either getting members their jobs back or protecting those jobs from the non-union.

We entered this year with political uncertainties after the election of the current president. We vowed to work with him if he'd meet us halfway, as did the International Union of Operating Engineers (IUOE), but we cautioned him and his administration that if they messed with national Right-to-Work (for less) legislation and our prevailing wage laws, we'd be ready to fight. We proactively partnered with many labor councils and Building Trades to protect these issues. This included attending the Western Region Fighting National Right to Work Summit in Los Angeles, working to secure pro-union legislation, such as in Nevada where contractors will have to pay prevailing wage on more projects, thanks to Assembly Bill (AB) 154, and more apprentices will get work thanks to Senate Bill (SB) 357. We also helped pass important transportation bills, such as California's Senate Bill (SB) 1, which will dedicate \$52 billion to transportation projects statewide for the next 10 years, as long as voters don't try to overturn it next year.

Unfortunately, for some of our union families in the counties of Napa, Lake, Sonoma, Mendocino, Butte and Solano, the year ended in devastation, as over 245,000 acres burned to the ground and close to 10,000 structures were destroyed by one of the worst fires in California history. Members and staff from Rohnert Park District 10 and the surrounding districts stepped up to the plate, first cutting firebreaks, using water supplies to save as many homes as possible and replacing power lines, while others donated food, money, clothing and shelter to those in need in these areas. We coordinated emergency 40-hour and eight-hour Hazmat classes and worked non-stop to secure the cleanup work for our members, proving to federal and state agencies that we had the manpower, the skill and the commitment to do the best job for the cleanup in these areas, because we lived in them. Currently this work is ongoing, and we will be needing Hazmat-trained operators for a long time. Signatory contractors have donated countless equipment and supplies, and surveying companies will be donating their surveyors for the rebuild. I want to thank all the Local 3 staff, including those from the OE3 JATC and our officers for their efforts in this process. The takeaway is that we are a union, but we are also families, communities and neighbors, and we help when help is needed.

That has been the overall theme this year. Despite violence, turmoil, natural disasters and political division, Local 3 always finds a way to give a hand and stand strong, even when it is hard to do so. It's safe to say many of us are tired. Hopefully you can catch your breath this holiday season, gather with those most important to you and help those who need it most. We have laid the groundwork this year for a union-strong 2018. Let's get out there, get together and get to work.

IUOE pays a visit to fire zones

In November, a camera crew from the International Union of Operating Engineers (IUOE) paid a visit to Santa Rosa (Rohnert Park District 10) to document firsthand the devastation from the North Bay fires, as well as the giant cleanup effort and Hazmat trainings Local 3 is providing to get members to these sites fast. The massive cleanup has required major coordination from many parties, including Business Manager Russ Burns speaking to the California governor's office about the necessity of keeping the work local and union, discussions with FEMA and OES regarding just how much trained manpower we had and the Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC) providing countless eight-hour and 40-hour Hazmat classes to get operators in the seats. Stay tuned for further details about the cleanup and subsequent rebuild.

Lessons from Seattle

In September, Amazon announced it would be building a second headquarters, HQ2, and requested proposals from communities across the country that wished to be considered as a possible site. Over 200 cities submitted proposals, jumping at the opportunity to be the chosen location for HQ2, which is expected to create at least 50,000 new jobs and \$5 billion in new construction. That's before factoring in the economic boom that will be caused by those jobs and that construction.

Unfortunately, some communities are finding that they have no chance of being considered for HQ2 and have essentially lost before the bidding ever began. That's because Amazon has learned some crucial lessons about the importance of well-funded and properly maintained infrastructure, as well as the value of forward-thinking housing development.

Amazon was a small company when it built its first headquarters (HQ1) in Seattle during the mid-1990s, but it soon grew into the corporate giant it is today. That rapid growth put a strain on Seattle's infrastructure, which was 50 years behind the necessary maintenance and improvements needed to accommodate the economic boom. It wasn't just the infrastructure. Housing wasn't available for thousands of new workers coming to the area, which meant current and new residents had to deal with the fourth-worst traffic and the fastest-rising housing prices in the United States. The economic boom brought jobs and prosperity, but those who were benefitting from those new jobs and that new prosperity found they still couldn't afford to live near their work, so they began buying up homes in Seattle's suburbs. This spread the area's traffic problems, and soon commuters were spending hours getting to and from work. It also spread the housing crisis, as even relatively remote communities in the region saw housing prices skyrocket. Instead of being ahead of the curve, the Seattle area found it was far behind, and continues to struggle to keep up.

With the benefit of hindsight, Amazon representatives are looking to build HQ2 in communities that have properly invested in their infrastructure and encouraged residential development. The question is whether politicians, business leaders and citizens elsewhere will now recognize the importance of building communities and well-developed infrastructure that can welcome economic growth when opportunity presents itself.

As we enter a new year and with midterm elections coming up, it's absolutely essential that we get the message out about the importance of properly funding infrastructure and encouraging residential development to attract businesses that will create local work for *our* communities. Doing so will not only keep our industry strong, our members employed and our Funds healthy, but it's also critical for the economic growth we want to see in our own communities and in our nation overall. Getting that message out will also protect the progress we are making, as a package of recently passed bills like California's Senate Bill (SB) 1 come under attack from those who would rather pass the buck for a few more decades than address these issues here and now. Stay tuned as we work together in 2018 to pass more transportation bills union-wide.

Third Quarter 2017 Consolidated Financial Results

During the third quarter of 2017, economic growth in our nation's economy expanded, with Gross Domestic Product (GDP) increasing 3.0 percent. Economists believe the hurricanes in Texas and Florida during the third quarter may have had an impact on GDP growth, while some think it is too early to estimate the overall impact. Consumer spending and business investment rose at an annual rate of 2.4 percent and 3.9 percent, respectively, in the third quarter. Both of these are a deceleration from prior quarters likely caused by the storms, as many consumers do not go shopping for nondurable goods and services during bad weather, and business activity was slowed. Economists expect the fourth quarter to achieve a 3 percent growth, as previously predicted. Repair efforts from the hurricanes in the East and the fires that affected our jurisdiction in California will have a positive boost in the coming quarters, especially in the building sectors.

Job growth during the third quarter of 2017 slowed with only 274,000 new jobs created nationally. The private sector added 257,000 new jobs, of which 18,000 were in the construction industry. The government sector reported a gain of 17,000 jobs during the quarter. The unemployment rate across the country for September 2017 was 4.2 percent, down 0.2 percent from June 2017 and 0.7 percent lower than September 2016. Within Local 3's jurisdiction, the third quarter of 2017 saw decreases in unemployment rates across three states, as compared to the same period in 2016. California's unemployment rate decreased from 5.5 percent to 5.1 percent, Hawaii's rate decreased from 5.8 percent to 4.9 percent. Utah's unemployment rate remained unchanged at 3.4 percent.

During the third quarter of 2017, Local 3's membership increased by 355 members, resulting in a Year-To-Date (YTD) membership gain through September 2017 of 580 members or 1.66 percent. Total membership as of September 2017 stood at 35,434.

Financially, third quarter 2017 results showed a net income of \$3,251,881 for the union. Consolidated revenues came in at

\$16.0 million - an 11.2 percent increase over the same period in 2016. Consolidated expenses were \$12.8 million - up 3.3 percent from the third quarter of 2016. YTD through September 2017, consolidated revenues came in at \$40.4 million - \$2,212,000 (5.8 percent) above the same period in 2016. YTD consolidated expenditures through September 2017 stood at \$37.6 million a \$217,000 (0.7 percent) increase versus 2016. Overall, Local 3 had a YTD net income of \$2,775,710 for the first nine months of 2017. Revenues for the first nine months of 2017 were positively impacted by an 8.1 percent increase in supplemental-dues receipts and a 2.2 percent increase in window dues and initiation fees. Expenses rose primarily due to increased employment costs and higher per-capita tax payments to state and local building trade organizations. For the General Fund, third quarter 2017 financial results were slightly better than budgeted expectations by \$437,259, or 53.9 percent.

Through the first nine months of the construction season, overall work hours for Local 3 are up over 1,329,000 hours or 5.8 percent. On a state-by-state basis, year-over-year Pension hours for the third quarter 2017 for California, Nevada and Utah are up 8.1 percent, 12.9 percent and 0.4 percent, respectively, versus the same period in 2016, while Pension hours for Hawaii are down 7.8 percent. By industry, through September 2017, Local 3's construction hours are up 12.7 percent, rock, sand and gravel hours are down 4.6 percent and surveyor hours are up 3.1 percent.



Commentary for third quarter 2017

The current state of the U.S. economy can best be described as continual upward progress. We are now approaching our ninth straight year of economic expansion. Unemployment is down to 4.2 percent, which is the lowest level since 2000. Consumer debt is near all-time lows, as is the housing affordability index, due to low interest rates. (Gross Domestic Product (GDP) is growing at about 2.2 percent year-over-year, but was 3 percent last quarter. Corporate earnings for the S&P 500 increased by 7.1 percent over the last year. The S&P 500 Index was up 4.5 percent in the third quarter and is up 14.2 percent year-to-date. Since the last market bottom in March 2009, the S&P 500 is now up 337 percent. Small cap stocks have lagged large cap stocks this year with the Russell 2000 up 10.9 percent Year To Date (YTD). The growth style of investing has dominated the value style with the Russell 1000 Growth Index up 20.7 percent YTD, and the Russell 1000 Value Index up only 7.9 percent. The 22 largest developed countries outside the US, as represented by the MSCI Europe, Australia, and Far East (EAFE) Index is up 20.0 percent YTD surpassing the performance of the S&P 500 which is up 14.2 percent. All areas of the globe contributed with the MSCI Asia Index up. Like most economic recoveries, small cap stocks have led the way with the MSCI All World ex-US Small Cap Index up 23.8 percent. Interest rates moved higher during the quarter.

City of San Jose park rangers face some dangerous tasks By Mary Blanco, business representative

In 1980, the city of San Jose Park Rangers' job description detailed that they patrol and enforce park rules and regulations, issue citations, administer emergency medical care, conduct search and rescue operations and perform fire-suppression activities. Rangers may also conduct tours and explain natural and historical park features.

Today, the rangers' duties still include these tasks to ensure San Jose residents can enjoy the city parks safely. However, their work environment has changed drastically! They often come into contact with park goers who are under the influence of alcohol, suffering from mental illness, buying, selling or using drugs, and homeless people, some of whom are battling an alcohol and/or drug addiction.

A couple of years ago, the rangers were asked to take on an additional assignment of protecting the watershed. (The city of San Jose entered into an agreement with the Santa Clara Water District.) Each entity was to provide funding for two rangers for this assignment. The rangers were tasked with patrolling the watershed and informing vagrants living along the creeks that they were trespassing, and if they didn't leave the areas willingly by three days, their belongings, tents and encampments would be cleared out. Obviously, this is a dangerous assignment, as the rangers have no idea who is occuping the tents/encampments and are only equipped with handcuffs, a bulletproof vest and pepper spray. They can choose to purchase their own bite stick to protect them from dogs, but the city does not provide it.

OE3 and the rangers have been in discussions for several months with city representatives about the need for additional safety equipment, but no resolution has been reached. OE3 will continue to pursue additional safety equipment for the park rangers. I will keep you updated, as we move forward.

Educating the uneducated

I went to this particular unit in anticipation of meeting with and talking to a dues-paying member I represent to discuss his future retirement. I was chatting with the entire group of eight employees about how much his retirement was worth and what he would be doing with his days of freedom, when one employee said, "Yeah, the unions have outlived their existence." I asked him why he thought that, and he explained that his grandfather was a union member and told him at a very young age to never join a union, because they are all bad. (Obviously his grandfather had a bad experience in his union.) The employee emphasized that no matter what I did to try to get him involved in the union, he would never join, even if he didn't have to pay dues at all. Soon, the break ended, and no one had time to stick around and hear my perspective about the necessity of unions.

On my drive back to Reno, I had time to think a lot about this alarming interaction. I thought about how ill-informed this member was and how tragic it was that he was sharing such wrong information. Even though his grandfather may not have been thankful for his union, his union fought for the very benefits his grandson obviously takes for granted today. This employee gets to enjoy vacation pay, paid sick time, retirement, the eighthour work day, overtime pay and the many other things that are negotiated on behalf of the employee. My plan for the next meeting is to deliver every bit of union information I have to this guy and show him what unions did for him and others and what could be lost if unions go away. Hopefully, he will change his mind.

Speaking of what unions do for their members, we just finished negotiations with one unit that had those very benefits threatened. The employers wanted to take away vacation accrual, so we took it to the members, and they rejected it hands down. We worked through the negotiations and fought hard, refusing any proposal to take away benefits. The employer reps. do not want to pay these benefits, and the sooner they can get rid of them, the more profit they make, until the employee makes nothing. Defending these hard-fought benefits is just another reason why unions are invaluable.



City of Dunsmuir upgrades its wastewater systems

In 2015, the city of Dunsmuir completed a \$6.1 million improvement project to its wastewater collection and treatment infrastructure. As part of the project, approximately 7,500 feet of failed, vitrified clay sewer main, 15 manholes and 59 laterals were replaced. In addition, backwater check valves were installed on laterals below the sewer main to reduce the likelihood of a blocked main line backing up into an adjoining residence.

The treatment of wastewater is very specialized and requires the issuance of state licenses for employees to work in this field. There are multiple grades of licensing, with each requiring a state-mandated test to obtain. As individuals progress through the licensing process, each test for the next grade becomes more difficult, requiring greater knowledge in the wastewater treatment process. Thus, individuals who obtain these licenses are in high demand. The city of Dunsmuir is fortunate to have the outstanding wastewater members we represent.

Oroville Dam project creates major organizing opportunities

Most likely you have heard about the Oroville Dam spillway failure in February. The initial emergency work was performed by Syblon Reid, Teichert Construction and Lund Construction. In mid-April of this year, Kiewit Infrastructure was awarded the Oroville Dam spillway replacement project

in Yuba City District 60.

At the same time Kiewit was ramping up, Local 3's Organizing Department was also ramping up. We hired three new organizers shortly thereafter, Raul Maldonado (Oakland District 20), John Curtin (Stockton District 30) and Casey Tull (Yuba City District 60).

If you've ever heard the expression, "sink or swim," then you know exactly what Tull was up against with the dam project. Kiewit was placing more orders than the district had ever been asked to fill, and most of the district's members were already working, since it was the middle of an already busy work season. The company was ordering 15 to 20 mechanics at a time, as well as dozer, excavator and crusher operators. Kiewit was also in the process of building one of the largest recycle plants District 60 had ever seen.

With the help of the district staff, agents, dispatchers and even the local area members, Local 3 was able to fill all of Kiewit's job orders, putting a ton of pressure on the non-union contractors at the same time. We put Local 3 hands in all the seats at the Oroville Dam spillway and grew our membership by sourcing operators from non-union companies like Franklin Construction, R & R Horn, Nordic and Duke Sherwood Construction. So far, we have been able to grow our membership by more than 100 operators, most of whom had been working non-union in the trade.

There were plenty of others who contributed to the cause. I would like to thank all those surrounding districts who helped fill those work opportunities on the dam project. Without the consistent team-player attitude by all the districts, projects of this magnitude would have trouble getting fully staffed. It's awesome to watch a plan come together with districts and departments working in conjunction with one another to service the projects and get members out on the job.

Our new organizers have been put right into the fire and are performing very well without much time to receive training. I'm sure they appreciate any help from the staff, former staff and members to help them learn on the fly. If you happen to run into these new organizers in the field, please greet them with respect, and remember, they are always trying to create more work opportunities for you.

As always, the Organizing Department appreciates all the help it gets from the members. You help us recruit skilled operators who are working non-union. If you know someone who is looking to make the transition from the non-union to becoming a Local 3 member, please let us know, so we can make sure to find them the best possible opportunity. Growth equals strength; it helps support our benefits and Pension and will provide stability for future generations of Operating Engineers.

Crew performs repairs while helping farmers

The Caltrans Newell Maintenance Yard is located 10 miles south of the Oregon border. With help from the Grass Lake crew, the Caltrans workers there recently completed a 10-day storm water repair job along a one-mile-stretch of Hwy. 161 near Lower Klamath Lake. The job was necessary, as the bank had eroded into the lake due to wind and waves. During the repairs, the crew was also able to make shoulder improvements with new base rock. By recycling 2,000 yards of native lava rock, which was taken from nearby fields, the project helped free-up land for area farmers to grow more crops. The lava rock was stockpiled at a location close to the jobsite, where it was inspected by the Department of Fish and Wildlife to ensure it was free of any contamination before being put in place as new rip-rap.

RHB recently picked up a \$13.25 million NDOT job on Hwy. 50 in Lander County that should kick-off in early spring.

Our district has been responding to the North Bay fires, one of the most devastating wildfires in California history, which burned over 240,000 acres and destroyed close to 10,000 structures. Local 3 members were a big part of the response, as our Heavy Equipment Operators (HEOs) cut firebreaks and our crane operators worked with Pacific Gas and Electric (PG&E) to replace power lines. Our Caltrans brothers and sisters were also a big help, clearing trees and keeping the flow of traffic moving, while first responders flooded into the North Bay to fight the fire storms. Our members will also be a big part of the recovery.

As of this writing, Local 3 is fighting to ensure that the cleanup work in the aftermath of these fires goes to local union contractors. We want our members to perform as much of the

work as possible, as they get themselves and their communities back on their feet. Business Manager **Russ Burns** and Director of Apprenticeship **Tammy Castillo** authorized emergency 40-hour and eight-hour Hazmat classes at our Hall to help us meet the huge demand for qualified Operating Engineers. Currently, we are training hundreds of members.

Large levee projects already on the rise

This past summer, the largest levee project in the city of West Sacramento's history began and was awarded to **AECOM Energy & Construction** for \$50 million. The project had a slow start due to last year's rains, but thanks to the hard work of our Local 3 hands, progress has since been made. This fall, at the project's peak, 40 to 45 members with **AECOM Energy & Construction** were working 10 to 12 hours a day, six days a week. (Stay tuned for a large feature on this work.) A smaller crew will be working during the slower winter months on projects that tie into the building of the new levee. A full crew will return once the rains pass to push for a finish date next December.

In the coming years, there will be a significant amount of levee work between West Sacramento and Natomas and along the Sacramento River south of downtown Sacramento. Another \$1.5 billion of work will go toward protecting neighborhoods in Land Park, Greenhaven and the Pocket area.

West Sacramento and the Natomas area are also waiting on over \$1.5 billion in funding to repair and upgrade levees to meet a 200-year level of flood protection, lifting building restrictions.

Plagued with protested contract bids, funding issues and public hearings on projects, this year our industry in Hawaii has been flat with little to no increase, as compared to last year. However, the Out-of-Work list has never gone below 15 percent statewide, as Local 3 continues to focus on jobs, which is priority No. 1.

As of this writing, Goodfellow Bros. is working on the \$5.4 million Kihei Force Main and will be laying 8,000 feet of six-inch main with Air Release Valve (ARV) installations and a pump station.

Our mid-size to smaller signatory contractors have increased and now comprise 57 percent of our workforce in Hawaii. These employers are looking for multi-skilled operators, as proficiency and productivity on several pieces of equipment is not only in demand but is the new expectation. Hawaii state certification requirements from the Kahuku Training Facility

Crane operators in Hawaii are governed by the Hoisting Machine Operators Advisory Board (HMOAB), a detached agency of the Department of Labor and Industrial Relations

(DLIR). If you are going to operate a crane in Hawaii, you must have a current Hoisting Machine Operators Certificate issued by the DILR. It is easier than ever to obtain one due to the launch of the HMOAB website last year (hmoab.hawaii.gov). You can apply online and submit your documents along with your payment, and your card will arrive shortly in the mail! This works for new cards and renewals. Remember, keeping your certification current is *your* responsibility!

How it works:

Block-by-block, district is booming

With the housing shortage in San Francisco, lots of private jobs are popping up, and construction is everywhere in San Francisco's South of Market (SOMA) and Dogpatch neighborhoods. At 915 Minna St., Granite Excavation & Demolition is drilling 60 holes for soldier beams around the perimeter of a five-story apartment building. The spaces between the beams will be filled with lagging boards. While Drill Operator Gary Hanson works on the holes, Excavator Operator Dave Harrigill moves material. At 631 Florida St., **R & B Equipment** is busy tearing down an old warehouse (targeted by graffiti artists) to make way for a large \$100 million multi-purpose building. Excavator Operator Marco Gomez is onsite with a 360 Komatsu. In the Dogpatch neighborhood, Ampco North Operator Jose Parra is clearing the way for a new condominium project. Next door, in Potrero Hill, newly signed Titan Constructed has Walter Caraang operating a Potain selferecting crane on a new housing project.

On Treasure Island, Independent Construction has Gradechecker James Mulanax using a Trimble GPS to check the size of the stockpile. On Yerba Buena Island, Desilva Gates has Operator Earl Ince building retention ponds ahead of the rain. James Wakin, Jeff Hollfelder and Francisco Lozano from California Engineering are onsite doing some final clean-up. Across the street, **Dees Hennessy** Operator **Jose Aguilar** is installing 88 H-Beams 35 feet deep for a five-story, 127-unit apartment complex.

The work picture is still strong in San Mateo County. In Pacifica, JDB Construction Operator James Burke is working on 700 feet of sewer replacement worth around \$1 million. Yerba Buena is also in Pacifica and has Operator Genaro Martinez working on concrete swales and storm

drains on two Hwy. 1 slide repairs. In Burlingame, Westside Underground Pipe is performing storm repair work with Operator James C. Lamaack. In Daly City, Teichert Construction is grading new parking lots for a car dealership with operators Joshua Kelley, Jessica Rivera Duran, Joe L. Brasil and Corey D. Bassard. In Menlo Park, at the Willow Road/Hwy. 101 interchange, a major redesign of the cloverleaf is underway, and O. C. Jones & Sons is preparing new lane detours around the new construction. Operators include Isreal J. Hernandez, Angel M. Estrada, Christopher Faltessek, Smith Ringgold Jr., Herver Meza, Andrea C. Sandoval, Michael T. Doran and Jose T. Segura. Directional boring across Willow Road for a 16-inch High-Density Polyethylene (HDPE) sewer line is being done by Walter C. Smith Company, Inc. Operators include Ryan D. Eaves and Michael P. Couch. At the San Francisco International Airport (SFO), Graniterock is working on the McDonnell realignment project with Operator Vincent Ruigomez and Gradesetter Casey D. "Hoops" Bargas Jr.

Busy year for dredging, crane rental and refineries comes to an end

Merry Christmas and happy New Year! We thank all of the Operating Engineers and their family members who helped during the recent California wildfires. Some helped with the actual fires, while others provided donations, reaffirming our faith in people, as communities came together to help each other, regardless of race, religion or politics. Please keep the victims of these fires in mind as Christmas and New Year's approaches.

Dutra Construction has been working on a \$7 million emergency repair project for the Department of Water Resources (DWR) at seven different sites (four in Solano County, one in Stockton and two in the Tracy area). With the work picture as good as it is, **Dutra** has been giving members the opportunity to expand their experience. Now is the time to step-up and get some training in order to fill the seats for these types of contractors. We should all be proficient on multiple types of equipment to show that Local 3 members are the best of the best.

At the time of this writing, **MCM Construction** is installing the falsework for the replacement overpass on I-80 at Midway Road, a project that has been keeping our members busy for several months. **Snelson Companies** has been in Cordelia working under the National Pipeline Agreement to provide geotechnical trenching for 300 feet of 24-inch gas line and replacement of

24-inch gas line and replacement of some of the line. Dredging season usually starts in

June, but many of our dredge hands started four months early this year. In February, dredge crews were off and running with the emergency cleanup work after the spillway failure at the Oroville Dam. **Dutra Dredge** and **Dixon Marine** began dredging the Feather River at the base of the dam. These companies didn't hold back when it came to providing the equipment and the manpower to help the town of Oroville, and our members really stepped up, working around the clock, seven days a week on 12 hour shifts. Refineries have been busy with Chevron's renewal project and Tesoro, Shell and Valero's turnarounds and general maintenance. Chevron alone has kept around 75 operators employed with **Cherne** and **Harder Mechanical**. Refinery work continues to look very promising, and upcoming turnarounds and capital projects will likely make 2018 even busier than this year.

Crane Rental has been just as busy as dredging and refinery work, as there have been constant requests in all districts for crane operators, oilers and Heavy Duty Repairers (HDRs). Operators were needed this year who could run everything from luffers to friction rigs, tower cranes, large and small hydraulic cranes, rough terrain and all-terrain cranes. With all the hours these crane rental members were working, 360 members were still able to come together in solidarity and ratify the biggest agreement in Crane Rental history! Without the unity of the membership and the rank-and-file negotiating members, this would have been impossible, showing what can be done when our members stand together in solidarity. Thank you to the membership and the negotiating team.



Recording-Correspondence Secretary Jim Sullivan has announced that in accordance with Article X, Section 9 of the Local Union Bylaws, the election of Political Action Committees (PACs) will take place at the first District Meeting of 2018 in each respective district. No Member shall be eligible for election, be elected, or hold the position of PAC Member:

- 1. Unless he or she is a continuous Member in the Parent Local Union for the two (2) years preceding nomination and not suspended for nonpayment of dues during those two years and a registered voter (with proof of current voter registration) in the District where he or she is seeking nomination;
- If he or she is retired, is an Officer of, or is on the payroll of the 2. Local Union or a related entity;
- 3. If he or she is an Owner-Operator or a Contractor.
- 4. No Member shall be nominated unless he or she is present at the meeting, or unless he or she has filed prior to the meeting with the Recording-Corresponding Secretary or District Meeting Secretary on the day of the meeting before the meeting commences, a statement in writing, signed by him or her, to the effect that he or she is eligible to be a PAC Member and will accept the nomination if nominated.

Recording-Corresponding Secretary Jim Sullivan, in compliance with the International Constitution and the Local Union Bylaws, publishes the following notice:

NOTICE OF RIGHT TO NOMINATE:

Bylaws, Article XII, Elections, Section 2(j)

Eligibility of Members to Nominate: Every Member of the Parent Local Union and its Subdivisions (except Subdivision R Registered Apprentices) and (except for Owner-Operators of an entity that employs Operating Engineers), who is not suspended for nonpayment of dues preceding the first nominating meeting shall have the right to nominate.

NOMINATION FORMS:

Bylaws, Article XII, Elections, Section 2(e)

Nominations shall be in writing and signed by one or more nominators giving the last four (4) digits of each nominator's Social Security Number and complete Register Number in the form following: (Note: Election Committee shall not count any nominators whose information is incomplete.)

NUMBER OF NOMINATORS REQUIRED:

Constitution, Article III, Section 3

Candidates for delegate must file nominating petitions in support of their candidacies signed by not more than two-hundred (200) members or two percent (2%) of the entire membership, whichever is less.

NOMINEES REQUIRED:

Once nominated, a nominee must sign and return the "Acceptance

of Nominee" form to the Recording-Corresponding Secretary, which must be received within ten (10) days of the date the candidate was notified of the nomination. Nomination forms are available at District Offices.

Nominees may also utilize the "Declination of Nominee" form provided in the Bylaws and available from the office of the Recording-Corresponding Secretary to decline a nomination.

INTERNATIONAL CONVENTION DELEGATES:

Bylaws, Article XIII, International Convention Delegates, Section 1

The Business Manager, President, Vice President, Recording-Corresponding Secretary, Financial Secretary and Treasurer are Delegates by virtue of their election to Office.

- a) To be eligible, a Member must, at the time of nomination, both be in good standing with respect to payment of dues and have been continuously employed or seeking employment in the trade for one (1) year preceding the month of nomination. (*IUOE directive 6/19/08*)
- b) Except as provided in Paragraph (e) of this Section, the Election Committee shall be nominated and elected at the regular quarterly or special District Meetings no later than November of the year next preceding the election.
- c) Each Nominee shall have the right to list one of the following after his or her name on the ballot: his or her elected or appointed Office or elected or appointed Position, or Collective Bargaining Agreement classification.
- d) Except as provided in (e) of this Section, nominations will be held in the month of December, and the election will be held in the month of February.
- e) When the International Convention is to occur during the year next following an election of Officers under Article XII of these Bylaws, the nomination and election of Delegates and Alternates to such International Convention shall take place concurrently with the nomination and election of Officers.
- f) Where there are no more candidates nominated for Delegates and Alternate Delegates than are authorized by the Local Union Executive Board, the secret ballot election shall be dispensed with and the Recording-Corresponding Secretary shall cast one (1) ballot for all the unopposed candidates for Delegates and Alternate Delegates, who shall then be declared duly elected

Then, all you have to do is call the Operating Engineers Health and Welfare Trust Funds at **(855) 279-2128** or the Pensioned Operating Engineers Trust Funds (non-Medicare members only) at **(855) 229-7822**.

3. If you're having surgery, get some important details beforehand.

- If your doctor is recommending care for you that requires the services of several different providers or recommending you receive services from another provider or facility altogether, be sure to ask whether the provider is in the Anthem PPO network.
- Call the Medical Assist Line: (855) 279-2128.
- Find out if an assistant surgeon, anesthesiologist physician or a certified registered nurse anesthetist will be involved. If so, call the Trust Funds Office. New boots on the ground

The first part of a series on coming together after the North Bay fires

It might not sound like much, but a new pair of high-end, composite-toed work boots can bring just a shred of normalcy to an Operating Engineer who has lost everything in the North Bay fires, as many Rohnert Park District 10 members did. Many Local 3 members also burned clear through their boots while battling the flames with water trucks or whatever resources they had on hand to save what they could. So Local 3 Safety Director/Special Rep. Michael Strunk worked with Ariat footware and apparel to get hundreds of boots donated to the Sonoma County community and our operators affected. Local 3 business agents loaded them up in trucks and hand-delivered them to crews, a small gesture in the middle of such devastation.

Local 3 member and Precision Crane's Vice President Tyler Elliff said that the morning after the first wave of fires broke out, many of his crewmembers couldn't make it to work, but those who did quickly gathered water from local businesses and filled up their water trucks, saving between 10 and 20 homes in the area.

"It sounded like a freight train," Elliff said of the fires roaring through his community. "The firefighters were mainly working to save human lives, so we chose to get in our water trucks and do everything we could to save the homes, saving whatever we could, putting it out as best we could."

They weren't trained at this; they didn't have face masks or fire gear, but they acted on instinct, working three days straight, sometimes worrying that their trucks would catch fire, watching their windshields crack from the heat as they literally drove through flames. According to Precision Crane's Ron Babbini, crews also fed water to fire trucks and endlessly fought spot fires.

"By the end of the week, we learned a lot more, and as crewmembers learned their families were safe, more joined us," said Elliff. Elliff's grandfather, Moe, started

Precision Crane with his son, Budd, in 1980, "withree trucks and no "with money in the bank." Unfortunately, Moe, who joined Local 3

around the same time as he formed the crane-rental company, was one of many residents whose home was destroyed in the Mark West area. Precision Crane Operator Ryan Schupbach also lost his home in Larkfield, as did his mother, father, aunt and uncle. When he got a

new pair of boots at his jobsite, however, he was able to find a smile. "I just have to make a plan and keep going," he said, while trying on a pair. "These are really comfortable

Lube Tech Nemesio Ruiz had a similar reaction to the boots, even though his world is so different now, since the fires took his home. "Thank you," he said. Others, like Michael Barker (Ghilotti Construction) from

Riebli Valley and Gary Rossi (De Silva Gates) from Larkfield, received the boots while standing in the front of their fireravaged properties, still able to give thanks for the gift.

Stay tuned for more about the relief efforts, clean-up and Hazmat training our union is providing to get residents back on their feet. (There are many stories of Local 3 heroes throughout the counties of Napa, Lake, Sonoma, Mendocino and Butte.)
