As security for such promise, I agree that the Operating Engineers Federal Credit Union (OEFCU) may hold as security for my "Time Payment Option" the amount of monies owed by me that are not in excess of the amount owed under my "Time Payment Option."

I understand that if I am more than six (6) months delinquent in meeting the agreed to payments, whether or not I am employed within the jurisdiction of the Local Union, I will (unless granted an extended time for reasons of sickness/disability) forfeit any and all monies paid the Union prior to such failure. My obligation to pay my total fees and regular dues and the security therefore shall continue.

I understand that if the regular or applicant dues are increased or decreased during the term of this agreement, the monthly payments will be modified to reflect the rate change.

I understand that if the total fee of an inactive member (i.e. suspended or on withdrawal) is not paid within the time set forth in this Agreement, the inactive member will be required to pay dues for periods beyond the stipulated time.

By signing below, I signify that all information contained in this application is true and correct. By completing this agreement, I am requesting new membership to OEFCU. I agree and understand that this membership account shall be my master account and that I may open any type of sub-account under this master account by mailing an application, telephoning or appearing in person before an OEFCU employee. I further understand and agree that all sub-accounts opened shall have the same ownership as stated on this application. Further, should I choose to establish different ownership, I understand that I must establish a new master account and sign a new master account agreement and documents. I agree to abide by all applicable laws and bylaws in all dealing with OEFCU. OEFCU is authorized to check my credit history and use consumer-reporting entities to verify the information on this application. I acknowledge receipt of and agree that all of my accounts will be subject to the Account Disclosure and Fee Schedule as amended from time to time. **By signing below, I certify under penalty of perjury that my TIN/SSN is correct, that I am not subject to backup withholding and that I am a U.S. citizen or resident alien.
