Facing 2019 stronger than ever

This union, its members, staff and their families have had an incredibly busy and productive year. Looking back on 2018, it's amazing just how many successes we achieved and how many obstacles we overcame to face 2019 in a great position – stronger than ever

This year started out with continued recovery and restoration efforts from the devastating North Bay fires that tore through Northern California at the end of 2017. Myself, your other officers, your district representatives and organizers worked around the clock with local politicians, the Federal Emergency Management Agency (FEMA) and the California governor's office to secure that work for highly skilled, local Operating Engineers. To further this process, our Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC) immediately offered Hazmat training to fill the need for qualified operators. It continues to be an emotional time for the communities that were impacted, but thanks to our swift recovery efforts, some areas are gaining a sense of normalcy. Learning how to navigate government regulations regarding this cleanup effort helped us face the terrible Shasta County fires with as much urgency, and we are currently providing cleanup to those areas and securing that work for our members, as well. At the time of this writing, the Camp Fire in Butte County is yet to be contained, claiming numerous lives, destroying well over 100,000 acres, tens of thousands of structures and obliterating several communities. Many Operating Engineers have been affected, lost their homes or have family members who did. Please keep the people from these communities and the surrounding areas in your thoughts, as we do everything we can to provide relief, supplies and eventually recovery efforts to those affected.

Other rebuilding efforts continued this year at the Oroville Spillways Emergency Recovery Project, with Kiewit maintaining an enormous operation to complete the construction of the main spillway. We officers visited that jobsite and were amazed at the coordinated effort and skill of operators, surveyors and inspectors onsite.

Other notable projects included the continuation of Fresno District 50's High-Speed Rail (HSR), the Hwy. 36 interchange project in Eureka District 40 and the ongoing public and private work in the Bay and San Jose areas, where tower cranes are so common, no one even looks twice at them anymore.

We faced a giant political year with critical internal and midterm elections, first passing California's Regional Measure (RM 3), which dedicated \$4.45 billion worth of work in the nine Bay Area counties, and Proposition 69, which secured the funding from Senate Bill (SB1) for infrastructure use only, both in the Primary Election. We held Local 3's internal election, where many members participated in the great democratic process of this union, voting with the best interests of the membership in mind. You voted for your current officers to continue leading you for another term, and we are all incredibly grateful and humbled by your support. Despite one of the worst recessions in history, we have led and will continue to lead this union in the right direction, politically, financially and through topnotch training programs, organizing drives, member education and increased benefits to our Health and Welfare Plans thanks to frugal measures put in place during hard times.

Next, we rallied our membership's political activists in the Voice of the Engineer (VOTE) program by attending countless rallies, making thousands of member-to-member calls, knocking on doors

across our four-state jurisdiction and dropping leaflets on doorsteps, all to educate our 37,000 members about candidates and legislation that would either improve or harm our livelihoods in the General Election. Though some ballots are still being tallied at the time of this writing, we achieved major wins by regaining House seats in California, Utah, Nevada and Hawaii, defeating Prop. 6 (a joke of a ballot measure in California) and enjoying local transportation victories like the passage of the Embarcadero Seawall Measure (Prop. A) in Burlingame District 01 and the Crescent City Harbor Bill in Eureka District 40. We also joined the International Union of Operating Engineers to help defeat a Right-to-Work (for less) initiative in Missouri by making thousands of phone calls to IUOE members in that state.

Our Public Employee/Unit 12 members also warded off the political attack of the Janus decision, by coordinating massive member communication drives, winning awards for their efforts and actually organizing more members than before the Supreme Court ruling! Unit 12 has held steward trainings and will be spotlighting shops with 100 percent union membership. Remember, Janus means these members don't have to pay dues anymore to enjoy the benefits of union representation, but they continue to do what's right, because unionism is alive and well in Local 3!

Unionism is also alive and well at the OE3 JATC, where the training center continues to break new records every year, including a total of 125,000 training hours in 2017, which is double what it was in 2012. The other training centers across our jurisdiction are also reporting increased hours, new training equipment and overall industry attention for the success of their programs. Our Technical Engineers Apprenticeship programs have also increased in size, as the annual Northern California Surveyors Joint Apprenticeship Committee (NCSJAC) Surveyors Competition enjoyed the biggest participation in the event's 28-year history.

As the economy improves and the need for more skilled operators becomes more and more apparent, Local 3 held multiple Recruitment Fairs this year, coordinating with our staff and the employers to gain experienced operators looking to make the leap into the union. Every event was full and gained major media attention, including a spotlight in Sacramento's *Good Day Sacramento* and *The Sacramento Bee*. We filled hundreds of jobs through those fairs and gained as many new members.

As I think about this past year, I see how tough, skilled and involved we've been, facing Public Employee attacks, transportation funding grabs and brutal natural disasters with grit and integrity that is just the norm in this industry and our union. As the holidays draw near, I hope you can take a little time to be thankful for the union that provides for your family, keeps you employed and trained and fights to secure your way of life against political attacks. I am certainly thankful for all of you and so proud to serve you as business manager and IUOE's first vice president. Today, you are a member of a union that is envied across the nation and sitting on about \$4.1 billion in Pension Funds, which is about \$1.5 billion more than before the "crash." Economic predictions are good for this coming year, so be sure to answer your phone when your dispatcher calls you. Happy holidays!



Hawaii's successes from politics to training


This month, we head to Hawaii District 17 for the round of Town Hall Meetings in Kauai, Hilo, Kona and Maui, and so I want to especially focus on Hawaii, since I am the officer in charge of that state. Hawaii fared very well in the midterm election, and they usually do, as the state is known for being very pro-labor. A few key wins for us in the Aloha State included Mazie Hirono's election to the U. S. Senate, David Ige winning the governor's seat, Josh Green winning the lieutenant governor's race and Tulsi Gabbard taking the race for Congressional District 02. All of our endorsed candidates won in the State House and State Senate races, as well as all of our endorsed mayoral candidates.

Besides being a very union-friendly and family-oriented state, Hawaii is very politically active. It's worth noting that our

membership there votes with Labor on a very consistent basis in every election, and for our internal election, a huge number of District 17 members participated in that process. We thank you for your activism in the democratic process, and we thank you for your support.

The Hawaii Training Center has also been improving during recent years under the new direction of Training Center Administrator Mike Akau. He makes it very clear that he does not tolerate mediocrity from his staff or his apprentices by using a system of checks and balances for all – a three-strikes-and-you're-out policy. This standard has improved the quality of those new journeymen entering the field and has ensured they receive the best training possible for what is expected from them.

I commend Hawaii District Rep. Pane Meatoga and his staff, as well as Mike Akau, John Monis and their staff for running a great union operation on the islands. Though Local 3's Headquarters may be on the mainland, we've all kept and upheld the very same goals of top-notch training efforts, political activism and membership service, and whenever we officers visit Hawaii, it feels like we're coming home. THIRD QUARTER 2018 CONSOLIDATED FINANCIAL RESULTS

During the third quarter of 2018, economic growth in our nation's economy expanded, with Gross Domestic Product (GDP) increasing 3.5 percent. The U.S. economy has grown by 3.0 percent in the last year, a growth percentage not seen since 2005. Increases in consumer spending, inventory investment and government spending spurred the third quarter GDP increase. Economists expect the overall growth for 2018 to be 2.9 percent. Economists warn of a continued slowdown over the few next years, anticipating 2019 to see only a 2.7 percent growth rate. Coming off the midterm elections, economists are split on whether the outcome will help or hinder the growth of the economy in the coming months. On a positive note, construction spending was up 6.8 percent for the first nine months of 2018 versus the same period in 2017.

Job growth continued it's ascent during the third quarter of 2018 with 569,000 new jobs created. The private sector added 512,000 new jobs of which 68,000 were in the construction industry. The government sector reported a gain of 57,000 jobs during the quarter. The unemployment rate across the country for June 2018 was 3.7 percent, down 0.3 percent from June 2018, and 0.5 percent lower than September 2017. Within Local 3's jurisdiction, the third quarter of 2018 saw California's unemployment rate fall from 4.2 percent to 4.1 percent and Nevada's rate decreased from 4.7 percent to 4.5 percent. The unemployment rate for Hawaii rose slightly from 2.1 percent to 2.2 percent, while Utah's rate increased from 3.0 percent to 3.2 percent.

During the third quarter of 2018, Local 3's membership increased by an additional 446 members, bringing the Year-To-Date (YTD) membership gain through September 2018 to 653 members or 1.81 percent. Total membership as of September 2018 stood at 36,658.

Financially, third quarter 2018 results showed a net income of \$2,610,736 for the union. Consolidated revenues came in at \$17.3 million – an 8.5 percent increase over the same

period in 2017. Consolidated expenses were \$14.7 million – up 15.7 percent from the third quarter of 2017. YTD through September 2018, consolidated revenues came in at \$45.6 million – \$5,200,000 (12.9 percent) above the same period in 2017. YTD consolidated expenditures through September 2018 stood at \$42.4 million – a \$4,776,000 (12.7 percent) increase versus 2017. Overall, Local 3 had a YTD net income of \$3,201,026 for the first nine months of 2018 with revenues positively impacted by an 18.4 percent increase in supplemental-dues receipts, as well as a 7.9 percent increase in window dues and initiation fees. Expenses rose primarily due to increased employment costs and higher per capita tax payments to state and local building trade organizations. For the General Fund, third quarter 2018 financial results were better than budgeted expectations by \$676,371, or 55.8 percent.

Through the first nine months of 2018, overall work hours for Local 3 were up 1,699,000 hours or 7.01 percent. On a state-by-state basis, year-over-year Pension hours for the third quarter 2018, in California, Nevada and Utah were up 8.0 percent, 13.3 percent and 7.37 percent, respectively, versus the same period in 2017, while Pension hours for Hawaii were down 4.62 percent. By industry, construction hours were up 8.4 percent, rock, sand and gravel hours were up by 1.4 percent and surveyor hours were up 30.0 percent, versus 2017. Local 3's work picture continues to be positive with the defeat of Proposition 6 in California and all the current projects continuing and new projects starting.



Commentary 3rd Q 2018 – U.S economic growth, supported by fiscal stimulus, has accelerated in 2018. U.S. GDP grew at 4.2% in the 2nd quarter and is estimated to have grown at 3.6% in the 3rd quarter, representing the best six-month growth level for the U.S. economy since 2014 and far exceeding the Federal Reserve's long-term expected economic growth rate of 1.8%. The labor market continues to be strong with the unemployment rate declining to 3.7% in the 3rd quarter, the lowest rate since 1969. Annual wage growth also showed signs of life, increasing 2.9%, the most since 2009. Inflation, while still running slightly above the Fed's long-term target of 2%, slowed somewhat to 2.3% in September. The S&P 500 index was up 7.7% in the 3rd quarter, taking the year-to-date return to 10.6%. Growth stocks continued to dominate value stocks with the Russell 1000 Growth Index up 9.2% vs. 5.7% for the Russell 1000 Value Index for the quarter. While the MSCI EAFE Index was in positive territory with a return of 1.4% for the third quarter, returns were muted by uncertainty around tariffs and the outcome of the Brexit deal. Interest rates moved higher across the yield curve during third quarter, resulting in negative to flat returns for government bonds and investment grade credit. High Yield performed better, given lower sensitivity to rising interest rates.

What to expect during fact finding

When employees receive a notice for investigation (sometimes called fact finding), it should be taken very seriously. This investigation usually begins with another employee or citizen filing a complaint with the respective agency. The preparation for this is very important, almost as important as the investigation meeting itself.

Employees who receive these notices should reach out to their union representative immediately and should have a good idea of the subject matter of the investigation. If the issue is of a serious nature, I suggest we meet in person at a public place of their choice, where they will feel comfortable talking about the subject matter. If they don't want to meet in person, I will schedule a time for an in-depth phone call. This should happen well in advance of the scheduled investigation meeting. This gives me time to follow up, if needed. I ask the employees to bring/send me all documentation they have regarding the issue, including past incidents that can be connected to this investigation. The more I know, the better we can prepare for the investigation meeting. Employees should be prepared for two or more investigation sessions before a final decision. In some instances, I may reach out to the investigator regarding this issue and ask about scheduling, expectations and basic subject matter.

When an investigation is going on, it is a very stressful time for employees, so the following guidelines should prove helpful. There will most likely be more than one person on the other side of the table asking questions. They will be writing extensive notes, and so will I. I tell our members to always be honest, and if they do not know the answer or can't remember, I tell them to say so. (Answers to some or most

of the questions being asked by the investigators are already known by them.)

I tell the employees to keep their focus on the questions and answers at hand, because when they lose focus, mistakes happen. Employees should keep answers as short as possible. If the investigator asks for elaboration, this answer still needs to be as short as possible. Employees are instructed not to talk when there is silence, because sometimes investigators pause on purpose, hoping employees who are already nervous will disclose more. Employees should also maintain a professional, respectful presence, as we do not need an additional charge for hostility or insubordination.

If the session is to be recorded, I will also record it. If employees are asked to sign a document, I advise them to read it over first and pass it to me to read before signing. If there is a concern with this document, I will ask to meet alone with the employees. We are entitled to take a break, and if either one of us asks for a break, both of us are to take the break at the same time. (The idea is that we stay together through this whole time period.) Employees should listen to the questions being asked and have the questions repeated, if needed. They should take a moment and ask the question in their head before giving the answer out loud. Employees should be aware that perceived friendliness from the other side during the investigation session is a tactic to make the employee feel they are in a "safe" environment, but most likely discipline or suspension/termination is the intended result.

I tell employees to follow the instructions that govern the investigation, and most importantly, not to talk about this to anyone other than their union representatives. The consequences of doing this could be greater than the original charge. If possible, employees should try not to worry until/if discipline is handed out. I remind employees that they have the best union representing them.

The City of Weed entered into a three-year Memorandum of Understanding (MOU) with Operating Engineers Local 3, in which our members' base salaries will increase by 17.8 percent over the term of the contract. As part of the agreement, Local 3 members will pay the 7 percent portion of the employee pension contribution to California Public Employees' Retirement System (CalPERS). The City also agreed to match our members' contributions to their 457 retirement plans up to 2 percent of their salaries.

The Butte Water District entered into a two-year contract in which our members were retroactively paid back to Jan. 1, 2018, an increase of 50 cents per hour. In addition, members will receive a 50-cents-per-hour increase to their wages on Jan. 1, 2019. The Butte Water District is under the farm labor regulations, which has a 60-hour workweek. This means that no overtime is earned, until the employees work in excess of 60 hours a week. Assembly Bill (AB) 2757, which was signed into law by California Gov. Brown, will eventually reduce the 60-hour workweek to 40 hours for all farm labor. As part of this contract, the employer has acknowledged AB 2757 and agreed to comply with the law.

The Susanville Sanitary District entered into a two-year MOU with Operating Engineers Local 3, in which our members receive the same percentage increase to their wages as the Consumer Price Index (CPI) for Social Security recipients, a 2 percent increase, retroactively back to July 1, 2018. Members will receive their next increase on July 1, 2019 at the CPI rate for Social Security recipients.

Two Successor Agreements, the Public Works and Miscellaneous Employees contracts, were negotiated with the City of Susanville. The Public Works members entered into a three-year agreement with a 1 percent salary increase in each of the years. We also added an additional 5 percent longevity step and 23 incentive items worth up to an additional 7.5 percent. The Miscellaneous Employees agreed to a two-year contract in which they received a 1 percent wage increase each year and incentive pays for higher education degrees up to 5 percent.

OE3 JATC hosts FEMA disaster training

Last month, first responders from around the country came to the Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC) to participate in four days of large-scale disaster training. As part of the Federal Emergency Management Agency's (FEMA's) disaster preparedness plan, the hands-on training includes how to signal, perform rigging, estimate load weight, provide tiebacks and cut through metal using a petrogen torch, among other things. The training keeps taskforce members mission-ready, so they can properly respond to large-scale disasters, whether they be terrorist attacks, like those perpetrated on 9/11, or earthquakes, wildfires, mudslides, hurricanes or tornadoes.













Working with Local 3 apprentices who operate cranes, forklifts, excavators and other heavy equipment, taskforce members experience scenarios that mimic real-world conditions. This includes gaining access to cars trapped under slabs of fallen concrete, rebar and steel beams, or safely working through rubble made to simulate a collapsed parking garage. The OE3 JATC's new, expansive property, up-to-date equipment, knowledgeable staff (Senior Coordinator Doug Albright is himself a member of Task Force 7) and well-trained apprentices make it all possible.

"We're spoiled... Training like this is held at various locations across the country, but this one is the best," said Sacramento Fire Captain and Task Force 7 Leader Mike Wolfe, whose deployments include Ground Zero following the 9/11 attacks, the 2010 earthquake in Haiti, the 2014 Oso Mudslide in Washington and 2017's Hurricane Harvey in North Carolina.

We're proud to be a part of this important training.

Crews work overtime to complete dam project

If you are working this winter, please keep safety on your mind. If you are working around others and see a potential hazard, do not hesitate to speak up. Don't hassle them over it, but talk about it and learn from it. If you see your co-workers performing a safe act, let them know you appreciate it. As union brothers and sisters, we need to work together to help each other.

Shimmick Construction crews have been putting in some major overtime, working 12 hours a day, seven days a week on the El Dorado Irrigation District's \$20 million Forebay Dam modification project. The job requires the dam be drained from Oct. 1 through Dec. 15. During that time, crews must repair the unstable reservoir inlet and install water control gates at the power and water supply intake structures. Other improvements include buttressing the downstream face with an improved subsurface drain system, armoring the spillway channel, replacing the irrigation valve house and installing a new seepage return system. Ultimately, the dam will be raised 10 feet. The Forebay Dam was built in 1923, and thanks to the hard work of these Operating Engineers, it should last another century. Goodfellow Bros., Inc. is working through the winter on the White Rock Springs Ranch phase of the Folsom Ranch Project. This \$10 million project is expected to keep around 25 operators busy until next summer.

Call the Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC) at (916) 354-2029 during the off-season to schedule some upgrade-training,

as winter is a good time to hone your skills. If you are on the Out-of-Work list, do not forget to contact the Hall to renew your registration. If it expires, you will lose your place on the list. Members on the A and B list have 84 days to renew their registration. Those on the C list must check in on the first day of every month.

If you are heading into the mountains this winter, please remember to Slow for the Cone Zone. Keep our Caltrans brothers and sisters safe, as they work long hours to keep our roads clear for travel. Happy holidays to you and your family.

Underground work continues

In Visitacion Valley, Cahill Contractors, Inc. is the general contractor on a new \$32 million, 55-unit, five-story, affordable public housing building, which should be done by next August. Hatton Crane and Rigging Operator Hector Bruno is on the project operating a 110-ton Rough Terrain (RT) crane. **Anvil Builders** is working on the Putman Street water main replacement project in Bernal Heights, where operators Alberto Marquez, Salvador Jimenez and Demetri Jimenez are digging as deep as 20 feet to lay a 48-inch coated steel pipe to Cortland Street. If you lost your home, or know Local 3 members who did, please call Dispatcher Chuck Adamson, as the District Office can make sure the necessary paperwork for any relief from the International Union of Operating Engineers (IUOE) is filled out and returned properly.

At the time of this writing, the fire is still not contained, and the full extent of the damage is unknown, but Local 3's officers and staff are already making sure Hazmat classes are available and certified operators are ready to rebuild. Look for further details soon. Securing this work for our members will not only ensure a steady income for local Operating Engineers when they need it most but will be necessary to prevent mudslides as the rains begin, restore utilities and services and get recovery underway. Meanwhile, Local 3 members from throughout the union have been donating items and helping in whatever way they can. Contact the District Office for more information on how you can make donations or otherwise assist those in need.

Our officers and staff are also working with local political leaders to prevent the kinds of predatory practices that follow these tragedies. One of the easiest ways homeowners who've lost property can be scammed is

by having unlicensed contractors who lack personal liability insurance, workers' compensation insurance and Hazmat certifications perform site cleanups. These contractors may do the work at a lower rate, but they leave homeowners without the requirements for a rebuild, resulting in a final bill that is two or three times higher than it would have been had the work been done by a reputable contractor. Spread the word for homeowners to "Check Out Before You Opt-Out!"

You must be dispatched before going to work, so remember to get cleared from the Hall before you do. If you are on the A or B Out-of-Work lists, your registration is good for 84 days. C-list registration is good for one month. If you let your registration expire, you will lose your standing and have to make a new registration. Keep your contact information current, so the Hall can call you when a job order becomes

available. When an order for a journeyman who can operate a particular piece of equipment comes in, that is what the contractor expects to get, so if you are not sure you have the skills to operate that particular piece of equipment, do not take the dispatch. If you do and are not qualified, the contractor can send you back to the Hall and you will lose your position on the Out-of-Work list. Thank you for being a part of this great union. The River Islands development project in Lathrop continues to thrive. Crews with Teichert Construction, George Reed, Inc., Moreno Trenching, Mozingo Construction and Mountain Cascade worked hard this year to get all the finish work and paving wrapped up on phase two, so they can go vertical with housing next year. Independent Construction spent most of the summer and fall on phase three, moving over three million yards of dirt and finishing 1,200 house pads and access roads. **Teichert** and **Mozingo** are building the wet utility infrastructure on the third phase. **Independent Construction** took down the barrier levee between the two phases, joining them into a truly giant housing development that will continue to fuel years of growth and job opportunities for Local 3 members. **Teichert Construction** is working on the West Lake Villages housing development on Eight Mile Road in Stockton that will include 260 pads and a lake. The project started before the Great Recession but came to a halt when the construction industry was hard hit in 2008. Mountain Cascade is working on almost five miles of pipe

and a pump station for the Tracy Wastewater Treatment Plant (WWTP), a project that should continue into early spring.

Contact the District Office to get a schedule of upcoming Hazmat refresher classes. Winter is also a great time to head to the Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC) and improve your skills with some journeyman-upgrade training. Contact the OE3 JATC at (916) 354-2029 to find out what classes are available. Don't forget, your registration on the Out-of-Work list is good for 84 days. Call the Hall before then to have it renewed.

Politics is extremely important, and many of the projects our members have been employed on were made possible through

Senate Bill (SB) 1 monies continue to fund projects to fix and rebuild our roads. On I-80 in Vallejo, **Ghilloti Bros.** is working on a \$5 million project to grind and pave four miles of existing asphalt in each direction from the Carquinez Bridge toll plaza to the Redwood Street exit. The project includes traffic control, guardrail barriers and electrical work. **Anrak Corp.** has operators **Jarred Shawles**, **Bert Maxwell**, **Bradley Schmidt** and **Mark Anderson** doing the grinding. **Ghilloti Bros.** paving crew includes Foreman **Sal Godinez**, operators **Humberto Gonzalez**, **Salvador Ruvalcaba**, **Jake Spaletta**, **Danny Fain**, **Doug Green**, **Bruno Moreda** and **Robert Humphrey** and apprentices **Sergio Hernandez** and **Dustin Dyer**.

Teichert Construction crews have been performing underground work and building pads for more than 100 new homes as part of the Vacaville Woodside Homes project in Solano County. A-S Pipelines has been performing underground utility work for new homes off Walters Road across from Travis AFB. Members have been doing levee work along the Montezuma Slough on two different \$1.5 million contracts with Graniterock and Great Lakes Environmental, which is signed to a PLA. Additional levee work should be plentiful next season between Solano County and the greater Sacramento area. Have a safe and happy holiday season!

OE3 BOTTLE COLLECTOR GAINS NATIONAL HONOR

The following ad has been printed in the Engineers News Swap Shop section for decades: "WANTED: Antique bottles. Paying up to \$500 for embossed whiskey and bitters bottles. Also want other antique bottles. Will give operators free appraisals on antique bottles."

You might wonder why someone would be willing to pay \$500 for old bottles, but you'd understand if you spoke to the writer of the ad, Local 3 member Richard T. Siri, owner of signatory company Siri Grading and Paving. Richard, who joined Local 3 in 1959 at the age of 18, was inducted into the Federation of Historical Bottle Collectors (FOHBC) Hall of Fame this year, and has the most complete collection of Western whiskey bottles and flasks, pumpkin seed flasks, Hostetters Stomach Bitters and USA Hospital Dept. bottles, about 150 of them. He also collects Indian basket-covered bottles, and even has a local chiropractor X-ray them to keep the outside weaving intact, while learning what the insides hold.

It's fitting that Richard might run across a few interesting items buried in the earth, given his line of work. The bottle collectors' bug bit Richard in the early 1960s, when his brother, Ted Siri, found some old glass bottles while on a job north of Willits, Calif. Ted showed them to Richard, and they paid a visit to a nearby trailer owner who displayed similar bottles in his windowsill.

"My brother sold him some of the bottles," Richard recalled, "and the guy was so jacked-up about them, we thought there might be more to this."

The two soon joined the Northwest Bottle Collectors in Santa Rosa, "and went from there."

During the beginning of Richard's collecting in the early 1960s, it was easier to find artifacts, as collectors would go to the ghost towns in Nevada or logging camps and creek dumps along the California coast, but by the early 1970s, most of the surface dumps had been picked over. Eventually, the government decided you couldn't dig and collect historical items without the presence of an archaeologist.

"Our last big dig in San Francisco that wasn't controlled by the City was when they were digging the footings for the Transamerica Pyramid." Richard wasn't involved in the construction of the 48-story building, which was completed in 1972, but he did know the contractor onsite, so he dug wherever he could, since the site rested on the original waterline of the city back in 1850 on Montgomery Street. According to Richard, there was a wharf fire in the 1850s there, and everything just fell into the Bay.

"There were bottles by the case buried in the mud," said Richard.

Today, expert bottle collectors must be much more patient and diligent. Hardcore researchers often use fire maps, finding old locations of covered-up outhouses and the layout of old towns. They use probes and perform calculated digging, because if you break the bottle, the value decreases.

Besides co-owning the family grading and son, paving business with his "Rick" Siri Jr., Richard and Rick also share the love of collecting, as Rick recently performed a 23-feet-deep bottle dig in San Rafael, using a backhoe and shoring boxes, so the ground wouldn't topple over him. He was able to find one good bottle!

According to Richard, what makes a bottle valuable is its condition, its age and the history that surrounds it. For example, he's on the hunt for a Baker and Cutting cathedral pickle bottle from the Bay Area, because there has been only one whole specimen known to exist!

Today, Richard continues to play a role in Siri Grading and Paving and of course continues collecting bottles and staying busy in various lead roles with the FOHBC and the Northwest Bottle Collectors. He collects other items of interest, as does his wife, Beverley, including casino ashtrays, classic cars, bitters advertisements and American Indian artifacts.

His Swap Shop ads have garnered lots of attention, as members still find things during lot renovations and dumpsite and trench digs. He has picked up several items over the years from this Local 3 service.

"Remember, in the late '60s, bottle-collecting was the thirdbiggest hobby in the US, after stamps and coins, and it didn't cost anything to do, just rakes!"

ADMINISTRATIVE CHANGE IN JOB PLACEMENT REGULATIONS

The following administrative change in the Operating Engineers Local 3 Job Placement Regulations for Northern California, Northern Nevada, Hawaii and Utah became effective April 1, 2016:

If any Local 3 Job Placement Center is unsuccessful in reaching an individual on the Out-of-Work list in California, Nevada, Hawaii or Utah 10 times within a 90-day consecutive period, the individual will be removed from the Out-of-Work List

All successful and/or unsuccessful call attempts made by any Job Placement Center are logged and tracked by the dispatch computer system. Upon reaching the tenth unsuccessful call attempt, the individual's registration will be deleted. A new registration will not be created. Individuals affected by this will need to call into a District Job Placement Center to get on the Out-of-Work List.

2019 Political Action Committee (PAC) Election

Recording-Corresponding Secretary Jim Sullivan has announced that in accordance with Article X, Section 9 of the Local Union Bylaws, the election of Political Action Committee (PAC) members will take place at the first District Meeting of 2019 in each respective district. No Member shall be eligible for election, be elected, or hold the position of PAC Member:

Unless he or she is a continuous Member in the Parent Local Union for the two (2) years preceding nomination and not suspended for nonpayment of dues during those two years and a registered voter (with proof of current voter registration) in the District where he or she is seeking nomination;

If he or she is retired, is an Officer of, or is on the payroll of the Local Union or a related entity;

If he or she is an Owner-Operator or a Contractor;

No Member shall be nominated unless he or she is present at the meeting, or unless he or she has filed prior to the meeting with the Recording-Corresponding Secretary or District Meeting Secretary on the day of the meeting before the meeting commences, a statement in writing, signed by him or her, to the effect that he or she is eligible to be a PAC Member and will accept the nomination if nominated.
