Lawsuit updates; Semi-Annual cancelled

I never thought we'd still be dealing with COVID-19 at this point, but here we are. At the time of this writing, most offices are open to foot traffic with safety precautions. We operate with contingency plans in place, in case more shutdown orders are made from the states' governors in our jurisdiction.

The California Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC) is also back to training with reduced numbers to meet COVID-19 safety requirements. An in-depth article on some of the Heavy Duty Repair (HDR) classes can be found on page 25.

Former OE3 JATC director Tammy Castillo retired at the end of June, and after conducting interviews, Greg Gasaway was hired as the new director at the beginning of last month. Greg brings a lot of experience to his new position at the training center, having worked there since 2010. I look forward to watching how Greg and his team continue to improve the training center for our members.

Despite having cancelled this month's district meetings, we continue to look at creative ways to communicate to the membership and keep them informed, from the OE3 Mobile App, e-mail blasts, and the Engineers News' Instagram feed, to podcasts, district reports on our official YouTube page and more.

Unfortunately, there was no past experience to fall back on or playbook to refer to on how to handle a global pandemic. By acting fast and facing issues head-on, we have been able to keep ahead of those who took a "wait-and-see" approach. From the beginning of March, we began putting plans in place, should shutdowns occur, and our plans have led to our success in keeping all systems operating to ensure you get dispatched.

With the safety and health of our membership as a top priority, we have cancelled the Semi-Annual Event previously scheduled for Sept. 20. Stay tuned for an announcement here and a possible postcard coming in the mail with an update on how we will communicate important State of the Union information to you. COVID-19 may keep us from hosting large gatherings, but it's not going to ever stop us from communicating to you what you need to

Speaking of communicating important information to you, at the 2018 March Semi-Annual Meeting, we promised to keep you updated regarding the investigation of former OE3 IT employees. As you know, on Aug. 15, 2018, we authorized the filing of a civil lawsuit in Federal District Court against former OE3 employees Scott Wilson, Dennis Kelsey and Eugene Romero as well as Wilson's wife, his brother-in-law and his long-time friend. Throughout this process, we continued to cooperate with Federal law enforcement on this matter.

Now, nearly two years later, I am pleased to inform you that on Friday, June 26, 2020, the United States Federal Bureau of Investigation (FBI) arrested former OE3 IT director Scott Wilson in Corsicana, Texas. At the time of his arrest, he was living in a Corsicana house which it is alleged he built with funds stolen from the OE3 membership. The United States Attorney's Office in the Northern District of California formally charged Wilson with Mail Fraud and Aiding and Abetting (18 U.S.C. §§ 1341-1342) and Forfeiture (18 U.S.C. § 981 and 28 U.S.C § 2461).

OE3, via its counsel, has been fully cooperating with and

supporting a joint FBI and United States Department of Labor (DOL) investigation for more than two years, as well as prosecuting a civil case for these acts against Scott Wilson, former OE3 employees Dennis Kelsey and Eugene Romero, and other defendants.

While we have provided regular updates to our membership regarding our efforts to investigate and seek justice regarding the full extent of harm caused by Wilson, Local 3's IT Director from 2011 through 2017, and the others we believe were involved with this substantial embezzlement scheme, I wanted to share a summary

In 2017, consistent with our fiduciary obligations as a labor union under Federal law, we began and thereafter maintained our own investigation to determine the extent of the monetary loss to OE3 and its membership, and to collect and analyze a substantial amount of evidence in order to allow OE3 to seek recovery of its loss as well as to provide significant and ongoing support to law enforcement.

Our investigation discovered that, over many years, Wilson and others executed a carefully calculated and deliberate scheme through a sophisticated system of fraudulent invoicing by their shell companies, often for highly technical IT goods and services. Throughout these activities, Wilson concealed his ownership interests and control of the companies from OE3, all while Wilson was entrusted with oversight of IT department procurement. These deceptive practices also entailed false statements to auditors and OE3's officers, formation of shell companies, fictitious vendor employees and middlemen, backdated and fraudulent contract documents, aliases, data shredding software, and encrypted data and communications. These actions took place in California, Texas, North Carolina, South Carolina and Wyoming. Wilson and others intended to, and did, steal from and do harm to OE3 and its membership, as more fully alleged in the civil complaint we filed.

We are extremely thankful to the United States Attorney's Office for their decision to prosecute Wilson and bring him to justice and to the FBI and the Department of Labor (DOL) for their investigative diligence. While the arrest and charges are a significant milestone regarding OE3's effort to seek restitution and damages that Wilson and others owe to OE3 and our members, and to obtain justice for our membership, we are mindful that the criminal proceedings will likely take some time to conclude. In the meantime, we will continue to cooperate with any requests from law enforcement and will monitor the criminal proceedings to bring you updates as the criminal prosecution progresses. For now, please understand that we cannot comment further in light of the ongoing criminal prosecution.

Reports from our districts show that work hours are better at the time of this writing than they were at the same time, last year. This is incredible news, given that many sectors of our economy are reeling from the economic impact of COVID-19. Our success continues to be a result of your essential skills, your safety awareness and your dedication to being the best in the business. Thanks for all your efforts through these hard times. Please be safe and stay informed, as we continue to navigate through this pandemic together. We will get through this.

Don't you want to have a say in November?

In a late-night move to offset the \$1.2 billion budget shortfall in Nevada due to COVID-19 shutdowns, the Nevada Legislature

passed Senate Bill (SB) 3. Under the guise of "balancing the budget," this bill will divert over \$21 million from the Highway Fund to the General Fund, which translates to over 200 jobs and \$35 million in economic impact to the state. In other words, this is a "Rob Peter, to save Paul" effort, and Labor is not pleased. Investing in infrastructure is one of the fundamental functions of government and is especially valuable during challenging economic times.

The Nov. 3 General Election will have major consequences for Labor and the economic and social well-being of every household in the country. Don't you want to have some say in how things play out? To give you an idea of registered voters in our four-state jurisdiction, let me provide some 2020 statistics. At 15.6 million, California may have the highest number of registered voters,

but as a percent of its population, it has the second lowest voter registration rate in the country. Hawaii has the lowest percentage of registered voters, with only 49.5 percent of its population registered. Nevada has 1.27 million registered voters, which equates

to 55 percent of the state's population, while Utah has 1.44 million registered voters, which is 64.2 percent of its population.

> What this means, is we can all do better. Imagine how strong our labor and jobsite protections could be, if every single union household in the country was registered to vote ... and voted? (Anti-labor groups know the current and potential power of educated union voters, because they spend millions of dollars constantly trying to silence our voice. Let's make them spend even more.)

We will be sending you lots of political information in the coming months, and we will never support issues or candidates beyond what puts money in the back pockets of our membership. But none of that matters at all, if you are not registered to vote!

If you aren't registered, it's easier than ever. Visit Local 3's website at www.oe3.org and click on the "politics" section at the top. Find your

state and get the information you need. Then, come election time, get the facts. Read here, online, on the OE3 Mobile App and any election information coming from Local 3. Then, Vote Union!

With support from Local 3, Assembly Bill (AB) 5 passed in 2019 with the rallying cry of "AB 5 and a union!" The bill made so-called gig companies treat their workers as full employees, rather than independent contractors, and therefore eligible for basic workplace rights and protections, including the right to organize. It was a major win for Labor and OE3, as gig companies are eyeing the construction industry as a potential new industry to "disrupt." Unfortunately, that victory is at risk this November. Billiondollar companies and their lobbyists are deceptively marketing Prop. 22 as the "Protecting Independence Proposition," and touting the gig industry as a "new progressive framework" for employment, but in reality, it's

just another attempt to strip workers of the hard-fought gains they've made over generations of struggle. This November,

From mid-March until May 31, they had been paying their employees 1-½ hours for every hour worked after 40 hours, with four of these hours going into salary and the rest into vacation. After a recent Zoom meeting with all of the unions, this incentive ended, and the extra 40 hours will be put into a vacation bank, with the employee able to cash it out or keep it. This is a nice benefit. Also, employees who had to stay home for medical conditions were paid their full salary and accrued vacation and sick leave while being at home. Again, thanks to City of Porterville officials for working with Local 3 and taking care of their employees!

Castro Valley Sanitation District ratifies first contract

On June 18, the newest members of the Operating Engineers Local 3 Public Employees Division ratified their first contract. The negotiations were led by Castro Valley Sanitation District (CVSan) chief stewards Phil Governor and Gilbert Espinoza with assistance from me.

The one-year deal was ratified by 100 percent of the membership. The contract includes a 2.2 percent wage increase for every member of the bargaining unit with retroactive pay back to March 1, 2020, better health care opportunities for the majority of the bargaining unit and enhanced vision and dental benefits.

The process took longer than normal because of the COVID-19 shelter-in-place obligations; however, the membership got a solid contract that will form a foundation for what we can build on toward the future.

"It was great to get this deal done," said Governor. "This has been a long process for us here at CVSan. We decided to organize about two years ago and reached out to Local 3's Felix Huerta and David Tuttle to begin the process and haven't looked back since. Our membership would not have been able to achieve this agreement on our own. We sincerely appreciate all of the hard work and level of professionalism that Felix, David and everyone at OE3 delivered. Thank you, OE3."

The parties will be back at the table at the end of the year to work toward securing a long-term arrangement. I believe CVSan officials will have a better understanding at that point of their long-term financial situation, which will allow us to negotiate a fair multi-year agreement. I'm looking forward to making sure the membership gets what they deserve.

Stop the movement to defund Stockton Unified's Police Department

The country is going through some tough times right now, but America is strong, and we will get through it all together. One issue that is especially troubling is the small groups trying to defund police departments. We all agree what happened to George Floyd was a tragedy and should never be tolerated, but we must not judge all police officers by the actions of the very few.

One of these small groups in Stockton, Calif. wants to defund the Stockton Unified School District Police Department. Citizens of Stockton need to stand up and oppose this. The Stockton Unified School District Police Department has always put the students first and is ahead of the game when it comes to dealing with ethnic diversity and finding solutions to problems. This police department has been in the schools for over 30 years and has never been characterized as racist. I have the privilege of working with the members of this department and find these officers, dispatchers and records personnel to be some of the best at their jobs. They are highly skilled and well-trained, which includes mental health crisis training. This training helps them recognize issues and work them out to avoid an arrest.

The Stockton Unified School District Police Department is also trained in intervention techniques, which deals with de-escalation as it pertains to force used and emotions involved. Officers with this training often contact school counselors to assist them in dealing with certain issues to get a different perspective.

If the Stockton Unified School District Police Department is defunded, it would impact the entire city of Stockton, not just the schools. School incidents will not just stop, once the police department is defunded. Problems will continue and most likely increase due to no police presence. This will put more of a burden on the Stockton Police Department, which is already burdened with low staffing levels. This will then increase response times to the schools, putting students and teachers at risk. It will also increase the response times to citizens. The Stockton Unified School District Police Officers Association and the Stockton Police Officers Association both oppose defunding the Stockton Unified School District Police Department.

The School Board should recognize the work the police department does for the district and stop the movement to defund the police department.



Watch yourself! City officials do not tolerate jokes, innuendoes and intimate conversation By Mary Blanco, business representative

It's important to maintain a professional demeanor while at work. I have been involved in investigations in San Jose recently where multiple members were accused of making inappropriate comments and gestures of a sexual nature in the workplace. While the remarks and/or gestures may not rise to the level of sexual harassment, the City's Discrimination and Harassment Policy states that employees can still be disciplined for misconduct. Examples of inappropriate comments or gestures include discussing sexual activities with coworkers while at work, making obscene hand gestures or making sexual innuendos or remarks about a person's sexual orientation, etc. You may say, "I was just kidding. I didn't mean to offend anyone. We are all friends here." Regardless, the City takes these allegations very seriously and will discipline employees for such actions, even

if there was no malicious intent. These cases can easily result in termination, depending on the severity of the comments and/or actions, and your tenure.

The City also has a Code of Ethics Policy that requires all city employees "... to maintain the highest standards of integrity and honesty, and they are expected to treat all members of the public and fellow City employees with respect, courtesy, concern and responsiveness." Together these two policies should guide your actions while at work. Keep discussions with co-workers professional during briefings and throughout the day. Your career depends on it! COVID-19's trickle-down impact on municipalities

The entire economic engine of the United States' economy was brought to a halt with the outbreak of the COVID-19 virus. There is not a person in America who did not suffer physically, financially or mentally due to the disastrous impacts of this virus. Our government has taken steps toward dealing with the medical aspects of this virus by expediting the production of a vaccine, providing needed ventilators and creating new medications and treatments. In attempts to stabilize the economy, the government has created programs designed to support small businesses and provided direct payments to individuals. New CEMA contract provides extra security during difficult times

The Santa Clara County Employees Management Association (CEMA) contract passed with a commanding 98 percent yes vote by CEMA members and is in full implementation. Wage increases, Pension reduction, pay premium increases, etc. went into effect May 4, just before the COVID-19 crisis became full-blown.

This contract campaign was a truly Herculean effort, involving help from OE3 lobbyists, the Political Department and Public Employees Division, our own media campaign, member calls and e-mails, member surveys and rallies at the Board of Supervisors chambers with record numbers. This contract campaign was

unprecedented, seeing strikes from other units, power outages, statewide fires, a pandemic and economic damage. Through it all, CEMA has enjoyed robust support from the Board and the County executive to conclude negotiations with a strong agreement for CEMA members. This agreement acknowledges the significant contributions our members have made and

continue to make with a more than 4.3 percent average yearly increase for five years, a signing bonus, Pension contribution reductions and many language improvements.

The work begins now to convert our hard-won gains into full implementation of the contract and ensure a smooth roll-out. CEMA's negotiating team, post-COVID-19, will finalize a version of CEMA's contract for printing. Included in this copy of the contract will be a "CEMA Recommends" section that will explain, clarify and give context to some of the more confusing sections of the contract.



Thank you again to all members who participated in the vote. Your active engagement and the strong support of the contract set new records for CEMA and achieved the richest contract CEMA has seen in decades, if not ever. We will continue to support our residents and members during this difficult time. Be safe and enjoy the extra security this contract provides.



REBECA ARMENDARIZ OE3 AGENT, ACTIVIST, CITY COUNCIL CANDIDATE

She does it all — Vote Armendariz for Gilroy City Council

Local 3 Public Employees Business Agent Rebeca Armendariz currently represents about 2,300 public servants from the Santa Clara County Employees' Management Association (CEMA), everyone from janitors to nurses. Rebeca joined the Local 3 staff last year. After a strong and successful OE3 contract campaign, she spearheaded the CEMA Liaisons Team, which consists of members who are similar to union stewards, as they serve as conduits of information between members and representatives and vice versa. Members of the Liaisons Team will only improve OE3 member representation for all, ensuring needs are met through constant channels of communication.

Besides her influential role as a Local 3 Public Employees business agent, Armendariz is running for Gilroy City Council in the upcoming Primary Election on Nov. 3, and Local 3 proudly endorses her. The idea that union members can run for local offices is one that is often overlooked, but if union members win influential positions, imagine the clout we'd have in securing labor protections, approving projects that will employ middle-class workers and honoring collective bargaining agreements for public employees and on public projects.

This is part of Armendariz's calling and why she hopes to represent the members of her community. She is a fourth-generation Gilroyan, the proud daughter and granddaughter of the farmworkers who built Gilroy. Her values are rooted in the work ethic and sense of community from the working families who make Gilroy a strong community.

Her life and career has been spent advocating for working families, including many of our essential workers (Local 3 members) on the front lines of the COVID-19 pandemic. It was perhaps while doing this important work, that she contracted the virus herself in April, as did her mother, activist Augustina "Sally" Armendariz. (Sally raised Rebeca on the picket lines.) Rebeca's mother almost didn't make it from the complications, but pulled through after a long hospital stay. Rebeca's symptoms were more tolerable, but they reminded her of certain protections she fights to maintain for union workers.

"This is a stark reminder to union members that we always fight to maintain and improve the benefits that we do have," Rebeca said. She has helped increase wages and defend the rights for many working families.

Always present in social movements, Rebeca's principled views and values drive her work. Her passion for activism is driven by her mother and her family. These values of civic duty, responsibility and a lived citizenship inspire her three children who are often beside her, participating. Besides representing Local 3's public employees, she recently completed a term of service on the Gilroy Planning Commission for 2016-2020. She is a former member of the Housing Advisory Committee and Community Development Block Grant Advisory Committee, and a former Parks and Recreation Commissioner. Rebeca is a founding member of Gilroy Growing Smarter and was a Chair of the Yes on Measure H campaign. Rebeca is an elected delegate for Assembly District 30 to the California Democratic Party.

Signatory RNR is working all over Sacramento, including at a project that involves demoing parts of the I-5 overpass near Beach Lake, as a new bridge is built. The project is called Beach Lake, but Forklift Operator Clay Johnson and everyone familiar with it, calls it simply, "Beach." Johnson has been assisting Superintendent/ Excavator Operator Glenn Green on the demo of the outside edges of the I-5 overpass, until the new bridge is complete. As Johnson picks up debris from I-5, he works in dusty ground near a stream, as traffic buzzes overhead. Above him, Green seems precariously placed on busy I-5, chomping at side rail and dropping it below.

At two other locations, Engineers News caught up with other RNR crews working in tight quarters among the resurgence of traffic, as businesses reopen after recent shutdowns. As a subcontractor to the Granite/Teichert Joint-Venture (JV) I-5 Corridor Enhancement Project in Sacramento County, RNR has been working on new pedestrian crossings, replacing non-ADA-compliant ramps and building new bridges, as part of the \$370 million of work that extends from 1.1 miles south of the Elk Grove Boulevard Overcrossing to the American River Bridge. The project is partly funded by voterapproved Senate Bill (SB) 1 monies and Measure A, both endorsed by Operating Engineers to ensure this kind of work for our members and communities would be possible. The project will rehabilitate pavement, construct new High Occupancy Vehicle (HOV) lanes, replace a pedestrian overcrossing, construct sound walls, install new fiber optic lines and ramp meters and extend many entrance and exit ramps.

RNR Superintendent Kyle Holmes, who is fourth-generation member, said that despite this giant project's challenging positioning throughout I-5, "We love a challenge. The shoring is very tight, and there is no room to work, but with good planning, it's going smoothly."

RNR was formed in 2007, and since then, the fairly young company has worked on 131 jobs and employed small, tight-knit crews of Operating Engineers.

"I started with RNR on Job No. 19," said longtime crewmember Josh McCarty. "They take good care of me. I don't sit at home."

McCarty began his apprenticeship with Local 3 in the late 1990s, after having been a carpenter on some tilt-up work. His specialty is crane work now, but he can do anything.


"If it breathes diesel and has hydraulic fluid running through its veins, I can run it," he said. "This job here is very technical."

Working in another portion of I-5, also amid heavy traffic, is another longtime Local 3 crane operator, Randy Tippit. Currently, he is building a bridge smack-dab in the middle of I-5, which is "crazy dangerous ... with crazy traffic," he said. Not to worry, though.

"Most companies are, 'hurry up and go, go, go,' but RNR is more about safety," he said.

He takes personal pride in safety himself, refusing to make a pick, if it's not been set-up right, and that's important, since he is making picks so close to traffic.

RNR has other projects in Roseville and Anderson, Calif., and recently finished some of the McKinley Village floodgate bridges. (The company specializes in structural concrete, retaining walls and bridges.) Plan on seeing RNR in the Greater Sacramento Area for a long time to come!



Members work on diverse projects throughout San Francisco

Report

In San Francisco, at 1064 Mission St., 250 units of onebedroom and studio apartments for the homeless, along with medical and dental care facilities, are going up. Silverado is onsite with operators Pedro Quintero and Larry Flores finishing up the demolition and excavation work. This will make room for **Drill Tech** Foreman **Max Ussery** and Crane Operator Bill Carpenter Jr. to place 167 auger cast piles 75to 85-feet deep for the foundation. At one of the last remaining sites on the downtown waterfront, 75 Howard St., an exclusive, gold, condominium tower is going up. This 335,000-squarefoot, 220-foot-tall tower will contain 120 residential units on 20 floors above a 5,000-square-foot premier restaurant space. Maxim Crane Works is putting Tower Crane Operator Thomas **Kelly** to work in a 300-foot, free-standing tower, the tallest in the city. Bigge Crane and Rigging is also onsite with Hoist Operator Anthony Manzo. Another tower of condominiums, 30 percent of which will be affordable housing, is going up at 434 Minna St. Condon-Johnson & Associates is performing the shoring and ground stabilization work, with Michael Cross running a crawler crane and **Jason Noe** operating an excavator. **Sheedy Drayage Co.** is onsite assembling a tower crane with

Operator **Danny Seibert** using a 90-ton

Rough Terrain (RT) Crane and Operator **Mike Maynard** using a 75-ton Link-Belt Crane. Once the tower crane is erected, an operator with **Liberty Equipment** will be brought onsite to run it. At 1 De Haro St. on Potrero Hill, **Hathaway Dinwiddie** is building a new \$50 million manufacturing facility. The new building will be four stories tall with office spaces on the top floors and a manufacturing plant for building electric cars at the bottom level. **Bigge Crane and Rigging** is onsite with Tower Crane Operator **David Caddell** and Lift Operator **Roger Towle**.

All this new construction in San Francisco requires utilities. In Pacific Heights, **M. Hernandez Contruction** is installing 2,000 feet of eight-inch, ductile-iron waterline at four- to sixfeet deep. Foreman **Clementa Pena** is running the operation with support from operators **Roberto Pena** and **Alfredo Pena**. Close by, **JBD & Sons Construction** is installing a new 12-inch, clay sewer line at 10- to 11-feet deep. Operators **Jason Vaz** and **Timothy Woods** will continue this work on 16 additional blocks in the neighborhood.

In San Mateo County, **Drill Tech** is currently working on a seawall project in Pacifica, where several structures have fallen into the ocean over the years due to erosion. Crews are stabilizing the cliff with injection anchors and shotcrete armoring. Operators include **Ismael Leon** and **Eric C. Schwafel**.

In Daly City, **G. Bortolotto & Company** has crews paving on various residential streets. Operators include **Michael T. Valencia, Chris M. Ely, Servando Sandoval** and **Mattia G. Bortolotto**. In San Mateo, **Anvil Builders** is working on the \$22 million Dale Avenue Pump Station project, which consists of replacing mechanical and electrical, as well as instrumentation in the pump station. Operators include **Salvado Jimenez**, **Martin Briseno** and **Daniel Pena**.

Demolition company goes to work on levee project in Marysville

Teichert Construction is working on the \$16 million, 200year Goldfield Levee project in Marysville, and Al's Land Clearing, Inc. is performing \$450,000 of work clearing the right-of-way as a subcontractor on the project. Al's Land Clearing, Inc. is a demolition company that recently tore down the Clarion Hotel in Sacramento and has multiple projects throughout Northern California, including the Reach B Levee project, which includes the demolition of 40,000 linear feet of concrete barrier on I-5 in Sacramento.

Knife River, Teichert Construction, Flatiron, Inc. and MCM Construction are working on multiple projects on Hwy. 20 in Yuba, Sutter and Colusa counties. George Reed, Inc. has an emergency overlay project in Sutter and Yuba counties that requires the placement of an estimated 80,000-85,000 tons of asphalt. Teichert Construction has a \$20 million emergency overlay project in Butte County. RCI General



Engineering has a \$2.8 million new cell project at the Neal Road Landfill. Gordon Ball is working in Sierra County on a \$7.5 million project. Call the Hall to get the latest information on upcoming and ongoing projects from Dispatcher Chuck Adamson.

It's going to stay hot this season, so be sure to drink plenty of water and know the signs of heat exhaustion, such as heavy sweating, nausea, vomiting, muscle cramps and dizziness. Project in American Canyon to keep crews busy for next 1-1/2 years

Work in Solano County has ramped up this summer, as construction seems to be the one industry that has not been greatly affected by COVID-19. This is largely due to the fact that our members have been following health and safety guidelines to protect themselves and others. Your efforts to keep our work from being shutdown is greatly appreciated. Thank you for keeping Local 3 going strong!

Teichert Construction is keeping members busy on new roads and underground utilities for private housing developments in Dixon and Vacaville. Independent Construction is building new housing pads off Pitt School Road in Dixon. Mountain Cascade is installing a 36-inch waterline off Claybank Road in Vacaville for the Village Estates project, which should continue into the fall. Project completion is expected in December 2021.

Levee work is going strong

Report


Raito is doing cut-off walls for the Sacramento River East Levee (SREL) project, **Teichert** is working on the \$50 million Reach B levee project and at the time of this writing, it is estimated that the Lower Elkhorn Basin Levee Setback (LEBLS) project will bid at around \$200 million. **DeSilva Gates** has six operators refilling a borrow site for levee repairs using 500,000 cubic yards of material imported to West Sacramento from Elk Grove.

Several projects were recently awarded, including the West Capitol Avenue project in West Sacramento, which was awarded to Graniterock for around \$14.8 million, the new

fire and rescue facility at the Sacramento International Airport, which was awarded to Broward for around \$12 million, and the Lower Yolo restoration project, which went to Four M for approximately \$8.4 million. The Student Athlete Performance Center at University of California (UC) Davis was awarded to **Hunt** for \$40.5 million. Security Paving is keeping five members busy on the \$20 million overpass project on I-5 near the Sacramento International Airport. Dutra is working on the Raley's landing dock across from Old Sacramento as part of an effort to revitalize West Sacramento. In addition to all the new public projects in the region, there is plenty of private work in Folsom, Roseville and Natomas.

We've made it through a very difficult time by following safety precautions recommended by the Centers for Disease Control (CDC), and as the COVID-19 crisis seems to be improving, so does the work picture throughout our district. Other areas of the state were not so lucky, with many of their jobsites shutdown while ours were still going strong. Moving forward, let's

> continue following the CDC's health and safety recommendations, as we don't want to go backward on a job well done. We are all very fortunate to be classified as essential workers, as many people are not and are unable to support their families and businesses, at this time. Mercer-Fraser's rock plants are going strong, and the company will be doing roadway excavation at the Bayside Cutoff, the Jameson Fish Passage in Fortuna and a soldier wall project in Weitchpec on Hwy. 96. Wahlund Construction is working on several projects, including the one at College of the Redwoods. **S. T. Rhoades** has members working on paving projects in Del Norte County and in Humboldt County on West End Road. Steelhead Constructors is doing seismic retrofits to bridges in various locations. The

company is also performing some roadway excavation as part of an environmental mitigation project on Pachaco Lane in Arcata.

Now is the time to consider getting training! Instead of waiting for the Out-of-Work List to clear out, you can take advantage of training to get your minimum qualifications credentials and get dispatched sooner. If you're looking to hone your skills, journey-level training requires 360 work hours reported from a contributing employer (call the Hall to make sure your employer is contributing). With those hours under your belt, you can sign up for two-week classes. Once you complete that two weeks and pass, your new skill will be listed on your credentials, making you a more valuable employee. It's also important to keep your credentials updated. Did you obtain a Class A driver's license? Renew your Hazmat or crane certifications? Let the Hall know. Our District Office is now open and following county guidelines regarding facemasks and social distancing. Feel free to call ahead, if you have any questions. Be safe and stay healthy!

Members tackle massive Mountain View Corridor project

Report

Despite the COVID pandemic, Local 3 contractors have more work than they've had in years and continue to bid for more. This is great news for all Local 3 members, as it helps to increase membership and strengthens our market share. Project spotlight

The multi-phase Mountain View Corridor project has been under construction for the last decade, and many different contractors have put their signature on it over



with Kiewit and W. W. Clyde teaming up to tackle the \$200 million project as Mountain View Corridor Constructors (MVCC). The current phase consists of 19 bridges and is 4.5 miles long (reaching from 4100 South in West Valley City to California Avenue in Salt Lake City). So far, the project has employed nearly 100 Local 3 operators at its peak and is scheduled to be completed next spring. While MVCC has self-performed much of the work, subcontractors have performed some aspects of the project. This includes the Hot Mix Asphalt (HMA) paving, which is being done by Geneva Rock Products and providing those members with good hours for the work season, as well. Once the project is completed, the west end of the rapidly-growing Salt Lake Valley will have an eight-lane freeway.

Union successfully negotiates City of Elko contract with no concessions

Report

From Reno

Work in the Reno-Sparks area continues to pick up. Granite **Construction** is working on the \$61.24 million runway project at the Reno-Tahoe International Airport, the \$18.46 million West McCarren Boulevard improvement project and the Derby Dam project. **Q&D Construction** is working on the \$8 million Parr Boulevard Bridge replacement, the \$3.4 million Golden Valley sewer main replacement project, the \$3.8 million Hawthorne Industrial Airport project, a \$3.8 million mill and fill project on Hwy. 50 and on other projects throughout the area. Sierra Nevada Construction (SNC) has crews working on a \$9.2 million roadbed modification project in Austin, the \$2.1 million Boomtown pump station, multiple warehouse projects and \$3.3 million of preventative street maintenance for the City of Reno. **Aspen Developers** is working on the \$4.5 million Golden Valley Lift Station.

Thank you to Lt. Gov. Kate Marshall and State Controller Catherine Byrne for their commitment to Nevada's working families and their leadership in helping to maintain good-paying jobs. They helped preserve a \$29 million project in Ely that was in danger of being pulled, with its funding dispersed elsewhere. Due to their efforts, our members with **Q&D Construction** are scheduled to begin work on the project this summer. In addition

to directly benefitting Operating Engineers working on the project, this job will bring in much-needed revenue for the community, whose public employees are also Local 3 members. This is an outstanding example of the gains union workers have made since Labor-friendly officials were elected to represent our state once again.

OE3 JATC Mechanics Corner

The Coronavirus pandemic has forced us to make some changes to the Supplemental-Related Training (SRT) Heavy Duty Repair (HDR) engine class. According to Local 3 Operating Engineers Journeyman and Apprentice Training Center (OE3 JATC) Master Mechanic Rodney Buck, we usually have six students and have had to drop it down to two students for a "soft opening," with social distancing and masks being worn. HDR Instructor Kevin Kennedy updated the curriculum to accommodate the two-student class by having them work on a D6T engine, changing the injector harness and pulling injectors out and replacing them.

Kevin had the students use Caterpillar Electronic Technician (ET) on the C7 test engine to troubleshoot problems with the engine and get familiarized with ET. Then the students used ET to read the existing codes on the D6T and confirmed the issues. The Caterpillar ET diagnostic tool provides the capability to access Electronic

Control Modules (ECMs) from a personal computer. The user can display the status of a group of parameters (temperatures, pressures, etc.), view active and clear logged diagnostics, display the current configuration of an ECM and much more. The identification of the ECM is automatically retrieved and is displayed on a screen when the program is started. Diagnostic test and calibrations can also be performed. The service tools provide information and features needed to help a mechanic diagnose problems and perform repairs.

HDR fifth-step apprentices Mario Silva and Brandon Steward were given the Caterpillar procedures for replacing the harness and pulling the injectors. This used to be a quick process for mechanics to access the valve covers, but now with all of the clean air emission components stacked on top of the engine, it takes much longer to remove all the components to access the valve covers.





Grief and addiction

It is a natural human response to avoid pain. We learn from a young age to seek happiness and steer clear of discomfort. We watch pivotal adults in our lives maneuver triumphs and losses in a variety of ways, and their coping mechanisms help us develop our own ways of handling what life throws at us. When life shows up in the form of loss, expressions of that loss can vary greatly depending on personal beliefs, experiences and coping skills. Grief and loss can be associated with more than a loss of a loved one and can lead to choices that may have negative consequences.

We can experience grief and loss over many things, such as major changes or setbacks in life. These can include the loss of important relationships, jobs and pets or changes in personal health or the health of a loved one, financial security or moving to a new community. Each one of these events represents a shift in our reality and will require time to process and readjust.

Unfortunately, loss doesn't come with a guidebook or a timeline, and many are ill-prepared for recognizing and implementing healthy steps to deal with the feelings that arise. Many successful and productive people still falter when faced with unexpected loss. When a major loss occurs, many of us avoid our peers, support systems and families. Some of us are taught by the well-intentioned to ignore, downplay or distract ourselves from the current situation or our strong feelings in the hopes that they will just disappear. At times, we are exposed to ways of escaping through substances or the use of

alcohol in an attempt to change the way we feel

completely.

When a loss is suffered, many different emotional and physical symptoms can bubble to the surface, throwing life into a tailspin. You may feel anger, confusion, denial, depression, fear, guilt, irritability, loneliness, numbness, sadness or shock. Physical symptoms can include fatigue, upset stomach, weight-gain or weight-loss and dizziness. Selftalk in response to these symptoms can lead to a negative self-concept. Common phrases are, "I should be over this already," "Everyone else seems good; why can't I just get past this?" or, "I feel numb; there must be something wrong with me." Unfortunately, it is common and emotionally costly for people to judge their insides by everyone else's outsides, and the grieving are not immune.

Intensity of pain and the possibility of a downward spiral can create a perfect storm for addiction. Wanting to numb the pain or ease the discomfort is normal and may push some to seek a temporary fix that leads to a lasting problem. How many times has the glass been raised in search of comfort and only produced more negative feelings? How many times has the "relief" turned into disaster? The negative consequences associated with physical and psychological dependence on drugs or alcohol is farreaching, and the cost is high. If you find that the once temporary fix has turned into a lasting problem, there is help. The Assistance and Recovery Program (ARP) provides low-cost recovery resources to Local 3 members in whatever stage of addiction or dependence they may find themselves in.

Remember, grief is a normal and healthy expression of loss. It has no definitive time table, and outward expressions of grief can change drastically from person to person. If you are walking through loss, know that there is no right or wrong way to process grief. Pain and loss doesn't always end in addiction, but if it does, help is always available. NEW LINK BELT TELESCOPIC CRAWLER CRANES BEGIN TO ARRIVE

Orders placed by Local 3 signatory employers for new Link Belt telescopic crawler cranes have already started to arrive, with more scheduled for delivery in the near future. These include an order for a total of six TCC-1400s and TCC-2500s, which Bigge Crane and Rigging confirmed in June. Thanks to language negotiated into Local 3 contracts in recent years, an oiler and operator will be required on crane rigs over 140 tons, meaning the use of many of these cranes will result in a minimum of two dispatches, ensuring increased work hours and contributions to Local 3's Health and Welfare and Pension plans.

The 140-ton TCC-1400s come with a six-section, 195-foot main boom with a pin and latch telescope system, as well as a swing-away extension that allows the crane to reach a maximum tip height of over 257 feet. The 250-ton TCC-2500s come with a seven-section,

223-foot main boom with a power pin and latch telescope system and can reach a maximum tip height of 346 feet (or 351 feet with extensions).

Crane Operator Randy Tippit works for RNR Construction and recently spoke with *Engineers News* staff after learning about recent orders for the new cranes.

"I know some contractors have them now, and I would love to try one out," he said.
