



Political Director Chris Snyder spearheaded that campaign, and I am pleased to announce that he was recently appointed to serve on the Golden Gate Bridge Highway and Transportation Board, where he can use his labor and political background, as well as his negotiating skills, to advocate for our members in the bus and ferry transportation sector. Financial Secretary Dave Harrison was also recently re-appointed to the CAL-OSHA Standards Board. These are two highly influential positions that have a direct impact on countless working people. Please note that we are strong supporters of union members running for local or state political

> offices or boards any time. The more participation we have in the political process, the better. Please also note: VOTE awards for 2020 will be coming out soon, just another form of appreciation for all you do.

## NGM campaign/education continues

Last month, Business Manager Dan Reding, Financial Secretary Dave Harrison and I visited Elko, Nev. in District 11 to meet with mining members, including stewards, working for Nevada Gold Mines (NGM), the relatively new joint-venture that absorbed Newmont and Barrick Gold Corp. in 2019. As has been discussed here many times in the last year, we enjoyed a huge settlement win against NGM last year, when the National Labor Relations Board

(NLRB) ruled that the company had unlawfully withdrew recognition of Local 3, blocked the union from representing the bargaining unit employees, changed employees' working terms and conditions without bargaining with the union and discouraged union membership. Faced with the prospect of a federal court injunction and Unfair Labor Practice (ULP) litigation before the NLRB, NGM reversed course and agreed to settle the pending ULP

charges, finally recognizing Local 3 as the workers' representative and honoring the Collective Bargaining Agreement (CBA). We'd like to think this means everything is flowing perfectly now, but whenever there is a new successor or a takeover, the company has to be educated on the process.

Your Local 3 Nevada staff, including your organizers and officers, are working diligently to educate NGM and hopefully develop a working relationship with them, while also explaining to our

members the sometimes lengthy practice of handling grievances, especially now, during COVID times.

To our mining members in Elko and any prospective ones, we are confident we will work these issues out. It is important that you come together as one voice and realize that a grievance against one is a grievance against all. This is the foundation of unionism and only works when we work together. Nevada is a Right-to-Work (for

> less) state, which means union members have an even more difficult time, because non-union members work beside them and receive the benefits of the contract union members fight for. Non-union members do not have a say in the contract, and so we are educating the mining workforce about the total value and necessity of unionism. It is a battle, for sure, but we have a skilled staff, doing everything possible to make this transition beneficial for all.

## **Delayed retirement incentive (bonus Pension)**

To encourage participants to keep working and lower long-term costs to the Pension Fund, the Officers and Trustees of Local 3 provide the delayed retirement incentive for participants who are eligible for a service pension. The amount of the incentive, or bonus, the member receives, is based on how long the member delays retirement. For example:

- » 1 year: 10 percent
- » 2 years: 25 percent
- » 3 years: 50 percent
- » 4 years: 75 percent
- » 5 years: 100 percent
- » Each additional year: +20 percent

You can do a rough calculation of your particular situation using this example and plugging in your numbers.

#### **EXAMPLE:**

- » Age 55 with 30 years of credit (Rule of 85)
- » Monthly benefits at service pension retirement date =
- » \$5,000 per month/\$60,000 per year
- » Works two more years and retires at 57

(bonus percent) 25 percent X \$60,000 divided by 24 months = \$625 24 months X \$625 = \$15,000

Remember, you must work at least one calendar year past your Service Pension Retirement Date (SPRD) and contribute at least 350 hours to qualify for the bonus. The payments will end pursuant to the example above or when you reach your unreduced Social Security retirement age, or at death.

The delayed retirement incentive is a real "win-win." The employer gets to keep a top hand (you), the participant gets to not only build his or her pension but also get a bonus, and the costs are lowered for the Fund!

The Fresno Airport is at more than 80 percent capacity in flights, and there are extra flights flying into and out of Mexico, even with COVID. This increase in capacity and extra safety precautions means we need more Local 3 Airport Police Officer staffing! These members are essential! The Fresno Airport Police are in negotiations now, and the captains will start negotiations in May or June.

If you are flying in or out of the Fresno Airport, say hello to these officers and captains and let them know you are a member of Local 3, as well. They need your support, especially during these trying times!

Other essential workers in Fresno District 50, include our Madera County Dispatchers. These dispatchers work 12-hour shifts to keep Madera County residents safe. They are the first line of defense, when people have an emergency, either because someone is injured, ill, the victim of domestic abuse or other traumatic events. They remain calm and direct often terrified callers about the next safe steps to get these people the help they need as fast as possible. They are looking forward to negotiations starting in April 2021 and hope to get the best wages and benefits possible during these trying times. We will keep you posted on negotiations.







## CEMA negotiates payments for members to separate; avoids layoffs

A looming threat

In the heart of Silicon Valley, County Employees Management Association (CEMA)/OE3 staff foresaw the looming economic threat of COVID-19 and all the associated economic damage prior to the first stay-at-home orders. By ratifying a favorable contract in April 2020, just before the shelter-in-place order was imposed, CEMA secured the economic future of the membership. As soon as that five-year contract was implemented, a new negotiation team was assembled from the membership, led by staff, to negotiate a Voluntary Separation Incentive Program (VSIP). Realizing the likely damage from the pandemic, CEMA leadership worked swiftly with the County to avoid layoffs. CEMA put to use the lessons learned three months prior with the Superior Court of Santa Clara County Chapter and the excellent guarantees and benefits CEMA negotiated there – including layoff protection in a time of non-COVID-related budgetary concern.

Working for a solution

Santa Clara County political leaders from the Board of Supervisors and the administration all stepped up to find solutions quickly with CEMA. All options were on the table, including voluntary reduced work hours, furloughs, grants of pension airtime and separation payments. Our internal survey of the membership found pension airtime and separation payments were the preferred options. All parties wanted to implement voluntary measures rather than imposed layoffs, and through negotiations, we settled on a one-time, cash payment to encourage eligible employees to leave. The Board of Supervisors was an excellent partner, and CEMA and OE3's political strength greatly helped secure this deal, which helped the budget of the County and our members' pockets.

A solid start for 2021

With a signed and implemented VSIP in place, CEMA members applied for the program. A total of 141 CEMA positions chose to separate with three months' pay. This worked out well for everyone. Taxpayers saved money in the long run, as some of the most seasoned staff left the payroll, and our membership secured a solid financial head start to a retirement or separation for 2021. The savings for the employer have allowed for no anticipated layoffs in the immediate future – a brief sigh of relief for us all.

OE3, the membership, the employer, politics and power all came together to find a great solution that benefitted all. It is rare that a union celebrates the loss of some of its members, but in this circumstance, avoiding layoffs and securing cash in hand was a benefit for all heading into a better 2021.



### Two apprentices graduate from mechanics program

Two City of San Jose OE3 members graduated from the apprenticeship mechanic program, Paulo Dutra and Vito Maletta Jr.

Paulo started working as an Equipment Maintenance Assistant II for the City of San Jose in January 2015, joined the apprenticeship program in April 2016 and graduated in June 2020. He is currently working as a mechanic at the Central Services Yard.

Maletta started his career with the City in January 2007. He was initially hired as an Equipment Mechanic Assistant I, but then applied for, and was accepted into, the apprenticeship program in June 2016. He graduated from the program in June 2020. He is currently assigned to the West Yard.





### **Apprenticeship Spotlight: Gregory Toth**

Second-step Crane Apprentice Gregory Toth works for King Crane. The Sonoma resident makes the commute to San Jose, but driving has never been a problem for him. Gregory was a truck driver before he came into the union. He remembers seeing the cranes on his truck routes, and that's what motivated him to apply for the Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC) program. He finally talked to a crane company to find out how to get into the union. Many of his friends had union jobs, so he knew unions take care of their members and that joining Local 3 would be the way to go.

Though he's taken a pay cut and the training has proven to be challenging, he knows the money will come in time and that it will require commitment and hard work. Besides, he enjoys the training. When he isn't training, he loves the outdoors and hopes to start a family someday.





## CREWS HELP FIRE-TORN COMMUNITIES MOVE FORWARD @engineersnews

No one questions that last year was hard, but imagine if in the middle of COVID and shutdowns, you lost your home and property to a massive wildfire. For many residents living in Lake, Napa, Sonoma, Solano and Yolo counties, this was the case. From Aug. 17-Oct. 2, the LNU fire, named for the Cal-FIRE Lake Napa Unit (LNU), tasked with the area's fire control, burned a total of 363,220 acres after 11,000 lightning strikes caused dry brush to spark fires. The LNU fire eventually consumed 1,500 structures and six lives. It is the fourth-largest fire in California, which fed on the fringes of Vacaville, roaring over I-80 and destroying acres of farmland, wineries and ranches.

Unfortunately, Local 3 crews have had to become veterans at fire cleanup, as devastating Northern California wildfires have become a seasonal thing in the last several years. In fact, Joint-Venture Goodfellow/Teichert/Odin (GTO) was formed last year specifically for providing fire cleanup, and Excavator Operator Jeff Sutton got his Hazmat certification to play a role in helping families move forward.

Out on Mix Canyon Road, one of the homeowners approached him, while he was cleaning up her property and asked if he had found any silverware or perhaps a menorah. Both items had been in the family for about six generations. Sutton had no luck with the anniversary silverware, but he did uncover the menorah, and the homeowner cried.

"We're helping people move on," he said. "Most are thankful."

According to GTO Foreman Brandon Dietrich, who oversees about four crews cleaning up individual properties on Mix Canyon Road, Stagecoach Lane, Vickrey Lane and other Vacaville-area locations, there are about 380 properties they are cleaning up in Solano County alone and 1,408 total.

He thinks they may finish by late April or early May, but it's not a simple process. First, the asbestos needs to be removed. Then, tree crews come in to remove burned trees. Everything is carefully and safely dealt with, so as not to expose chemicals to the public or cause toxic materials to leech into the ground. All crews are fully-suited up in Hazmat gear to remove debris.

While many operators recently became Hazmat-certified to provide cleanup, 24-year member Azure "Blue" Gribble has always had her certifications. She joined the Apprenticeship Program after being just 15 years old, homeless and finding a flier about Job Corps in a storefront window. This decision changed the trajectory of her life forever.

"I wouldn't trade this for the world," she said. "I love my job and my crew. My whole career has been here, mainly with Teichert. This work, the cleanup, is very humbling. We are helping people rebuild on a very personal basis. It's hard."

A property is finished, only after crews remove burnt-out vehicles, perform cleanup work and test the soil. Then they move onto the next one. Without them, there could be no rebuild on these properties. Our crews are the ones to ensure removal is done safely and with dignity for the remaining valuables that may still be found.

#### Podcast talks about latest NGM news for miners

Report

#### From Reno

Work in Reno and the surrounding areas has slowed due to weather, but many members continue to work. Ames Construction and Q&D Construction have been working on the Hwy. 395 Spaghetti Bowl Express (SBX) project, which should keep crews busy throughout the year. Titan Electrical Contracting has been relocating electrical utilities to make way for a total redesign of the on- and off-ramps for Mill Street and 2nd Street. Q&D Construction has numerous dirt and pipe crews working on subdivisions throughout the region. Granite Construction has crews working on a solar project east of Sparks and should start work at the Reno-Tahoe International Airport soon, weather permitting.

#### From Elko

At the time of this writing, the Elko Office has been open for daily business with protections in place for the staff and the membership. Construction is slow, so members have moved on to doing snow removal. **Q&D Construction** finished the first phase of the Southwest Gas line extension into the Spring Creek area, with hopes of getting the next phases of the project done this year. The company has upwards of \$55 million of work in the Elko area this year. **ACHA Construction** is finishing a couple of projects for the Nevada Department of Transportation (NDOT), including an office site and road drainage repairs. The company has been awarded a \$2.5 million power plant project and smaller projects to keep members busy through the winter. Granite Construction has been awarded a \$9 million road widening project on Hwy. 93, a \$2 million street repair project in the City of Carlin and a few mining projects that will start as soon as possible. Remington Construction is working on the final phases of the new fire station in Lamoille and a few mining projects. N. A. Degerstrom has been going strong at the Gold Bar mine in Eureka. Ames Construction has kept our members

working at the Marigold mine in Battle Mountain, at the Hycroft Mine in Winnemucca and at various sites on Nevada Gold Mine (NGM) properties.

At the time of this writing, gold is at \$1,883.11 and fluctuating daily. As we continue to seek resolution for our NGM membership regarding outstanding issues, please stay focused and engaged in the constant battle for your right to be union members. We have been making bus stop visits, talking to the membership, making site visits, updating our union posting and meeting with management to address contract items, as well as membership grievances. We look forward to having membership meetings again and getting back into action. If you have questions, comments or concerns about NGM and its current status with the union, or any other issues that need to be addressed, please contact the Elko Hall or your agent. For surface mining, contact Business Agent Josh Jauer at (775) 399-3773. For underground mining, contact Business Agent **Lyman Hatfield** at (775) 401-1622. #### Thousands of trees removed from last year's fires

Goodfellow Bros., Teichert and Odin Construction have teamed up under a Joint-Venture (JV) called **GTO** and hired a lot of our members to perform tree removal and debris cleanup from lots destroyed during last year's fire. Over 115,000 trees will be removed by the end of this project, employing many operators and continuing well into the year. (See pages 14-15 for more.)

Weber General Engineering has been keeping members busy through the winter with private work near Cordelia. Knife River has up to 12 operators performing

underground work for a housing subdivision off of Liberty Island Road.

Granite Industrial and Bockmon and Woody Electric are working on the \$8 million Lake Herman Road solar project in Benicia. The project is being done under a Project Labor Agreement (PLA) and will include the development of a 35acre, 5-megawatt alternating current solar facility. The facility will connect to Pacific Gas and Electric's (PG&E's) pre-existing electrical system, which is adjacent to the project site, and the power generated will be sold to Marin Clean Energy. Since breaking ground last November, operators have bladed roads, drilled thousands of holes, off-loaded material and excavated trenches. All work is expected to be completed by this spring.

As part of the second phase of the over \$5.7 million Kaupakalua Road pavement reconstruction project, members working for Maui Paving recently repaved approximately 3.5 miles of roadway. Subcontractors GP Roadway Solutions, Apply-A-Line and Goodfellow Bros., Inc. also worked on this phase of the project. The work involved excavating over 13,500 cubic yards of roadway, installing 80,600 square yards of geo-grid and permeable separator, placing 6,500 cubic yards of UTB, 8,500 tons of four-inch ATB, 5,200 tons of 2.5-inch mix V and the reconstruction of 16,100-linear-feet of Kaupakalua Road.

#### Local 3 members celebrates 100th birthday

On Dec. 8, member Robert "Bob" Miller celebrated his 100th birthday! This last May, Bob and his wife, **Betty**, celebrated their 75th anniversary with their family, including their children, Kenneth and Brenda, and reminisced about Robert's career.

"Dad would come home from work every once in a while with a wild animal to give us kids as pets," said Brenda. "We had a jack rabbit for awhile, and dad built a nice-size rabbit cage for it. Then, one time, we had a king snake that I got to take to school for show and tell."

Before moving to the Bay Area, joining Local 3 and starting a family, Bob lived in Montana and lived a life of adventure and uncertainty. On Dec. 7, 1941, he was serving with the 14th Air Force division on a ship that was heading toward Hawaii, when his captain received word that Japan had bombed Pearl Harbor. The ship was turned back to San Francisco and entered a zig-zag pattern for fear that they could be Japan's next target. In 1942, he flew out to Australia, then to China, and spent 26 months

serving as a supply runner for the Flying Tigers.

In July of 1946, Bob returned to civilian life and joined Operating Engineers Local 3. He built a great career as a heavy equipment operator, which not only supported him and his family, but was something he loved to do. He would remain a

> committed Local 3 member for seven decades, spending most of those years operating dozers and scrapers, as he moved tons of earth on projects that helped shape the Bay Area we know today. He even built the pads his current neighborhood and home were built on.

Retiree Joe Martinez is a 45-year member of Operating Engineers Local 3 and has worked at the Kennecott Copper Mine for 48 years! He served as a steward for his fellow members for 40 of those years, and although he could have retired over two years ago, he decided to keep working until hanging up his hardhat last November.

"I was still able to be a benefit to my employer, my family and my union brothers and sisters," he explained.

Joe says he has no plans to just sit on the sidelines, now that

he is in retirement. He is signed up to be a volunteer for the Voice of the Engineer (VOTE) program and wants to remain involved in other union activities. Volunteering is part of who Joe is, and he has volunteered for many years with the Knights of Columbus, a Catholic organization that helps women and children who have lost their husbands or fathers and serves as a broader community outreach service.

Joe has an impressive union heritage. His father also worked at the Kennecott Copper Mine, starting in 1947, and stayed there until his retirement. Today, Joe has two sons and a son-in-law who are union members (one is a union steward and another is the president of the Steel Workers Union). Joe moved from New Mexico to seek employment at the Kennecott Mine with four brothers

and one sister, and all of them either joined Operating Engineers or the Steel Workers.

Joe first started working at the mine in 1972, as a Steel Worker on a rail gang. Two years later, he joined Operating Engineers as a shovel operator's helper. When the economy took a hit in 1984, the copper mine shut down for two-and-a-half years. It was during that time that the north end of the mine was bought out by **Rio Tinto**. The rail system was removed, as crews were able to transport material more efficiently with haul trucks than with rail cars, and the shovels were upgraded to

> electric shovels, eliminating the need for a shovel helper. That's when Joe was called back to work as an electric shovel operator, and he continued in that position until he finished out his

Joe is a very kind and generous man, which his family and all who know him can attest to. He has been married 48 years, has three children and two grandchildren whom he is proud of. Joe is a wonderful example of sacrifice, dedication and strength, and he has plenty of advice for his union brothers and sisters.

"Don't make a decision on whether you like something or not unless you have at least tested it," he said. "Do not put money before love, and always remember... United we bargain, divided we beg!"



In the meantime, if you would like to see the new building, contact the District Office, and District Rep. **Wyatt Meadows** would be happy to give you a tour.

The High-Speed Rail (HSR) project is picking up steam, as both major sections are preparing to add rail, and sections of overpasses are being paved and made usable. While there is a lot more work to be done, we are expecting only two to three more years before railways are installed and completed. Right-of-ways and permits are also beginning to be let out, which means there will be many more job opportunities.

Solar projects are in full swing and new dispatches going out every day, so make sure to call the District Office and renew your registration on the Out-of-Work List, if you're not currently working.


#### A few tips to be prepared for upcoming work season

Second, make sure your listed classifications are up-to-date with the dispatcher. Most importantly, call the Hall to verify that your contact information is correct! A five-minute phone call could make all the difference in how this season starts off for you. Another way to make this upcoming work season a success is to take advantage of journey-level-upgrade training at the Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC). If you have not taken or scheduled your minimum qualification testing, you should do so as soon as possible.

Currently, members working in our quarries are busy preparing for the upcoming work season, and we are expecting a busy year in our mountain counties, as **Sierra Mountain Construction Inc. (SMCI)**, **Mozingo Construction** and **Sinclair General Engineering** all have projects lined up in the region.

Thank you to all of our brothers and sisters working for Caltrans. They have worked long and hard this winter in order to keep mountain passes safe for travel, and soon they will be clearing and reopening those higher elevation passes that were closed for the winter.

Sonoma County Airport terminal expansion starts

Report

The work picture in our district looks promising, as our contractors have a lot of work on the books and have already gotten started on some of it. The largest is the fire cleanup work being done under a Joint-Venture with Goodfellow Bros., Teichert Construction and Odin Construction (GTO). Crews are cleaning up structures destroyed by fire and removing hazardous debris. Sierra Mountain Construction, Inc. (SMCI) is the subcontractor responsible for removing any hazardous trees. This work is expected to last through the summer and should put quite a few of our members to work. If you are

qualified to perform this work, please contact the Hall to make sure you are on the list!

One of the other large projects in our region is the \$30 million Sonoma County Airport terminal expansion. **Q&D Construction** has been selected as the construction management at-risk contractor for this project, and **Ghilotti Construction** will be onsite as one of the main subcontractors. Stay tuned for more information on this work in the future. In the meantime, stay safe out there!



## How much does it really cost to fake a drug test?

Workplace safety is defined as the act of protecting employees from work-related illness and injury. Nearly 20 percent of all private industry worker fatalities happen in construction. Companies and employees often face litigation based on preventable circumstances, which carry a hefty price tag. Families trudge through countless stressors as a result of lost wages, injuries and other damages, and employers feel the sting of lost productivity, low morale and missed deadlines. Yet we often miss the whole picture. Every person is subject to the human condition, meaning we are all a variable and not robots. This can create the circumstances for accidents. We can take into account human error, which is part of the factor, but how many of these accidents are a result of the 100 percent preventable effect of drug and alcohol use in the workplace?

While the primary focus of workplace safety revolves around the physical safety of a work environment, an increased focus is being directed on drug and alcohol use by employees as a contributing factor to the ever-increasing hazards faced in present-day workplaces. The use of drugs and alcohol serves to hinder necessary functions, such as decision-making, coordination and appropriate reaction responses, and greatly increases the risk of accident, injury and even fatality. The National Council on Alcoholism and Drug Dependence relays alcohol dependent workers are 2.7 times more likely to have injury-related absences. Hospital emergency department studies show that 35 percent of occupational injuries were from at-risk drinkers.

An estimated 14.8 million Americans use illegal drugs, and more than 70 percent of them are employed. The year 2019 shows the highest level of positive drug tests in the last 16 years, with employers facing regular, on-the-job use or employees arriving to the jobsite impaired and unable to perform work safely. Furthermore, drug use can be a contributor to volatility among employees and criminal behavior, such as theft, creating a negative work environment for employees who want to come to work, do their jobs well and return home safely to their families.

Because of these staggering statistics, it isn't uncommon for a company to require drug and/or alcohol testing on a preemployment, post-accident or random basis. Drug testing is implemented to establish a safer work environment with additional benefits, including increased productivity and a reduction in employee turnover. Many employers work diligently to ensure the best possible daily outcome for all present, knowing the magnitude of this uphill battle and the potential harm caused if something is missed. Supervisors are trained on reasonable suspicion and tasked with monitoring their work environment, knowing there is no possible way to have eyes on everything all of the time.

Most of us already know all of this. However, some of us still try to find ways around these rules put in place to keep us all safe and productive. It is said that necessity is the mother of all inventions, and unfortunately, this is true among those who choose to continue to use despite knowledge of the negative consequences of that use. If 70 percent of the estimated 14.8 million Americans using drugs or alcohol are employed, how many of those approximately 10.3 million employees have tried to fake or alter a drug test in an attempt to retain their employment or be hired by a new company? With the internet providing an abundance of "how to" videos enacted by all kinds of actors, from lab coat-sporting professors to blood-shoteyed teenagers, with flashy labeling and comical branding, such as "urine luck" or "Upass" to lure buyers into a false sense of security, it's no surprise the markets are saturated. Other well-known and often utilized methods include using someone else's urine, adding chemicals to a urine sample, delaying drug testing and detoxification

Whether or not a person is successful in pulling off his or her deception, who really wins? What appears as success, such as a negative pre-employment test, can turn around to be a costly positive post-accident test later on. What began as a catchy label advertising a "double money back guarantee," for just \$70, could cause the user the loss of a consistent income for an extended period of time. How much is this worth? The ultimate pull for the person using is to continue the behavior without facing consequences, which wars with the employer's desire to provide a safe, productive jobsite for all. Unfortunately, when someone is under the influence, he or she loses the ability to see past the immediate need for a substance. This can cause the user to compromise the safety of others, leaving them vulnerable to the after-effects of those poor decisions.

Responsibility lies with all of us as individuals. Bringing our best each day to our employment ensures success. Remember, safety is up to us all, and if you find yourself in a position where the compulsion to use is greater than your ability to make the right choice, get help. Your employers are aware of these tactics. It's only a matter of time before you are caught. Why not get help before that happens? #### **ELECTION COMMITTEE NOTICE**

Bruce Noel, Recording-Corresponding Secretary of Operating Engineers Local Union No. 3, announces that in conformity with Article XII, Section 3(b), Elections, of the Local Union Bylaws, elections for Members of the Election Committee will be held in March at each district's Special Called Meeting. The Committee will conduct the 2021 election of Officers and Executive Board Members.

## ARTICLE XII, SECTIONS:

- (a) The election of Officers and District Members of the Local Union Executive Board shall be held during the month of August by mail referendum vote of the Membership of this Local Union under the supervision of the Election Committee and a firm of Certified Public Accountants, selected by the Executive Board, with such other technical and legal assistance as may be provided.
- (b) The election shall be conducted by a committee known as the Election Committee composed

Committee, composed of one (1) Member from each District in which nominations will be made. The Member shall be nominated and elected by secret ballot at the regular quarterly or specially called District Meetings by vote of those Members present whose last known address, as shown on the records of the Local Union ten (10) days prior to the first such District Meeting in March preceding the election, was within the area covered by the District. Each nominee shall be a registered voter in the District in which he or she is nominated, shall have been a Member of the Parent Local of Operating Engineers Local Union No. 3 for five (5) years next preceding his or her nomination and election, and shall not be a candidate or nominator of a candidate for any

Office or Position.

The nominee for Committee Member in each District receiving the highest number of votes shall be elected, and, in the event he or she is unable or unwilling to serve, shall be replaced by the nominee with the next highest number of votes, and he or she, under the same circumstances, by the next highest, and so on, until the list of nominees is exhausted.

## 2021 POLITICAL ACTION COMMITTEE ELECTION

Recording-Corresponding Secretary Bruce Noel has announced that in accordance with Article X, Section 9 of the Local Union Bylaws, the election of Political Action Committee (PAC) members will take place at the Special Called Meeting of 2021 in each respective district. No member shall be eligible for election, be elected or hold the position of PAC member:

1. Unless he or she is a continuous member in the parent local union for one (1) year preceding nomination and not suspended for nonpayment

- of dues during that one year and a registered voter (with proof of current voter registration) in the district where he or she is seeking nomination;
- 2. If he or she is retired, is an officer of, or is on the payroll of the local union or a related entity;
- 3. If he or she is an owner-operator or a contractor;
- 4. No member shall be nominated unless he or she is present at the meeting, or unless he or she has filed prior to the meeting with the Recording-Corresponding Secretary or to the District Meeting secretary on the day of the meeting before the meeting commences a statement in writing, signed by him or her, to the effect that he or she is eligible to be a PAC member and will accept the nomination if nominated.

#### **LOCAL 3 SCHOLARSHIP FOUNDATION CONTEST RULES FOR 2021**

The Local 3 Officers, Executive Board and the Scholarship Board of Directors understand that the workplace is rapidly changing, and many jobs require skills that can be attained only with a good education. Local 3 is dedicated to giving our young people the opportunity to succeed by providing them with the chance to further their education and training. For this reason, Local 3 awards annual scholarships to children, stepchildren and foster children of Local 3 members.

Local 3 awards two types of scholarships: **Academic Scholarships** (winners are judged based on academic qualifications) and **Merit Scholarships** (winners are selected through a random raffle drawing).

Please note: Academic Scholarship applicants who do not win are <u>automatically</u> entered into the Merit Scholarship raffle drawing (at the July Executive Board Meeting). Please do not submit multiple applications.

## All applications <u>must</u> be <u>postmarked</u> on or by March 31, 2021.

#### **WHO MAY APPLY**

Children (including stepchildren and foster children) of Local 3 members may apply for the scholarships. The parent of the applicant must be a member for at least one year immediately preceding the date of the application. Grandchildren are only eligible to apply if their grandparent (member) is their legal guardian. Children of deceased members are eligible to apply for the scholarships if the parent of the applicant was a member for at least one year immediately preceding the date of death.

#### **ACADEMIC SCHOLARSHIPS**

Six Academic Scholarships will be awarded to children of Local 3 members.

#### » 1st place - \$15,000 total

Two scholarships of \$6,000 each will be awarded to the first-place female and male applicant, with an additional \$3,000 each for the second, third and fourth years of college if they remain a full-time student.

#### » 2<sup>nd</sup> place - \$12,500 total

Two scholarships of \$5,000 each will be awarded to the second-place female and male applicant, with an additional \$2,500 each for the second, third and fourth years of college if they remain a full-time student.

#### » 3<sup>rd</sup> place - \$10,000 total

Two scholarships of \$4,000 each will be awarded to the third-place female and male applicant, with an additional \$2,000 each for the second, third and fourth years of college if they remain a full-time student.

These scholarships can only be used for study at an accredited college or university located in the United States and will not impose restrictions of any kind on the course of study. Recipients may accept any other grants or awards that do not rule out scholarship aid from other sources. Winners must submit proof of full-time enrollment to receive payment.

Academic Scholarship applicants must be a graduating high school student who has, or will be, graduated at the end of either the fall semester (beginning in 2020) or the spring semester (beginning in 2021) in public, private or parochial schools. They must plan to attend an accredited college or university anywhere in the United States during the academic year and be able to meet the academic requirements for entrance into the university or college of their choice. Students selected for a scholarship must have achieved not less than a 3.0 ("B") weighted grade point average in their high school work.

#### **AWARDING ACADEMIC SCHOLARSHIPS**

Upon receipt of the application package, the membership of the parent will be verified. The application will then be submitted for judging to the University of California Berkeley Scholarship Selection Committee, an independent outside group composed entirely of professional educators.

Apart from verifying the eligibility of the applicant, Local 3 will not indicate in any way that one applicant should be favored over another. The University of California Berkeley Scholarship Selection Committee will submit their selected finalists to the Scholarship Foundation's Board of Directors for approval.

Academic Scholarship winners will be notified by Local 3 and posted on www.oe3.org.

## REQUIREMENTS FOR ACADEMIC SCHOLARSHIPS

The following items must be submitted together by the applicant (unless it is the policy of the school to submit the Report on Applicant and Official Transcript directly).

- **1. Application** filled out by student
- 2. Essay written by student
- **3. Report on applicant** filled out by authorized school representative
- **4. Official transcript** from school (signed or stamped)
- **5. Letters of recommendation** one to three letters from teachers, community leaders, family friends, or others who know the applicant must give information about the applicant's character and ability

**Note:** Winners will be contacted for a photograph to be used in *Engineers News*.

#### MERIT SCHOLARSHIPS

In addition to the six Academic Scholarships, Local 3's Scholarship Foundation will award 25 Merit Scholarships in the amount of \$2,000. Children (including stepchildren and foster children) of Local 3 members who are currently attending or planning to attend college or trade school full-time in the next year may apply for the scholarship.

#### **AWARDING MERIT SCHOLARSHIPS**

Upon receipt of the application and required essay, the membership of the parent will be verified. Apart from verifying the eligibility of the applicant, Local 3 will not exercise any choice among the various applicants. The Merit Scholarship winners will not be judged on academic qualifications but will instead be selected through a raffle drawing held at Local 3's July Executive Board meeting. Previous Merit Scholarship winners and applicants may re-apply each year. Applicants need not be present to win; winners will be notified by Local 3 and posted on www.oe3.org. Winners must submit proof of full-time enrollment to receive payment.


