Initial 2. The Employer recognizes that by making such a request, he has referred an Applicant under the
provisions of the JAC Standards for "Employer Referrals". **The Employer certifies that the Applicant
has been employed by the referring employer and that said Applicant is familiar with the work of an
Operating Engineer.**

Initial 3. In consideration of the JAC waiving the eight-week POP Program at RMTTC, the Employer agrees to
retain the services of the Employer Referral Applicant for his/her entire POP period (i.e.: 1120 hours)
unless said apprentice shall have been: 1) laid off due to lack of work and the Employer is in compliance
with its apprentice manning requirements, or 2) terminated for just cause by the employer.

4. The Employer is aware that when this Applicant is indentured into the Apprenticeship Program, he/she
will be required to complete **320** hours of Supplemental Related Training (SRT), and that as an apprentice
he/she will be dispatched to Rancho Murieta Training Center **four times (80 hours per class)** during
his/her Apprenticeship Program at the direction of the JAC. _____
