Stronger together

If you didn't get a chance to watch the Semi-Annual video on our official Local 3 YouTube page, please do so. There's a lot of good information there about how well Local 3 is doing on all fronts, Pension, Health and Welfare and agreements and some very positive projections for the future.

Speaking of those projections, because of the unheard of Pension return of \$5.18 billion (highest ever) as of July 31, 2021 (preliminary, unaudited), our Pension Fund is projected to be in the Green Zone (funding status) by 2023, three years earlier than previously projected, based on the current market trend.

Because of false information given out on our Pension during the internal election, I want to establish the facts. The Pension is set to be in the Green Zone with current "market trends," because in the last 10 years, we have achieved over 9 percent in Pension returns. If we hit the 7.5 percent benchmark for the next two years, we will be over 80 percent funded. Some may say, "We doubled our Fund, so why aren't we in the Green Zone already?" Unlike your 401(K), which you don't touch until your retirement date, we pay out nearly 10 percent a year, in Pension payments to Retirees. Remember, that is what it's for. Also, remember that we grew the Fund to a record \$5.18 billion in the middle of a pandemic. That's by having the right people in the right place, doing the right things. And thanks to this membership who elected the current administration, we have the right people in office. You have obviously seen the growth we have made in the last three years, how we have handled the pandemic, improved our Funds and stayed connected to you all in many different ways, even without standard meetings and events. You voted for experience, and I am grateful for that, because your vote proves that you respect and honor this union as much as we do. I am humbled to serve you.

I also want to remind you that these internal elections and external elections have consequences every time. That is why

we approach politics as we do, constantly assessing how certain measures or candidates stack against our needs for work, collective bargaining agreements and union protections. You should use the same approach during an internal election. Thank you for those who participated in the democratic process for this election. Remember that sometimes not voting is even worse than voting for the wrong candidate.

Though these past few years have not been easy ones, and though we had no playbook on how to address so many changing protocols and events, it has been nice to share such positive news about the state of our union. I remember all too well, sitting before the membership as an officer during the Great Recession, when our Pension Fund dipped to below \$2.6 billion in December 2008. We had to discuss over and over again how the economy was free-falling, the private market was drying up and work hours were dipping. Many were out of jobs across our country, but the economy, and Local 3, specifically, came out of those dark times, just as we came out of the stock market decline at the start of the pandemic (30 percent in just 30 days).

The ability to overcome that, as well as the ability to overcome this global pandemic, has proven that Local 3 survives and thrives no matter what is thrown at us. This is because of your staff and your skillset, as well as your dedication to what you do.

When things are going well, we often don't think to get involved, but even in good times, I urge you all to stay in contact with your district office, continue to get your upgrade-training from your state's training center, be in communication with your job steward or foreman, and when we can finally have in-person meetings, attend them. We are stronger when we are all in it together.

Stay safe out there. Keep talking with each other and stay connected, and I sure hope we can see you all again very soon.

Several Public Employee victories go on behind the scenes

I first want to thank you all for electing me to serve another three years as your president. It means a lot to me and this administration that you have put your confidence in us, and believe me, you have made the right decision. Operating Engineers Local 3 is doing the best it ever has, in terms of our Pension and Health and Welfare Funds, even in the middle of the ongoing pandemic, fires and changing guidelines. Business Manager Dan Reding addresses much of this during his filmed Semi-Annual speech, available on Local 3's official YouTube page. Please check the video out, if you haven't already.

Some of the other recent gains we have made include many Public Employee victories, including several rulings in our favor by the Public Employment Relations Board (PERB). Some of these included a County Employees Management Association (CEMA) member who was vindicated after being retaliated against by her employer. We were also able to get two engineer-conductors from the Sonoma Marin Area Rail Transit (SMART) their jobs back with backpay, after they were wrongfully terminated for over a year.

PERB also rejected an Unfair Labor Practice (ULP) charge filed by the notoriously anti-union National Right to Work Legal Defense Foundation against us, proving that their claims were unfounded.

Regarding Newmont Gold Mines (NGM) and our thousands of members working in the mining industry in Elko, Nev., we continue our tireless efforts to handle our members' grievances and organizing more of the mining membership, and we have seen our relationship with NGM improve, as well. We have also ran a few ads and a video about our union's efforts in the *Elko Daily Free Press*, which is seen by the residents of Elko and most notably the mining community. Local 3 continues to gain ground in the public eye, which only serves our overall purposes.

Local 3 advances the interests of our members from the public and private sector every day. A lot of this goes on behind the scenes, but they are huge gains for Labor. Again, thanks for your support, and I will continue to update you on all the good things ahead for Operating Engineers Local 3.



Throughout this time, these members make interstate travel over California's mountain passes, as well as recreational travel into the Sierra Mountains, possible, all while keeping roadways safe for those who live in the region.

Doing snow removal work is a great way for Operating Engineers to stay busy and keep pulling in a paycheck through the winter, and

as the Officer in Charge for Unit 12, I can tell you that we get a lot of members asking us just how to get that work. This year, I wanted to answer that question before that work really gets underway.

To become a Permanent Intermittent Worker, Local 3 members must take an examination, get a passing score and have their name added to an employment list. To get started, visit www.CalCareers.ca.gov, where you can view employment vacancies and go over the step-by-step instructions for applying. Vacancies can also be viewed at www.dot.ca.gov/jobs/vacancy.html.

The career of a Unit 12 Tractor Operator-Laborer encompasses quite a lot, and we thank our members for doing all that they do to provide a safe and beneficial environment for California's natural resources. Keep these members in mind the next time you take advantage of these open spaces.

With the fire season also comes many work opportunities, as we have experienced in past fire seasons. It's a worthy cause to help create a sense of forward movement for communities who have lost everything, especially if your cleanup and rebuilding



efforts involve your own community. The officers of Local 3 have been working diligently with the California Office of Emergency Services (Cal OES), Cal-Fire and the Governor's office to ensure that the cleanup work is done with Local 3 members, as we are the most skilled and trained to perform this sensitive kind of work. However, the only way to get that work is if every single member who is interested is up-to-date on the required safety credentials. A 40-hour HAZWOPER card is a must. We can only get this work, if we are certified to provide it, and we do not want untrained out-of-state workers coming in and taking it.

To make this work possible for those interested, we have conducted 40-hour classes and have eight-hour refreshers available this year and next. See page 13 in this edition for the schedule, and feel free to contact myself, the Operating Engineers Local 3 Journeyman and Apprenticeship Training Center (OE3 JATC) or Director of Safety/Special Rep. Michael Strunk with any questions or concerns. Contact information is available on the OE3 Mobile App or by calling your district office.

Thank you again for trusting me and allowing me to continue serving you. I look forward to the next time we can meet in person.

New medical plan for those eligible for Medicare

Medicare-eligible Retirees and their spouses will have access to a new medical plan very soon. Local 3, in partnership with Labor First, is excited to announce that **effective Jan. 1, 2022**, the Anthem Medicare Advantage (MA) plan will be the new medical plan for current and future Medicare-eligible Retirees and their spouses.

This plan will provide comprehensive medical coverage with access to see any Medicare contracted provider or hospital with no co-pays or deductibles for any Medicare-covered services. Be

on the lookout for an announcement letter from the Trust Funds office regarding this new plan, FAQs and other comprehensive information. Also, we will be holding virtual meetings to explain the new plan in greater detail. **There will be NO changes to the Retiree premiums, prescription drug plan through Optum RX, vision plan, hearing aid reimbursement or dental plan.** Stay tuned for more information on the dates of these meetings.

Pension Processing Time Table

If you are getting ready to retire, the question is, what do you do, and when do you do it? First, there are three packets of important paperwork involved in this process.

The first packet is the Pension Application, the second is the Pension enrollment packet, where you choose your payment option (how much you will receive monthly for your lifetime), and the third is the Pensioned Health and Welfare packet, if you qualify.

STEP 1 You should submit the Pension Application to the Trust Funds Office about three months in advance of your retirement date, if you were never divorced, or about six months in advance, if you were divorced. You can access this application by visiting the Trust Funds website at (www.oe3trustfunds.org), getting a copy at your District Office or having one mailed/e-mailed to you by calling the Trust Funds Office at **(510) 671-8827**.

STEP 2 About one month before your requested retirement date, we will mail you an enrollment packet. When you receive this, it is a good idea to call the Trust Funds Office at **(707) 290-1834** or **(510) 671-8827** to schedule a phone or video consultation with us. You will be choosing how much money you will receive monthly for your lifetime, so it is important to make the right decision with guidance.

STEP 3 During the first of the month of your retirement, the Trust Funds Office will deposit your Pension money in the account of your choice for the upcoming month. We will also mail you a voucher with the gross Pension amount and any line-item deductions, for your records. You will receive these monthly payments for your lifetime.

STEP 4 If you qualify for Pensioned Health and Welfare, you will automatically be sent an enrollment packet about two weeks after your first Pension payment. Contact us should you need assistance filling it out.

It is very important that you make the right decisions for your individual situation, and equally important that you understand those decisions completely. These are lifetime choices, and once you choose a Pension payment option, it can never be changed. We are here to help at any time – just give us a call!

El Dorado Transit operators ratify one-year agreement

Around this time last year, representatives of El Dorado Transit were talking with me to initiate a section in the Memorandum of Understanding (MOU) about Reduction in Force (RIF), also known as layoffs, due to the drop in ridership and revenue related to the COVID-19 pandemic. Though it was only about a year ago, a lot has happened for this bargaining unit since that time. Ridership has picked up, along with revenue (some suspended routes have been reinstated) and a new route has been added (Lake Tahoe). Most employees have been brought back from the layoff list.

Our contract expired on June 30, and in late May, negotiation team members Jayson Ravens, Bradford Goode, Steve Kubat and I negotiated a one-year contract with modest and respectable terms. We didn’t get everything we wanted, but we knew we had to be realistic. (A one-year contract was sensible.)

TERMS OF THE NEW ONE-YEAR CONTRACT:

- » **A 1.5 PERCENT BASE WAGE INCREASE.**
- » **THE ADDITION OF A SHOP STEWARD TO ASSIST WITH UNION BUSINESS.**
- » **FOR OVERTIME WORKED ON ANY HOLIDAY, COMPENSATORY TIME ACCRUAL IS NOW THE EMPLOYEE’S CHOICE – PAY OR COMP TIME (USED TO BE MANAGEMENT’S CHOICE).**
- » **DESIGNATED TRAINER PAY SIDE LETTER EXTENDED ONE MORE YEAR.**
- » **SHORED UP RIF LANGUAGE (THE PAST LANGUAGE DIDN’T SPEAK ON HOW TO BREAK A TIE WHEN TWO OR MORE EMPLOYEES HAD THE SAME SENIORITY TIME; WE ADDED A TIEBREAK MECHANISM; WHEN TWO OR MORE EMPLOYEES HAVE THE SAME SENIORITY TIME, THE DATE AND TIME OF WHEN THE APPLICATION WAS SUBMITTED (TIME STAMP) IS THE TIEBREAKER.)**
- » **MOST IMPORTANTLY, WE PRESERVED THE BENCHMARK CALCULATION FORMULA EL DORADO TRANSIT USES TO DETERMINE THE EMPLOYEES’ SHARE AND EL DORADO TRANSIT’S SHARE FOR MEDICAL COST CONTRIBUTIONS EACH MONTH, WHICH LOCAL 3 NEGOTIATED AT ZERO COST FOR THE EMPLOYEES WHO ARE IN OE3 MEDICAL OR A SLIGHT OUT OF POCKET FOR THOSE EMPLOYEES WHO OPTED FOR EL DORADO COUNTY MEDICAL.**

I want to thank Jayson, Bradford and Steve for a job well done. This round of negotiations was done in record time, and I look forward to working with them again in the near future.



How can we help our communities destroyed by fire?

Devastating fires have burned more than 2 million acres across California, and more than a dozen large wildfires are still burning. Among the most notable includes the state's second-largest fire on record, the Dixie Fire, which has hit northern Sierra Nevada and the southern cascades region, destroying almost 1 million acres. To the south near Lake Tahoe, the Caldor Fire forced South Lake Tahoe residents to flee, as 1,000 structures, including more than 700 homes, were destroyed. The Monument Fire, which has burned almost 300 square miles of the Shasta-Trinity National Forest and threatened more than 10,000 structures, has also impacted California residents. And these are just a few of the fires.

What can we, as Operating Engineers do?

First, if you have lost a home or property to a fire, please contact your District Office, as staff there may be able to help you receive assistance, available from the International Union of Operating Engineers (IUOE).

Secondly, get involved in the cleanup and repair efforts. You can be a part of the essential workforce that provides devastated communities with a sense of a better future by helping cleanup the fire sites and then providing necessary rebuilding efforts. To do this, you must become Hazardous Materials (HAZMAT) certified. The union and the Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC) are providing many HAZMAT refresher courses throughout its district offices, which run through April of next year. Please refer to the dates and times of these classes below. Call your District Office for more information. To participate, you must be able to provide your current HAZMAT card.

In times of ongoing crisis, as the present times are, there is no better way to move beyond whatever struggles we're having, than to help out someone else. Fire cleanup, especially in your own community, is a great way to start!



It's an annual thing. Dredging. Our members with various signatory dredge companies regularly provide dredging in areas like the Port of Stockton and the Port of Oakland, removing the sediment and sands that sweep in with the ever-moving tide. It is necessary work along 20 miles of waterfront from the Oakland Airport to the Bay Bridge, where giant cargo ships and vessels must be able to clear 50-foot-deep channels. Recently, we caught up with a well-balanced crew of union veterans and apprentices with Dutra, providing regular dredging at the Port of Oakland with the massive Derrick Barge (DB) 24, and with help from the ferry boat (the Danny G) and the tinder boat, (the Phyllis T).

The DB 24, with Operator Tim Back and 20-year member/Capt. John Boykin, uses a swinging clamshell bucket to remove 800,000 cubic yards of material over a very short timeframe from the inner and outer harbor. It is literally a balancing act, not just with the

constant pull and drop of the unmistakable red bucket, but between Phyllis T Boat Operator Andre Lay and Apprentice Julio Colchado, transporting workers to and from their ocean jobsite, to Danny G Boat Operator Torin Ashby and deckhands Ben Rodriguez and Taylor Dill positioning the anchor for accurate stability.

Boykin, who definitely knows his dredging, found out about this line of work "from a guy at a bar," and has been doing it ever since. It's dirty, wet, salty and cold, but on days when the fog has rolled out and the Bay Area skyline can be seen, these crews get to breathe in ocean air and see office views thousands of tourists pay to visit year-round. Many, like Andre Lay, grew up around the water. Others, first worked on dirt crews and appreciated the change of scenery. Either way, dredging crews feel like the sea is always with them. It's a Dredging Thing. ✨

Demolition crews make way for new projects

Report

In San Francisco, near the **John S. Hensill** Hall off 19th Avenue, members with **Silverado** are demolishing and replacing the old San Francisco State University (SFSU) science building using three Link-Belt 750x4 excavators onsite with four-yard buckets and thumbs and two 350x4 excavators, one with a claw attachment. The concrete and rebar from the foundation and walls is being separated for off-haul. Members onsite include operators **Bertin Fierro**, **Raul Romo** and **James Frazee** and Heavy Duty Repairer (HDR) **Amarjit Singh**.

On McAllister Street near City Hall, **Malcolm Drilling** is demolishing old student housing units at UC Hastings Law School and making way for a new, 15-story building. The building will need substantial foundation work, so **Malcolm Drilling** has Crane Operator **Scott Ross**, drill operators **Alex Peralta**, **Dustin Sellers** and **Vince Pokrywka** and Apprentice **Abonie Barnes** shoring and drilling 375 auger cast piles. Others with **Silverado** will do the 25-foot dig-out.

At Bay Area Rapid Transit's (BART's) Balboa Park Station, **Cahill** is working on the Office of Housing and Community Development's Upper Yard project, which includes 131 units of affordable housing, a new transit plaza with safety upgrades, a path along Geneva Avenue and a new passenger-loading zone. **Silverado** operators **Pedro Quintero**, **Bertin Fierros** and **Iroane Olive** will demolish railroad ties, concrete paths and the retaining wall, then excavate 12 feet for the foundation work. **Drill Tech** has Foreman **Hector Perez**, Foreman **Nick Michalowski** and Drill Operator **Keneth Holt** putting in stone columns, micro piles and shoring.

In San Mateo County, **Half Moon Bay Grading & Paving Co.** has operators **Gary I. Giovannoni Sr.**, **Gary I. Giovannoni Jr.**, **John W. Giovannoni** and **Oswaldo Ramos Palomino** site grading for the \$23 million, mixed-use Big Wave project. In San Bruno, **Jos. J. Albanese, Inc.** has operators **Bruce E. Beausoleil**, **Jeffery Jones**, **Raul A. Delgado**, **Ron Ison** and **Steven Underwood** adding 440,000 square feet to the new YouTube Headquarters. They are currently creating below-grade parking, working on underground utilities and site grading. In Menlo Park, **Graniterock Construction** has operators **Jesus Hernandez**, **Jose Mascorro**, **Steven W. Lanning** and **Josh Congdon** working on the \$1.1 million Bay Front Canal and Flood Management and Restoration project, which will help mitigate and reduce the impact of flooding in the area.

Billions of dollars in work will be performed by Local 3 members, thanks to PLAs

Report

In Santa Clara County, Project Labor Agreements (PLAs) are helping to secure more work for our members. In just the last month, and in partnership with the Santa Clara and San Benito Counties Building and Construction Trades Council, Local 3 was able to ensure that \$20 billion worth of work will be done using union labor! As a result, there will be an abundance of work with the Santa Clara Valley Water District, the Santa Clara Valley Transportation Authority (VTA), the West Valley-Mission Community College District (WVMCCD) and many more private and public entities around the Bay Area. This year, our members will be working under a PLA to update the Santa Clara Valley Medical Center campus and adding a new, \$114 million Behavioral Health Service Center. There are many different aspects of this project that will be performed by our members with many different signatory contractors.

Guerra Construction operators **Hector Rodriguez** and **Simon Lepe** are performing fire restoration work at the James Lick Observatory on Mt. Hamilton. This work was much-needed after last year's devastating Santa Clara Complex Fire. **Guerra Construction** operators **Fernando Preciado, Julian Reyes** and **Jose Sanchez** are using materials from the nearby **Reed and Graham** asphalt plant to work on a tennis court rehabilitation project at East Side Union High School. This work is also being done under a PLA.

Redgwick Construction Company has Apprentice **Elizabeth Polcer** and thirty-eight-year member **Ken Davis** making \$2.1 million worth of improvements to the sports complex at Thomas Russell Middle School. The project is being done under a PLA with the Milpitas Unified School District.

(CEMA). 
Gone but not forgotten

Members complete middle school project

Report

In Sacramento, the **Granite Aggregate and Asphalt Plant** off of Bradshaw Road has had zero Occupational Safety and Health Administration (OSHA) recordable events since March 2014, all while averaging 1.1 million tons of production per year. Our members are able to safely keep up with that level of productivity due to safety programs like Speak Up and Listen Up and the Craft Safety Connection (CSC), and with over 20 years of reserves, the plant will continue to be central to work in the Sacramento Valley for some time. Keep up the good work!

Members with **Broward Builders, Don Lawley Company, Preston Pipelines, Studebaker Brown Electric, Consolidated Engineering Laboratories (CEL), Interstate Concrete Pumping and Szeremi Sweeping** recently completed the \$60 million, two-story Arden Middle School project on Watt Avenue. Crews worked seven days a week and got plenty of overtime. The project had to be completed prior to the new school year and included demolition of the old middle school, installation of underground infrastructure and the construction of a parking lot. The demolition work was done by **Don Lawley Company**. **Broward Builders** performed the earthwork, grading and paving, after installing the water, sewer and storm drains. **Preston Pipelines** performed the underground

work on the second phase of the project. **Studebaker Brown Electric** installed new electrical, dry utilities and overhead lighting. **Consolidated Engineering Laboratories (CEL)** performed all the special inspections. **Interstate Concrete Pumping** did the concrete pumping, and **Szeremi Sweeping** kept the site clean.

T&S Construction is working on the \$30.7 million Storm Water Pump Station Outfall project, which will be vital to the development of the railyards. Subcontractors include **Malcolm Drilling, RNR Construction, M&M Electric, Teichert Construction and Baker-Williams Engineering Group**. Others are yet to be determined. **Malcolm Drilling** Operator **Bill Lea** and Oiler **Tyson Roberts** completed 90 Deep Soil Mixing (DSM) foundational support piles at nine feet in diameter, 180 at five feet in diameter and 135 secant piles at three feet in diameter.


Elko's summer work season was busy, and members have worked a lot of hours. **Acha Construction** has been working on a new project in West Wendover and has picked up some new projects throughout the

Members build warehouses and housing developments

Report

Private work continues to keep our members busy, and crews are rushing to get those projects completed before the rains come. **Teichert Construction, Marques Pipeline, Smith Denison, Pacific Excavation** and **Knife River** are working on several housing developments in Manteca. **DeSilva Gates** and

Mozingo Construction are working on an Amazon fulfillment center at the Turlock Regional Industrial Park. **Goodfellow Bros., Mozingo Construction, Griffin Soil** and **Tracy Grading and Paving** are working on several warehouses at the Prologis International Park of Commerce, the largest master-planned park in Northern California. Crews broke ground on this project seven years ago, and it has provided local work ever since.

Our members with **Independent Construction** recently moved 1,000,000 yards of dirt for Phase 1B of the Tracy Hills project, which is a 5,000-lot housing development. This project has kept our brothers and sisters busy since they broke ground on it in 2016. Phase 2 is projected to start next year, providing even more work for members.

Let's stop talking about Sites Reservoir and actually build it!

Report

At the time of this writing, there does not seem to be any slowdown in work hours for our district, and there are still plenty of projects going out to bid. Sadly, we are also experiencing multiple wildfires in the region. Thousands of structures have already been lost, and that number will likely increase, by the time this goes to press. If you (or a Local 3 member you know) lost a home or property, please call the Hall. You may be eligible for assistance from the International Union of Operating Engineers (IUOE) and Local 3's disaster relief funds.


Mother Nature has been cruel to the North State over the last 10 to 15 years, with either too much or too little water, and the current, never-ending drought is one of the many reasons for these extreme fires. The lack of rain and snow has not only contributed to a tinder-dry forest, it has severely affected California's water storage. This is why additional surface storage is so desperately needed, bringing the proposal to build Sites Reservoir to the forefront once again. At one time or another, everyone has heard "talk" about this project. Well, the time for talk is over. It is now time to build Sites Reservoir! We are meeting with state leaders, the Sites Board

Authority and some stakeholders and water purchasers, and we will need member participation to convince the powers to be to do the right thing and fast-track this project.

A series of five widening projects on Hwy. 70 from Oroville to Marysville have been providing years of work for our members. Two of these projects are completed, and a third will be this season. **Teichert, Knife River** and **MCM** were the principal contractors on the projects, which totaled nearly \$100 million. **Teichert** and **MCM** will be starting a forth section this season, completing everything from Oroville to the Yuba County Line, including three bridges. The last two projects are estimated to be worth another \$100 million or more, and will increase safety by widening the road to five lanes, including a continuous turn

lane and eight-foot shoulders. For more information on this project or any others in the district, contact the Hall.

Please continue to protect yourself and others at home and on the jobsite from exposure to COVID-19. Unfortunately, we have seen an increased number of positive cases throughout our jurisdiction, but our membership has done an incredible job so far, and our work hours prove it. Keep it up and look out for your union brothers and sisters.

Bypass at Bayside Cutoff is awarded

Report

Our members worked on projects all over Humboldt and Del Norte Counties this work season. Humboldt County had several storm damage repair projects, as well as some road projects in outlying areas. Alderpoint Road, which is a back road that stretches from Hwy. 36 near Bridgeville to Garberville had several sections repaired by **Granite Construction** and **Steelhead Construction**. **Wahlund Construction** had storm damage repair projects in two locations on Mattole Road, which connects Shelter Cove to Ferndale. **Wahlund Construction** was also awarded sewer rehabilitation and water improvement projects by both the City of Eureka and Loleta Community Services. **West Coast Contractors (WCC)** has been repairing Aids to Navigation (ATONs) in the Humboldt Bay and demolishing the Coast Guard boat dock on the Samoa Peninsula.

Mercer-Fraser is the low bidder on the \$56 million bypass at the Bayside Cutoff. This has been a long time coming, as local residents know how dangerous it is to get on Hwy. 101 South from Indianola Way, and there are no safe crossings for the residents and businesses that reside

along the Safety Corridor between Eureka Slough and Arcata. Fortunately, this bypass will eliminate many close calls and accidents. In addition to this, **Mercer-Fraser** continues to replace the concrete barrier on Hwy. 101 near College of the

Redwoods, as well as the soldier pile wall on Hwy. 299 near Willow Creek. The company has also been awarded a project on Hwy. 101 at Ehlers Way in Del Norte County and another paving project on Hwy. 36 near Dinsmore.

October is the usual slow down period in District 40, with many projects limited by an Oct. 15 deadline for environmental reasons. This is also the time of year when we start to see more rain, snow and heavy weather. Thank you to our union brothers and sisters with Caltrans for maintaining the safety of our roads with tree and snow removal during the winter months. When you see these members performing their work, remember to slow down and keep their safety in mind when traveling.

Thank you to our members and their families for their continued support and their patience these past few months, as we adjusted to new office requirements.



WIDENING HWY. 299 ADDRESSES INFRASTRUCTURE NEEDS DURING EMERGENCIES

For most of the traveling public, road construction can feel like a delay-causing annoyance, but for many of the communities served by those projects, that construction can literally provide a lifeline to the outside world. In Northern California's rural, mountainous regions, the need for improved roads and highways has been tragically brought home in recent years. Communities hit by wildfires have experienced Yoshi firsthand the difficulty of evacuating isolated areas that rely on long-neglected transportation infrastructure. Thankfully, an increased focus on funding the vital construction, maintenance and repair of transportation infrastructure (like the Local 3-supported Road Repair and Accountability Act of 2017) is finally making it possible to address those difficulties, all while putting Operating Engineers to work.

A perfect example of this is the work Local 3 members with Mercer-Fraser and Jarrett Foundations have been performing on the Hwy. 299 shoulder-widening project near Willow Creek, Calif. For decades, this narrow roadway has served as a key evacuation

route for communities situated in the forests between Eureka and Redding. In fact, residents had to use the highway as an evacuation route just this year, as the Knob Fire burned through the area. However, using such a narrow roadway as both an evacuation and access route for emergency response vehicles heading in the opposite direction can create its own challenges. Fortunately, the current project to expand the highway's shoulders will create the necessary space for emergency response vehicles and evacuees to share the road in an emergency, allowing faster response times and smoother evacuations.

While projects like these seldom make headlines, a true understanding of their full impact and importance can serve as a reminder of how valuable construction labor is. As a result, Operating Engineers can continue to take pride in knowing that their labor not only supports them and their families, but serves the needs of communities big and small and in a variety of ways. ✨

CERTIFICATION OF ELECTION RESULTS FROM MILLER KAPLAN ARASE LLP

The accounting firm of Miller, Kaplan, Arase & Co., LLP conducted the election. Its report, in part, contained the following information:

We have monitored the tabulation of the ballots cast by members of the Operating Engineers Local Union No. 3 in the September 1, 2021 election of Officers and District Executive Board Members. The procedures we followed in connection with the mailing, receipt and counting of the ballots were in accordance with the applicable provisions of Article XII, Section 3 of the Bylaws of the Operating Engineers Local Union No. 3.

Pursuant to Article XII, Section 7 of the Local Union Bylaws, Bruce Noel, Recording-Corresponding Secretary, cast one ballot for each unopposed candidate in the election of Officers and District Executive Board Members.

The total number of ballots received, ballots disqualified, and ballots determined to be ineligible for any reason are indicated in our report and, in our opinion, accurately present the results of the election based on the ballots received.

ELECTION OF BYLAWS COMMITTEE MEMBERS

Per Article XXX, Section 2 (a) of the Local Union Bylaws, the following eligibility requirements have been established for the Bylaws Committee member nomination and election to be held at the regular fourth (4th) quarter district meetings in the year immediately following the election of Officers and Executive Board Members by secret ballot vote of those members present:

1. Shall be a registered voter (with proof of current voter registration) in the district where he or she is seeking nomination.
2. Shall have been a member of the parent Local of Operating Engineers Local 3 for five (5) years preceding nomination and not suspended for nonpayment of dues during those five (5) years.
3. Cannot be an employer or on the payroll of the Local union or a related entity.
4. No Member shall be nominated unless he or she is present at the meeting, or unless he or she has filed prior to the meeting with the Recording-Corresponding Secretary or to the District Meeting Secretary on the day of the meeting before the meeting commences, a statement in writing, signed by him or her, to the effect that he or she is eligible to serve on the Bylaws Committee and will accept the nomination if nominated.

PROOF OF VOTER REGISTRATION FOR BYLAWS COMMITTEE NOMINEES

Proof of voter registration may be obtained by going to your county Registrar-of-Voter's or County Clerk's office. The cost for a certificate varies by county, but is usually nominal (\$1) or free. All Bylaws Committee Nominees, please bring a copy of proof that you are registered to vote to the District Meeting at which nominations take place. Any member seeking nomination who does not submit proof of registration will not be eligible to hold office.

ELECTION OF GEOGRAPHICAL MARKET AREA COMMITTEE MEMBERS

Election of Geographical Market Area Committee (GMAC) members will take place at each district's regularly scheduled district meeting, except for Hawaii, during the fourth (4th) quarter of 2021. In accordance with Article XXXI of the Local Union Bylaws, elections shall be held at the fourth quarter district meeting of the year in each district after the election and installation of officers. Eligibility rules are as follows:

- a. Must be dispatched and working under a Local 3 construction agreement or registered at the Operating Engineers Job Placement Center seeking a dispatch to work under a construction agreement in his or her district/geographical market area.
- b. Must be a member of the parent Local continuously for the two (2) years preceding nomination and not suspended for nonpayment of dues during those two (2) years.
- c. Must be living in the GMAC's district geographical area.
- d. Must be an "A" list journey-level operator.
- e. Cannot be an owner-operator.
- f. Cannot be a retired member, an officer of the Local union, or on the payroll of the Local union or a related entity.
- g. No member shall be nominated unless he or she is present at the meeting, or unless he or she has filed prior to the meeting with the Recording-Corresponding Secretary or to the District Meeting Secretary on the day of the meeting before the meeting commences, a statement in writing, signed by him or her, to the effect that he or she is eligible to serve on the GMAC and will accept the nomination if nominated.


