## In-person district meetings this month

Please take special note of a few items listed in this edition. First and foremost, we are having in-person District Meetings and Town Hall Meetings starting this month. You will find the dates, times and locations of these meetings on page 28. We will be electing our Political Action Committee (PAC) members at these meetings, so please plan on attending. Our PAC members are very important to the election process for Local 3, as they interview local candidates and ask them candid questions regarding their positions on the things we, as a union, hold dear, such as their stances on Project Labor Agreements (PLAs) and collective bargaining rights. They also review candidates' voting records. This member-elected group does the groundwork for your local races, so that if you find they have endorsed a particular candidate, you can rest assured that they have made the right choice. Your Public Relations staff, Political Department and officers recently met with the staff at the California Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC) to discuss how we can unite around the union's core needs and explain these needs to our new apprentices coming in to the training center. The OE3 JATC staff is the first point of contact for our apprentices and are the most influential people in these apprentices' lives, both in terms of filling them with industry knowledge as well as union knowledge. The message about the union's core needs was well-received, but what was most obvious to us officers was how dedicated your OE3 JATC staff is to improving and changing the lives of our apprentices. They had countless success stories about how an apprentice came in with nothing (some had been homeless and hopeless), and today, some of these apprentices are now running jobs as foremen or are even on the OE3 staff. I hope we can all recognize how invaluable our instructors and coordinators are at all of our fourstate training centers. ## **OE3** reaches Settlement Agreement with Nevada Gold Mines

If you work in Northern Nevada's gold mines, live in the region or have simply been following the story, than you know that

Newmont and Barrick Gold Corp. became a joint venture in 2019 called Nevada Gold Mines (NGM), and immediately went to work trying to bust our union. Fortunately, we were able to present our case to the National Labor Relations Board (NLRB), which agreed that NGM had unlawfully withdrawn its recognition of Local 3, blocked the union from representing employees, changed working terms and conditions without bargaining with the union and discouraged union membership. Faced with the prospect of a federal court injunction and an Unfair Labor Practice (ULP) before the NLRB, the company reversed course and agreed to settle the pending ULP charges, including recognizing Local 3 as the workers' representative and honoring the



Collective Bargaining Agreement (CBA). Despite this win, NGM continued to do everything it could to block the union from fully

representing the membership and continue its business, as usual. Local 3 responded by engaging in an aggressive organizing campaign within the mines, with Elko staff working closely with the Organizing Department to recruit more workers and strengthen our negotiating position and bargaining power, and filing dozens of grievances to enforce the CBA. Those efforts have paid off, and a Settlement Agreement was reached between OE3 and NGM.

Thank you to all of our staff, and especially our members, who worked hard to make sure their collective bargaining rights were maintained and protected, despite the deep pockets and aggressive tactics of their employer!

# EXTRA! **Labor Deug** EXTRA! EXTRA!

#### A highlight of recent news items that are specific to Local 3 and the broader Labor Movement

n March, the U.S. Department of Labor announced it was proposing changes to the Davis-Bacon Act, which is the current Federal Prevailing Wage law. As with all prevailing wage laws. the Davis-Bacon Act prevents the government from using its taxpayerfunded infrastructure investments to drive down the wages of its own citizens, and instead uses that influence to maintain strong wages for American workers. If implemented, the proposed changes would ensure

prevailing wage protections cover more workers, properly reflect current wage rates in their area, systematically keep those prevailing wage rates up-to-date and toughen their enforcement, precisely as funding from the federal infrastructure bill jump starts projects across the nation. Unfortunately, the last time the Davis-Bacon Act was revised was over 40 years ago, leading to the need for prevailing wage rates to be changed to reflect today's modern economy. The International Union of Operating Engineers (IUOE) was joined by the other national Building Trades in organizing a letter-writing campaign in support of these changes from rank-and-

file union members across the country. Thank you to everyone who submitted letters to the Department of Labor, letting representatives know the proposed changes would be welcomed, as they would directly benefit Operating Engineers and their families. Stay tuned for more information, as these proposed changes work their way through the system.

#### The broader Labor Movement

Despite a well-funded anti-union effort, workers at the Staten Island Amazon warehouse in New York successfully organized the first American facility operated by the notoriously anti-union company. Shortly afterwards, another warehouse in New Jersey announced its workers had submitted enough signatures to hold their own union election. Others may be doing the same in the near future. The company is also facing allegations that its representatives interfered with a union election at another facility in Alabama, where workers say the company removed union materials from break rooms, tried to prevent workers from having union discussions by limiting their access to the warehouse before and after their shifts and forced workers to attend anti-union meetings.

## **About Your Pension**

We hope you were able to take advantage of the Pre-Retirement Call-in Meetings held last month. Be on the lookout for information regarding the second round of Pre-Retirement Call-in Meetings, which will be scheduled for October of this year.

One question that comes up often is whether a spouse is entitled to a Pension after the member passes away. The most popular type of Pension benefit is the husband and wife 50 percent option. This is payable for a member's lifetime; however, if the member passes away before his or her spouse, the spouse will then receive half of the Pension for his or her lifetime. Another option is the 60-month Guarantee. If you are single when you retire, or married and your spouse consents in writing to your rejection of the husband and wife Pension, you will receive monthly pension payments guaranteed for a minimum of 60 months after your retirement date. Remember that benefits are payable to the member for his or her lifetime, but if the member lives less than 60 months after retirement, monthly payments will continue to his or her beneficiary for the remainder of the 60-month period. These are only two of the many payment options. Once you complete the Pension application, you will receive an enrollment packet allowing you to choose among the various payment options with your exact dollar amounts that are specific to your individual situation. You can also read about these in the *Pension Summary Plan Description* (SPD) booklet, which is available online at **www.oe3trustfunds.org**.

## **Document requirements for your Pension application**

We get many requests for retirement each month, and each Pension application requires certain documents.

#### Requirements

- \* Proof of your age (see below)
- \* Marriage license, if married
- \* Proof of your spouse's age (see below)
- \* Death certificate, if widowed
- IMPORTANT: If previously married, divorced or separated, all judgments, qualified domestic relations orders, property settlement agreements
- \* If disabled, a copy of your Social Security Disability Award, including disability onset date

If you have questions, concerns or issues with providing any of these required documents, please call the Trust Funds Office (see below and at right).

#### List of acceptable proof of age for participant/spouse

Provide any of the following records as proof of age for you and your spouse. If you cannot provide a record from Group 1, please submit two items from Group II. Copies are generally acceptable, except as noted below. Any original documents submitted will be returned via certified mail

**Note:** if first and/or last name is not consistent on proof of age, marriage license or any other document submitted, please provide written explanation and documentation with your application.

#### Group I. Submit one of the following:

- 1. Birth certificate
- 2. Baptismal certificate or a statement as to the date of birth shown by a church record, certified by the custodian of such record
- 3. Notification of registration of birth in public registry of the vital statistics
- 4. Certification of record of age by U.S. Census Bureau
- 5. Hospital birth record, certified by the custodian of such birth record
- 6. Foreign church or government record
- 7. Naturalization records (photocopy not permitted submit original)
- 8. Immigration papers (photocopy not permitted submit original)

## Group II. Submit two (2) of the following, if unable to submit one from Group I

- 1. Drivers License
- 2. Military Record
- 3. Passport (submit one copy only)
- 4. Letter from Social Security stating your date of birth as shown in their records.
- 5. School records, certified by custodian of such records.
- 6. Vaccination records, certified by custodian of such records.
- 7. Insurance policy showing date of birth.
- Marriage records showing date of birth (application for marriage license or church record, certified by the custodian of such record; or marriage certificate)
- 9. Signed statement by the physician or midwife who was in attendance at birth, as to the date of birth shown on their records.
- 10. Other evidence, such as signed statements from persons having knowledge of your date of birth.

It took 642 days, 21 meetings with the Board of Directors, 28 bargaining sessions and two rallies, but on April 4, the Operating Engineers reached a tentative agreement with the Golden Gate Bridge District (GGBD). What started as a relatively ordinary bargaining session took a complete nose-dive with the start of the COVID-19 pandemic and the resulting lockdown. All of the bargaining team members were forced to figure out how to bargain in a virtual manner as well as deal with the GGBD's significant loss of revenue.

## City of Santa Rosa Water Department members do it all

I represent three units at the City of Santa Rosa, and one of those units is made up of workers in the Water Department who are classified as Utility Systems Operators, which includes Utility Systems Operator Is and IIs and Senior Utility Systems Operators. The workers in this unit are vital to the safe and efficient flow of water to the Department's customer base throughout the entire city, which is 91 percent residential service and 9 percent commercial service. They perform highly sophisticated operations, construction, repair and maintenance-related activities in support of City water distribution, water quality and wastewater utility operations. These workers are responsible for nearly 1,200 miles of water and sewer pipe, 6,000 fire hydrants, 19 water booster pump stations, 22 water reservoirs and 17 wastewater pump stations. This includes testing, cleaning, leak repair, fire hydrant maintenance, water meter installation, operational emergency response, general construction and more. Anything to do with water or wastewater, these are the workers who get it done, and OE3 is proud to represent them!

## Westlands Water District cares about employees



Westlands Water District has shown its employees appreciation for working through the pandemic by providing each field employee a \$6,000 COVID bonus, even though they did not receive any American Rescue Plan Act money.

After just a few bargaining sessions, Westlands Water District and OE3 agreed on a three-year contract, which, in addition to the COVID bonus, includes health-care contribution benefits. Now, there is no more Tier 2 for health insurance. Every employee will pay the same amount for health insurance, which will put hundreds of dollars a month back into our members' pockets.

Westlands Water District also awarded 15-year employees a \$1,000 bonus and 20-year employees a \$1,500 bonus. There will also be a 9 percent wage increase over three years.

Shop stewards James Isbell and John Johnston were so pleased with the contract that they wanted to present it to the members over a taco lunch. The members voted overwhelmingly to accept the contract. Member/Pipe Fitter Tim Bisbee, who is nearing retirement, said that the total of the COVID bonus and annual bonus will help him pay off his house. A few other members said that the contract was more than they expected because of the drought and the District's lack of water supply. Manager Thomas Birmingham stated in his presentation to the Board that he viewed the relationship between the District and OE3 as a partnership that results in a high level of service to growers. According to Johnston, morale is the highest it's ever been in his 20-plus years with the District. Overall, this was a very good contract for the members and a positive boost for morale.

## Why we vote union

With culture wars driving a lot of today's politics and dominating much of our public discourse, it's easy to forget that voting union means voting with the specific goal of promoting good, local jobs with union rights, safe working conditions, great wages and the kind of health care and retirement benefits working people can build their lives around, regardless of their personal political opinions. To help Local 3 members remain united on these shared goals, the *Engineers News* is highlighting candidates whose pro-union policies resulted in (or will result in) tangible benefits to Operating Engineers.

#### David Isom and Judi Honeychurch

#### Fairfield-Suisun Unified School District Board

Governing Board members David Isom and Judi Honeychurch supported a Project Labor Agreement (PLA) covering Fairfield-Suisun Unified School District projects that exceeded a \$3 million threshold. As of today, this PLA has covered almost \$100 million of work, all of it performed by Local 3 members and their allies in the other Building Trades.

#### Dr. Tony Ubalde and John Fox

#### Vallejo City School District Board

Vallejo City School District Board members Dr. Tony Ubalde and John Fox supported Measure S, a bond measure that funded our work on school construction, improvements and maintenance, as well as a PLA covering any work over a \$1.5 million threshold. Having the support of Ubalde and Fox helped streamline negotiations for the PLA and made the process much more friendly to Operating Engineers.

#### Sheriff Thomas A. Ferrara Solano County Sheriff

Measure AA, also known as the San Francisco Bay Clean Water, Pollution Prevention and Habitat Restoration Measure, was passed in 2016 with support from Sheriff Thomas A. Ferrara. Measure AA covers nine Bay Area counties and included a PLA, which is a major reason the Sheriff supported it, as he personally saw how a PLA helped get a new Solano County detention facility built on time and under budget. With the support of Sheriff Ferrara, the measure passed and Local 3 successfully negotiated the PLA. Today, funding from this measure is keeping Operating Engineers employed on two Montezuma Wetlands Restoration projects and the Haire Ranch Wetlands restoration project along Hwy. 37.

Local 3 members are encouraged to help elected officials understand that embracing pro-union policies like these are how they can earn an endorsement from our member-elected Political Action Committees (PACs), the support of our Voice of the Engineer (VOTE) volunteers and the votes of Local 3's membership. Please review the union's endorsements on the following pages, and remember that when our endorsed candidates and measures pass, tangible benefits to Operating Engineers happen.

Write to your creditors to explain your situation; include what led to the problem and how you plan to fix it. **Put it in perspective.** Do you have your health? The love and support from friends and family? Focus on the good things that are happening in your life. It's hard, but you are going to need to be optimistic to make positive changes.

**Fight inertia.** Doing nothing, while easier than taking action, will get you nowhere. Get up and get out, but resist the urge to shop if your spending is out of hand. If you are already loaded down with debt, and keep receiving offers for more credit cards in the mail, destroy them and throw them away. Consider removing your name from promotional lists by visiting www.optoutprescreen.com or by calling 888-5-OPTOUT (888-567-8688).

**Prioritize your spending.** Chances are, there are some expenses you can reduce or cut out that can relieve some of the pressure. Review your spending and eliminate expenses that aren't absolutely essential. Prioritize according to necessity - basic needs such as food, housing, utilities and children's expenses come first, and everything else after those.

# From the BALLOT BOX TO THE JOBSITE

## VOTE efforts result in good work hours on publicly-funded projects

As Local 3's Voice of the Engineer (VOTE) volunteers gear up for this year's Primary and General elections, previous political victories are funding projects that employ Operating Engineers, while serving as an example of how the union's political efforts are inseparable from the work its members depend on. In Fairfield District 04, three of those projects have been providing steady work hours for Operating Engineers, while strengthening Local 3's Health and Welfare and Pension Funds. These include the I-80/Hwy. 29 Separation Bridge project, the Solano Community College Library replacement project and the Cleo Gordon Elementary School Modernization project.

The \$18 million I-80/Hwy. 29 Separation Bridge project began last year with funding from the Road Repair and Accountability Act, which VOTE volunteers helped pass in 2017. Located just a short distance from the Carquinez Bridge in Vallejo, the project involves the complete removal and replacement of a 173-foot bridge deck. Once completed, the new bridge deck will have an increased vertical clearance and the strength to support a greater load capacity. This project also entails the construction of new bridge approaches, the addition of new drainage inlets and the creation of a path that will connect pedestrians and bicyclists to the Vallejo Bluff Trail on the northbound side of Hwy. 29. Myers and Sons is the general contractor for the project, with subcontractors Blue Iron, Pacific Coast Drilling Co. (PCDC) and Mike Brown Electric having recently completed work onsite. This project will continue to employ Operating Engineers until it is completed next summer.

The \$46 million Solano Community College Library Replacement project is located in Fairfield and began in 2017 with funding from Measure Q, a bond measure that VOTE volunteers helped pass in 2012. A new library was constructed, as part of the project, and operators with Central Valley Engineering (CVE) are currently wrapping it up with the demolition of the old library. In addition to getting this project funded and approved, Local 3 was able to secure a Project Labor Agreement (PLA) with Solano Community College. Operating Engineers and the community also benefitted from the presence of Business Agent Cary Leider on the Citizens' Bond Oversight Committee (CBOC).

"A tradesperson was needed on the oversight committee, and I was happy to be appointed and to serve," he said. "As a member of the oversight committee, I meet regularly with other committee members to make sure that funds set aside for this work are being spent properly."

The \$21.3 million Cleo Gordon Elementary School Modernization project was made possible with funding from Measure J, which VOTE volunteers helped pass in 2016. The project is also located in Fairfield and is being done under a PLA with the Fairfield-Suisun Unified School District that was secured by Local 3 and its allies in the Building Trades. The first phase of the project began last April, with a crew of operators from Bay Cities Paving and Grading starting work on the second phase last month. This project is scheduled for completion next summer, at which time students at the school will benefit from a new, nine-classroom building, a new library, a new play structure, a reconfigured main office with a safer and more secure entrance and an expanded parking and student drop-off area.



#### Public utilities work keeps crews busy

#### Report

The San Francisco Public Utilities Commission (SFPUC) continues to generate work for our members and their signatory employers. At 19<sup>th</sup> Avenue and Vicente Street, **Ward & Burke Tunneling**, one of our newest signatory employers, has Crane Operator Chad Valentine, Excavator Operator Jose Cruz and Operator **Kurt Davidson** upgrading a sewer line that floods during heavy storms. The project involves putting in a 72-inch micro tunnel from 20<sup>th</sup> Avenue to 14<sup>th</sup> Avenue and will keep our members busy 10-hours-a-day, six-days-a-week for the next six months. Just a few blocks away, another SFPUC project is underway at Stern Grove, home of the Stern Grove Festival, an annual, outdoor music festival. Anvil Builders has Excavator Operator Ronnie Sowells and Gradesetter Thomas Butterfield doing emergency work on a large water transmission line that had a valve break and flooded the concert meadow. The work includes removal of debris, restoration of damaged buildings and stabilization of the hillside.

On Vermont Street in San Francisco's Potrero Hill District, **Webcor** is building a \$90 million, six-story office building with underground parking. **Silverado** has operators **Luis F. Santana**, Savvas Halikas, Ian Wells and Apprentice Angel Gonzales doing the mass-excavation, while Malcolm Drilling has Crane Operator Tim Corwin and Drill Operator Danny Bosewell working to shore up the thirty-foot dig out. CF&T Concrete Pumping is also onsite with Operator Luis Tovar.

In San Mateo County, **Hathaway and Dinwiddie** is working on a 23-acre life-science campus in Brisbane. **McGuire and Hester** has operators **Tommy Lee**, **Alfredo Barragan** and **Carlos Ayar** doing the landscaping. In Millbrae, **Goodland Landscape** has operators **Bernabe Cervantes**, **Ascensio Cortes**, **Bill Fontana**, **Joseph Pena**, **Ricardo Perez** and Apprentice **Rudy Rovetti** working on \$52 million worth of field and stadium improvements at Mills High School and Cappuccino High School. **Bockman and Woody** is onsite with members **John Conn** and **Joe Kumanchik** installing new lighting, while **Case Pacific** has operators **Jason Urnberg**, **Robert Tanquileg** and **Josh Strain** drilling for a new sound wall.

Thanks to everyone who volunteered in support of the **Matt Haney** campaign. We hope to see many of you at our next District Meeting on Thursday, May 6 at the Carpenters Hall in Foster City.





#### Work to begin on final phase of Hwy. 101 project

#### Report

**Ghilotti Construction** has been awarded the final phase of the Hwy. 101 widening project, which will start at the south end of Petaluma and continue through the Novato Narrows. This \$78.8 million project will greatly reduce traffic in the area by adding a third lane to both northbound and southbound Hwy. 101. Our members will be busy excavating, doing underground work and grading and paving on this project for years.

This is an election year and there are several state and local races that will have a direct effect on our work and our union, so please get registered to vote, check your voter registration status or, if you've recently moved, your voter registration information. As the season starts to pick back up, you will also want to make sure your contact information is updated with the Hall and keep your registration on the Out-of-Work List current. This will ensure that we can get a hold of you when there is work and get you dispatched. If you have A or B hire status, your registration is valid for 84 days. However, it is recommended that you contact the Hall monthly to renew your registration. Registration for those with C hire status is only valid for the calendar month, so you must call on the first of each month to be placed back on the Out-of-Work List. If there is any job classifications you are not qualified for, contact the Hall about scheduling your minimum qualification testing at the Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC). Scheduling for journey-level upgrade training is also available.



Road reconstruction projects put members to work

Work is going strong throughout the district. **All American Construction, Inc.** has been keeping our members busy on the over \$3 million Fifth Street reconstruction project in Marysville, which will be completed this summer. The work consists of removing and replacing curbs, gutters and sidewalks and grinding and overlaying the roadway. **MJD Engineering** is installing the underground utilities and **St. Francis Electrical** is installing the new signals and electrical.

**DeSilva Gates Construction** has several projects in our district, including work on Hwy. 162 in Oroville, on Hwy. 70 north of Marysville and a couple subdivisions in the Plumas Lake area. **Teichert Construction** is working in Colusa on Hwy. 20 and on multiple subdivisions throughout the region. **Bridgeway Civil Constructors, Inc.** is working on a \$7.2 million project on Hwy. 70 near Feather River Boulevard that involves widening the highway and building new barrier rails. **Knife River Construction** is reconstructing Bridge Street in Yuba City. #### Geneva Rock develops new facilities in Ogden

Report

Report

Over the past decade, **Geneva Rock** has been expanding and establishing a strong presence in northern Utah. With the increased amount of work the company was steadily being awarded, it needed to further develop its facilities and the decision was made to buy and develop a large 32-acre plot of land. Crews began dozing and leveling out the area in 2020, where the company's branch office has been up and running for a couple of years, in order to develop the rest of the property for various aspects of **Geneva Rock**'s business.

Part of the project included the construction of a massive new mechanic shop, which covers approximately 10,000 square feet and includes 10 bay doors, a paint booth, a wash out bay, an oil bay and an additional set of offices. There is also a truck ramp where aggregates can be hauled in on belly dumps, emptied on a

truck ramp and conveyed to a series of aggregate storage silos.

The most prominent features of the new **Geneva Rock** development are the two massive domes that can be seen throughout the Ogden Valley. These domes serve as storage for fly ash and concrete powder that is brought in by a new, partially underground rail track. The amount of pipe and utility work involved was no easy task, but Foreman **Jaysen Jorgensen** did a great job overseeing that aspect of the development. His crew made short work of their task and quickly moved ahead with other aspects of development. This \$54 million endeavor has kept several operators working year-round for two seasons, which is a welcome change in Utah, where it can be difficult to find steady work through the winter months.






## Crews tackle major bridge improvement project

In Fairfield, **Ghilotti Construction** has our members working nights on North Texas Street, as part of a project to replace underground water lines in the downtown area. This work should continue into late summer. **Ghilotti Construction** is also working on a large housing and infrastructure project at Lagoon Valley. **KDW** and **DeSilva Gates** are building new roads for the One Lake project off Vanden Road in Fairfield. This is an ongoing project that will carry over into next year. **O. C. Jones** is adding east- and westbound lanes to Hwy. 80, as part of a project that will continue for three more seasons. The new lanes will run from Airbase Parkway in Fairfield to Hwy. 505 in Vacaville.

Our members with **O. C. Jones** are making major improvements to the bridge at the interchange of Hwy. 80 and Hwy. 29, which is just past the Carquinez Bridge on the Vallejo side, with help from our members with **Pacific Coast Drilling**, **Myers & Sons** and **Mike Brown Electric**. So far, crews have demolished a mid-section of the bridge and are in the process of making repairs to damaged structures. This \$18 million project is being funded by the Road Repair and Accountability Act of 2017 and includes seismic repairs, grinding and paving, which started last June and will keep members busy until the middle of 2023.

On Hwy. 121, **Gordon N. Ball** is working on a \$6 million Caltrans road-widening project that began last October and will wrap up at the end of this year. **Don H. Mahaffey Drilling** is currently performing the cast-in-drilled-hole concrete pilling for the project, which will also include replacing the old bridge, reconstructing the road and creek restoration.



Granite is keeping members busy with fire clean-up work in the Tahoe Basin. Sierra Nevada Construction has numerous projects, including rehab work in the Reno/Sparks area and warehouse work in the Tahoe Regional Industrial Center (TRIC). Our members with Par Western Line and Titan Electric are working on the many rehabilitation projects going on in the area. Ames/Q&D Joint Venture (JV) continues to make progress on the Spaghetti Bowl Xpress (SBX) project. Q&D Construction continues to work on several subdivisions in Spanish Springs.

#### From Elko

Work has been picking up at a steady pace. Acha Construction is nearing completion of a new Maverick fueling station in West Wendover. **Q&D Construction** is working on the Emigrant Gap highway widening project and a paving job with bridge work on I-80 near Wells. Ames Construction is working at the Meikle Mine and has other projects that are expected to keep our members busy all season long. N. A. Degerstrom is working at the Cortez Mine and the Rossi Mine. Remington Construction is finishing a project at Bald Mountain.

At the time of this writing, Gold is sitting at \$1,925.57 and fluctuating daily. New Business Agent Kevin Rains recently visited the South Area mines to update union boards and meet the membership. While there, he was introduced to Nevada Gold Mines' (NGM's) management team and discussed the mine's plan going forward. Our staff will be making two trips to the mines per month, alternating between Surface Operations and Underground. Keep a look out for your agents, as they will want to talk with as many members as they can during these visits. Union staff are also meeting with job stewards, training them so they can better assist our membership in the field and having monthly Negotiating Committee meetings to keep everyone prepared for next year's contract negotiations. Remember, your union is here to help you and our team is available to assist you if trouble arises.

We will be attending both the upcoming Mine Expo at the Elko Convention Center on June 9 and 10, as well as the Eureka Gold Rush Games at the fairgrounds on June 25 and 26. Local 3 will have an equipment simulator at the Mine Expo and a booth at both events. Come out, visit with your union staff and membership and pick up some swag to take home.

#### Project will protect north San Jose from flooding

#### Report

In north San Jose, between Alviso Slough/Guadalupe River and Coyote Creek, our members with DeSilva Gates and Blue Iron are working on the first phase of the South San Francisco Bay Shoreline Project. This project will bring four miles of new levees to Santa Clara County, thanks to funding from Measure S, which our Voice of the Engineer (VOTE) volunteers helped pass in 2020. The \$518 million project, which is the result of a partnership between the U.S. Army Corps of Engineers (USACE), the U.S. Fish and Wildlife Service, the State Coastal Conservancy (SCC) and the Santa Clara Valley Water District, began last summer and will provide good work hours for Operating Engineers through 2036. DeSilva Gates is performing the earthwork for the new

levees, while Blue Iron has Foreman Wes Smith, Crane Operator Tylor Krammer, Oiler Steve Edward, Excavator Hydro Pile Rig Operator Marcilal Fernandez and Forklift and Skidesteer Operator **Daniel J. "DJ" Ogden** installing a coffer dam to hold back the Bay waters. These crews will restore and enhance 2,900 acres of tidal marsh and related habitat, which was lost due to salt production activities, and will provide public access and improve recreational opportunities along the shoreline. They will also reduce the risk of tidal flooding in this region, which is home to 2,500 residents, as well as businesses, schools and important infrastructure. This is just one of many large projects underway in our district and OE3 is proud to be a part of it!





#### Members maintain horse track

At Golden Gate Fields, operators **Rafael Meza**, **Victor Ordonez**, **Tomas Gomez**, **Steven Treasure**, **Tomas Gonzalez**, Shop Steward **Ryan Morris**, Superintendent **Juan Meza**, and Shop Mechanic **Salvado Castellanos** maintain and groom the track before every race and move the starting gate around the track, as needed. When they are not tending to the speedway, these members maintain a barn area that stables anywhere between 1,200-1,400 horses.

When asked what they liked best about working as Local 3 members at Golden Gate Fields, Steward **Ryan Morris** and Superintendent **Juan Meza** said they enjoy the benefits, the promise of a stable retirement and the good working conditions at the 81-year-old track.







No Member shall be eligible for election, be elected, or hold the position of PAC Member:

- 1. Unless he or she is a continuous member in the parent local union for one (1) year preceding nomination, not suspended for nonpayment of dues during that one year and a registered voter (with proof of current voter registration) in the district where he or she is seeking nomination;
- 2. If he or she is retired, is an officer of, or is on the payroll of the local union or a related entity;
- 3. If he or she is an owner-operator or a contractor;
- 4. No member shall be nominated unless he or she is present at the meeting, or unless he or she has filed, prior to the meeting with the Recording-Corresponding Secretary or to the District Meeting secretary on the day of the meeting before the meeting commences, a statement in writing, signed by him or her, to the effect that he or she is eligible to be a PAC member and will accept the nomination if nominated.

#### **PROOF OF VOTER REGISTRATION FOR PAC NOMINEES**

To be eligible to hold office, all PAC nominees must bring a copy of voter registration proof to the district meeting at which nominations take place. If you are unable to bring it to the district meeting, you may fill out a voter registration card at the meeting, before it begins. You may also fill one out online and print a copy of it prior to the meeting by finding your state's voter-registration link on our website at www.oe3.org.
