State of the Union/Semi-Annual Re-Cap

I think we can all agree that the March Semi-Annual Event was a success. We enjoyed a great turnout, met with great members, enjoyed some great information and then had some great food. Thanks to all who came out, even with the weather. If you weren't able to make it, some of the main takeaways from the meeting are below:

- * Despite fears of a recession, Local 3's concerns involve finding enough people to fill the seats of the many jobs we have now and coming soon!
- * Be sure to get your HAZMAT/HAZWOPER certifications (or renew the ones you have), so you can be ready to work on storm cleanup/repair work this year and beyond.
- * While many of our candidates and measures fared well during the last election cycle, politics never really sleeps. In fact, the Primary Election is happening next March, so please help out your districts, when the call comes to volunteer with the Voice of the Engineer (VOTE) program.
- * Politics can be divisive, but not when we unite around Local 3's core values, which are things we can all agree on: Jobs, training for those jobs, wages we can afford to live on, the ability to collectively bargain our agreements, and retirement and healthcare that keep us healthy, while we work, and happy when we retire.
- * Our membership numbers (including applicants) are continuing to grow – a direct result of our Organizing Department and the work you do in the field, by letting us know what you see and talking to non-union workers about what UNION means.
- * In 2022, we paid more than \$405 million in Pension checks to our Retirees, and we are proud of our ability to take care of our own in their Golden Years. Through Dec. 31, 2022, our Pension Fund return (investments) is sitting at around \$4.9 billion, unaudited and preliminary. We enjoyed 36.3 million work hours last year and predict that number is going to increase. We are moving in the right direction with our Pension and plan to certify in the Green Zone this year, as has been previously reported.
- * Our Health and Welfare Funds continue to remain strong, with our Active Health and Welfare Fund balance at \$655.5 million (through Dec. 21, 2022) and our Retiree Health and Welfare Fund at \$210.3 million.
- * We have negotiated several great agreements last year and this year, including a \$13 increase over the next three years for the California Master Agreement.
- * The new compliance entities we've partnered with in California and Nevada have done an incredible job at holding non-compliant contractors accountable, which has led to bids being awarded to our union signatories. For any questions you might have regarding compliance, please contact the NorCal Construction Industry Compliance (NCIC) for Northern California at (916) 993-2025, or the Northern Nevada Operating Engineers Contract Compliance (NNOECC) at (775) 857-4440.
- * The Local 3 Headquarters and District 20 offices have moved to 3000 Clayton Road, Concord, Calif. The phone numbers all remain the same.
- * Please make every effort to get out to your district's picnic this spring/summer, as we are so glad to be having them again!
- * Check out Local 3's updated website (oe3.org) and social media platforms, such as Facebook (facebook.com/groups/oe3members), YouTube (youtube.com/@OperatingEngineersLocal3) and Instagram (@engineersnews).
- * Local 3 continues to secure our work on renewable energy projects, such as solar farms, wind farms and offshore wind. Some of that work includes getting those projects funded.
- * Get involved this year in your union, as you are only benefiting yourselves, your co-workers and your family by getting informed and engaged in what is happening in your union!

Let's work together to make the rest of this year a great one. Please be careful as you drive on our freeways, and look out for roadside crews. Slow down just a bit more and take a little extra time. I hope to see you at a picnic this summer!

Apprentices are our future

These days, it's rare for me to attend a district meeting without swearing new members into the union. I'm always happy to do it, as it shows just how hard our Organizing Department and our Apprenticeship Programs have been working to grow this union.

A lot of people know that our Organizing Department is focused on growing our membership, signing new employers to our agreements and increasing our market share, but they may not realize how big a role our Apprenticeship Program plays in doing the same thing. Of course, they are aware that recruiting new apprentices is vital to our growth and our ability to meet the demand for Skilled and Trained Operating Engineers, but our Apprenticeship Program does much more than that. It also helps bring in new employers, as they come to realize the connection between the success of their business and having access to workers who go through rigorous training to meet the latest safety requirements and the most up-to-date government and industry standards.

The benefits to our employers are clear, but the benefits to our union are impossible to fully measure. That's because the Apprenticeship Program isn't just about training workers to do their jobs well, it's also about teaching those workers about their workplace rights, their union and how to actively participate in it. I believe this is what truly makes our apprenticeship an invaluable resource to the union and its membership.

The most common misconceptions about our union come from people who are simply not familiar with what it does, how it does it and why. It's hard to have those misconceptions if you have personal experience with the union and how it operates. Fortunately, our

apprentices learn about the union by developing that personal experience, as the program requires them to actively participate in union activities. In doing so, they are much less likely to be persuaded by falsehoods that harm our union or undermine our shared goals of securing better wages, stronger benefits and safer workplace conditions. For example, anti-union talking points often portray union activities as being held behind closed doors, where "union bosses" conspire to engage in shady activities. However, anyone who's actually participated in union activities knows that it's a lot more boring than that. The union actually accomplishes its goals and purposes through the help of active members who attend union meetings, show up to speak in city council meetings, write letters to elected officials, patiently share their knowledge and skills with younger members on the jobsite, or help coworkers file grievances or return bargaining surveys.

The truth is that our apprentices learn how to be good union members, and as I like to remind our apprentices, those who keep it up after they've journeyed out of the program are the ones who will someday lead this union. At some

point, they will serve the membership as business agents, district reps and officers themselves. Apprentices truly are the future of our union, a fact I am keenly aware of, as a member of the Nevada State Apprenticeship Council (NSAC), where I work with others to ensure apprenticeship programs in my home state meet the standards our employers, industry and economy require. We should all take pride in our Apprenticeship Program for training our workforce, while instilling union values into the next generation, so that they can someday carry us through whatever challenges come our way.

Apprenticeship and pre-apprenticeship programs get a funding boost

Last month, during an event hosted by North America's Building Trades Unions (NABTU) and the National Urban League, U.S. Secretary of Labor Marty Walsh announced a \$20 million cooperative agreement between the Department of Labor and the TradesFutures non-profit to promote construction apprenticeship opportunities through the "Sealing Apprenticeship Readiness Across the Building Trades"

initiative. Thanks to this funding, the department will work with a coalition that includes NABTU, the National Urban League and TradesFutures to ensure veterans, women and minorities are prepared for, and have equal access to, construction apprenticeship programs, as well as the tools to succeed once accepted into them.

"This cooperative agreement with the Department of Labor and the National Urban League will uplift people by recruiting and expanding building trades' workforce development

pipelines in communities that have been historically underrepresented in the trades while simultaneously meeting demand for unprecedented federal infrastructure investments," said TradesFutures Executive Director Nicole Schwartz. "We welcome this

opportunity to help recruit the next infrastructure generation and look forward to maximizing these investments to the greatest extent possible by empowering communities with a stronger, more diverse and skilled local workforce."

The work we do today keeps members working tomorrow

At the last round of District and Retiree Meetings, I heard reports of good politics and the jobs created from those same politics. It's a known fact that every single job an Operating Engineer does has political ties to it somehow. Those ties include things like storm water plan permits, the change of zoning from commercial to residential or vice-versa, mitigation approval for endangered species (animals and plants), air quality permits, Project Labor Agreement (PLA) approvals and most importantly, funding. On public works projects, like roads, bridges, rail and dams, funding is most often the toughest political battle. Then when we get a PLA approved, the entire project is guaranteed to be built with 100 percent union labor. Local 3 is known as a political powerhouse in our State Capitols, as well as Washington, D.C., and these kinds of battles are around every corner. The officers and staff of Local 3 embrace these challenges, because we know that when we fight, we win.

Some of the projects we heard about at this last round of meetings included High Speed Rail (HSR), which is currently keeping about 400 Operating Engineers working and will continue to do so for decades. We also heard about PG&E's plan to underground 10,000 miles of high voltage power lines. (This could create about \$15 to \$20 billion worth of work). Then there's the rail project in Utah that was said to need around 1,000 operators at its peak. We heard about the push for Off-Shore Wind development in Humboldt County and the thousands of jobs that it will create over the next 25 to 30 years. Finally, we heard about the multi-billion-dollar drydock project in Hawaii and the Lithium mines in Nevada.

These mega projects are just some of the highlights of these meetings. It seems every district had record work projections for the foreseeable future. None of these projects could have been possible if it weren't for political successes at every level. This is not something one person or one department can do. It takes every single one of us to be this effective. Your officers, district staff, Political and Public Relations departments and all of our headquarters staff isn't even enough. We need every member of Local 3 to engage. The bare minimum you can do is vote, but you can do more. We have the robust, member-based Voice of the Engineer (VOTE) volunteer program. Last year, we turned out almost 700 individual volunteers and had huge wins across our four-state jurisdiction, thanks to our VOTE volunteer efforts. This year and beyond will have plenty of opportunities for you to be a part of that success. Bridge operator makes river crossing possible

Our Unit 12 members operate 14 draw bridges along the Sacramento-San Joaquin River Delta. One of those members is Phil Pezzaglia. Phil operates the Helen Madere Memorial Bridge, commonly referred to as the Rio Vista Bridge, which is a continuous truss bridge with a vertical lift of 135 feet from the water line. Located on Hwy. 12, the bridge accommodates around 25,000 vehicles per day on Hwy. 12, and Phil is responsible for communicating with the

many heavy ships and pleasure crafts traveling up and down river, in order to plan for the opening of the bridge. He is also responsible for letting the traveling public know when it is safe to proceed across the bridge. The next time you use this crossing, whether on the road or on the water, remember that doing so is only possible because of the skills and knowledge of our Unit 12 brothers and sisters, like Phil.

Pile Drivers, Carpenters join OE3 apprentices for pile-driver training

For the first time ever, the Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC) partnered with the Pile Drivers and the Carpenters to create a week-long pile-driver training class. Here's what some of the apprentices had to say about the training, our Apprenticeship Program and the OE3 JATC:

Apprentice Matthew Miguel

"I've been in the Apprenticeship Program for three years. I still have to get some hours, so I will probably journey out of the program in another year, year-and-a-half or two years. I'm working for Condon-Johnson, which is a drilling company that does a lot of foundation work in the Bay Area, but we've been getting more and more pile-driving jobs.

"I came in as an oiler on a pile-driving rig, so I've been around pile-driving for years, but it's good to be here and be getting some seat time. Things are always moving on the jobsite and there's not a lot of time to put apprentices in the seat, plus it can get a little dangerous, so this is really nice for me to get to work with this equipment and get some hands-on experience.

"Whenever I come back up here, they ask me what I've been doing. They knew I was working around pile driving and doing foundation work, so they lined me up with this part of the training program. It's been great!"

Apprentice Summer Tex

"I've been in the Apprenticeship Program for less than a year, but I'm already a third-step apprentice. I came in with my certs, because I had been working non-union, but as soon as I got the opportunity, I applied for the union's Apprenticeship Program.

"I've been getting a lot of my hours working for Michels Tunneling, but all my crane experience was from doing bridgework for Security Paving. I got that experience running friction rigs, driving pile and running the vibratory hammer on a job where we were building a bridge over the San Joaquin River. We had some really good pile-driving foremen out there, and they gave me the opportunity to do it.

"My coordinator is always wanting to make sure I'm getting the experience I need, and there wasn't even a crane on my last jobsite, so he asked, 'Do you feel like you're going to be able to get your crane experience doing this?' and I told him 'No.' The first thing he says is, 'Well, we'll put you somewhere you're going to get it,' and here I am. Like I said, I already had my certs, but if I didn't come out here for this training, then I wouldn't get to know how to do it the right way and be as safe as possible. This is the first time they've ever done the pile-driver training with Pile Drivers Local 34, and what they're trying to do is make sure that we know exactly what we're doing.

"There's two different types of pile drivers we're learning on. One is a swing lead and the other is a fixed lead. There's also a vibratory power pack over there, which we haven't gotten into yet, but we will. We'll be out here for a full week, learning all of this with some great Pile Drivers from Pile Drivers Local 34. It's great, because if you don't have good Pile Drivers around, you'd never know what to do and wouldn't be able to get the job done right.

"The people from the training center, like our coordinators, and the union are always concerned about what's best for you. If you need them, they are there for you, and that's not just for the standout people. They know everybody, and they just want everyone to do good, make a good living and get the training they need. They'll give you their phone number. They'll give you their email. And if you can't do any of that, but you can get up to the training center, you can always find them here and willing to help. I've even come out on Fridays to get some seat time on the lattice boom, in order to get my certs, and they'll stop what they're doing, come out and fill in so that I can do what I need to. If you use them, they are always there for you."

UPGRADES IN THE MARSHLANDS

After more than a decade of planning, Local 3 members have started work on the first phase of the Arcata Wastewater Treatment Facility improvements project in Arcata, Calif. Much of the facility has been kept in operation since the 1980s through ongoing maintenance, but updates to the aging infrastructure were needed to improve water quality, meet modern standards and comply with new regulatory requirements from the North Coast Regional Water Quality Control Board (RWQCB). Those regulations are intended to prevent certain man-made chemicals found in industrial and household products from entering the water supply. Violations of the new requirements are not only hazardous, but can result in hefty fines for the City, so preventative maintenance on outdated equipment and facilities was not going to cut it anymore. A major upgrade to the facility was needed.

That's where Local 3 members came in, as their skills and knowledge were needed to perform a variety of tasks, from demolition to utility work, as well as the construction of new buildings and structures, improvements to roads and levees and the installation of new equipment. When Engineers News visited the jobsite, Operating Engineers with Wahlund Construction, which

is the general contractor on the project, were potholing for utilities. Since the facility is located in the wetlands of the Arcata Marsh, the construction of a planned electrical building requires a deep foundation system, so members with Hillside Drilling were also onsite, drilling 72-foot deep for the installation of new foundation piers.

The current phase of this project will continue with excavation and contouring, the installation of a new discharge pipe and an ultraviolet (UV) disinfection system, construction of the new electrical building, placement of structural fill to elevate an existing roadway, rehabilitation of an existing footbridge, the addition of rooftop photovoltaic panels and the raising of levees to meet municipal and federal emergency preparedness requirements. Design of the second phase is on hold until a feasibility study is completed, but is expected to include the construction of a new oxidation ditch and two new secondary clarifiers, as well as a new alkalinity feed system. Depending on the final scope of Phase 2, the project is expected to provide Operating Engineers with ongoing work over the next two to three years.

FULL SOLAR FORCE

OE3'S NEW SIGNATORY
HITS IT BIG WITH SOLAR

Centerline Drilling, a general contractor based out of Oregon, saw an opportunity to get into solar in California with a big project near Patterson, (Stanislaus County). The giant solar project called for the clearing and grading of many acres for solar arrays capable of generating renewable energy for local homes.

Centerline Drilling is known for being a specialist in, well, drilling, specifically for the power line industry, but could the company find the manpower for a job in California, requiring scrapers, dozers and excavators? Enter Operating Engineers. In true organizing form, Stockton Organizer Brent Hewitt went to work explaining that not only could Operating Engineers provide Centerline (and its sister machine plow company, R-2 Contractors) with a local Skilled and Trained Workforce – if Centerline and R-2 became signatory to Local 3 – they could also access a whole pool of job opportunities in the Golden State.

Centerline jumped at the opportunity, and Local 3 went to work filling dispatches for the project, which currently employs about 40 Operating Engineers between the two companies. The general foreman tasked with keeping everything in line, Jose Vargas, has been an Operating Engineer since 1999 and attested to the power of the union workforce that came in force to fill the seats. The Stockton

District Office, including Business Agent Juan Orozco, and OE3 organizers, also began sourcing non-union workers, many of whom signed up with the union right away to work locally.

One of these included Centerline Grading Foreman Andrew Alejo, who had worked non-union for close to 20 years, prior to signing with Local 3 about eight months ago. The Fresno resident is happy to be working so close to home and decided to sign-up with the union because of the possibilities of this new industry.

“It was the right thing to do at this time,” he said. “There’s an opportunity here with solar.”

Centerline Blade Operator Mike Colston (from Half Moon Bay), has been an OE3 member for more than two years, and because of this job, he was able to buy a home in Newman, Calif.

Because of the relatively new nature of this industry, most operators will fully admit they aren’t experts in solar, but they have been happy to learn, particularly about the kind of work R-2 Construction, which is providing the plow rig, is doing. The company lays the Medium Voltage (MV) cable underground with conduit for fiber optics.

“We pull the plow rig itself with a 1050K dozer with a D9 dozer and then we come back with a blade, we back-fill the plow, we whack it, and that’s pretty much the process,” said R-2 Contractors Foreman

Dylan Smith. “It’s basically getting the cable underground without having to trench it. Once we get the cable underground, we’re plowing the cable ... The plow also puts our dig tape in the ground on top of that. It’s a start-and-go kind of thing.

Eight-year member/R-2 Foreman Rob Eason explained that he has never done cable-plowing before this job, so, “It’s pretty exciting for all of us,” he said. “We’re moving forward. This is a very efficient way to do it.”

Vargas helped solidify the entire flow of the work from the start and will see it to completion.

“We’re very grateful with Local 3 because they have provided amazing people, amazing workers that are so excited about this new project,” he said. “We have nothing but young people working and all of them are really pushing forward. They really want this thing to explode.”

“Centerline is just excited about working with Local 3,” Vargas said. “They are impressed by how the union has been able to help in

all these areas. R-2 also likes this culture of training the generation of new people to work in this area and having the training that we have with Local 3 ... especially knowing they went through the Apprenticeship Program is a great deal. I can never emphasize that enough.”

This idea of training the next generation and holding everyone accountable is a philosophy Vargas has used to make this project so successful. It helps that he not only views his crews like family, but that some of them actually are. Site Superintendent Gustavo Vargas and Operator Abraham Vargas are his brothers, and Christopher Vargas is his son.

The opportunities are boundless for this line of work, both for all Operating Engineers, and particularly Centerline and R-2, which are reaping the benefits of being Local 3 signatories every day.

The project is expected to continue for more than two years on this portion. And yes, this is just the beginning! *Look for more on this project and find videos of the work at Local 3’s official YouTube page.* ✨

Members work on new school in Mission Bay neighborhood

Report

Construction is booming in San Francisco's Mission Bay neighborhood. Just south of Oracle Park, at Parcel 14, a new school, which has been in the making for over 25 years, is finally going up and should be completed by August 2025. The school will serve residents from the new housing nearby, educating 550 students from pre-kindergarten to fifth grade. Our members with **Goodfellows Bros.** are performing the demolition and underground work. So far, they've off-loaded about 150 loads of asphalt and removed underground utilities. Foreman **Hugo Bucio** is on the job with Gradesetter **Adam Snow**, excavator operators **David Horton** and **Simon Ponce Nieves** and apprentices **Phillip Stewart** and **Charles Michael**.

At San Francisco City College, our members with **Rudolph and Sletten** are putting up a new Science Technology Engineering Art and Math (STEAM) building. The work is being done under a strict Project Labor Agreement (PLA), which guarantees the use of an all-union workforce. **Drill Tech** worked on the tie-down anchor piles for the building pad. **McGuire and Hester** did the cut and cap on the existing utilities. **Jos. J. Albanese** has excavator operators **Jose Dominguez** and **Francisco Sanchez** digging for footings and elevator pits.

At Golden Gate Avenue and Laguna Street in the Fillmore District, **Michael O'Shaughnessy Construction** is replacing sewer mains. Excavator Operator **Robert Ortiz** is onsite to place

and pull shoring walls with a 314E CAT on wheels with a shaker attachment. Excavator operators **Julio Alfaro** and **Alec Morgan** are also onsite.

In the Mission District, **J. Flores Construction** is doing sewer laterals with Excavator Operator **Jorge Campos**. On 16th Street and Guerrero Street, **JMB Construction** has Excavator Operator **Ignacio Ochoa** and Skid Steer Operator **Arturo Valdovinos** making street improvements that include new concrete and ADA-approved handicap ramp returns.

Projects resume, after being stalled by winter weather

Report

On Hwy. 20 near Ukiah, our members with **Myers and Sons** have resumed work on a more than \$50 million bridge replacement project. Recent storms caused the creek to rise, temporarily shutting down the jobsite. Subcontractors, like **Ghilotti Bros., Mike Brown Electric, Highway Specialty and Jarrett Foundation**, have also been putting our members to work on this project, and that's just to name a few. In Cloverdale, **Rege Construction** is renovating a playground and a parking lot at Cloverdale City Park. The company will also be keeping our members busy on a private, tribal housing project at the south end of town over the next few months. Caltrans has been awarding emergency work in Sonoma and Mendocino Counties, mostly along Hwy. 1. **Granite Construction and Argonaut Constructors** were awarded some of these emergency projects just north of Jenner, with a couple more near Fort Bragg.

As for future projects that will employ our members, **J. F. Shea Construction** was recently awarded a \$4.9 million bridge project just south of Cooks Valley at the Humboldt/Mendocino County line. The work, which was originally scheduled to start last December but was pushed back due to severe weather, includes

construction of concrete barriers, polyester concrete overlay and some asphalt work. **MCM Construction** has been awarded an \$8.5 million bridge widening project on Hwy. 162 near Covelo, which will include upgrades to the bridge rail.

At the Sonoma County Airport in Santa Rosa, our members with **Q&D Construction** are on the tail-end of a \$40 million terminal expansion project. The ground work was done by our members with **Ghilotti Bros.**, and most of the subcontracted work went to signatory contractors. The terminal is now in use, but there are a few punch-list items left to complete. With more improvement and expansion projects planned for the airport, we are happy to report that the airport's management team has been very impressed with the work performed by Operating Engineers and other union workers.

Member's misclassification results in major payout in back wages

Report

From Reno

Sierra Nevada Construction (SNC) is putting our members to work on several new projects in the area, including the \$1.8 million City of Reno Patch Program, a \$1.4 million City of Sparks street rehabilitation project, a \$2.3 million Regional Transportation Commission street rehabilitation project, a \$5 million City of Fernley street reconstruction project and numerous warehouse projects. **Q&D Construction** is working on several new projects, including \$16.5 million of seismic retrofit work on several bridges along I-80 near Fernley for the Nevada Department of Transportation (NDOT), a \$7.5 million bridge replacement project in Pershing County, a \$1.4 million street rehabilitation project for the City of Sparks and a \$2.3 million street rehabilitation project in Reno for the Regional Transportation Commission (RTC). The company is also working on several subdivisions and warehouse projects. **Granite Construction** has been awarded the \$58.3 million Hwy. 445 project for NDOT in Sparks and continues to work on the RTC's \$44.1 million Oddie Boulevard project.

From Elko

Acha Construction is keeping members busy on the Church of Jesus Christ of Latter-day Saints' temple project and continues to work on the new Love's Travel Center project in Jackpot. **Ames Construction** is working on the Meickle Mine crusher

site in Carlin. **Granite Construction** has been awarded a solar project at the T. S. Power Plant in Argenta for Nevada Gold Mines (NGM), which will keep our members busy through summer. **N. A. Degerstrom** is working on the Gold Bar Mine project in Eureka and the Cortez Mine and is bidding on new projects in the area. **Q&D Construction** has been working on I-80 in Battle Mountain and keeping crews busy at the Hunter aggregate facility in Elko. **Road & Highway Builders** continues to work on a couple of box culvert replacement projects and has been awarded other jobs in the Elko area. The company was also awarded a new project on I-80 in Battle Mountain, as well as a new on-ramp/climbing lane on I-80 East at the Beowawe exit.

While preparing for contract negotiations with NGM, Local 3 discovered that a member should have been upgraded to the next Tech Level more than two years ago. After contacting the member and confirming her Tech Level, a grievance was filed on her behalf. Staff met with NGM representatives and were able to get her promoted to the proper Tech Level and secured an additional \$12,767.17 for her in back wages.

At the time of this writing, gold is at \$1,836.89. Our local business agents have been visiting members at NGM parking lots and are looking forward to talking with our members while visiting underground line outs this month.

Members meet high demand for Caterpillar engines and rebuilds

Report

Wheeler Machinery started as a Caterpillar dealer in Utah in 1951 and signed with OE3 in 1963. Today, the company has 11 different locations across Utah, and OE3 represents 600 employees. The northernmost location is in Logan, just 20 miles from the Idaho border, the southernmost location is in Hurricane, just 20 miles from the Arizona-Nevada border and the easternmost location is in Vernal, just 30 miles from the Colorado border. The location in Ely, Nev., services the westernmost part of Utah. Other branches are located in Ogden, Lindon, Cedar City, Moab, Salina and Huntington, and each one focuses on a specific part of **Wheeler Machinery's** business.

These days, **Wheeler Machinery's** Power System Division (PSD), which covers any and every industrial product with a Caterpillar engine, has an unprecedented amount of work, thanks to an oil and gas boom that put Caterpillar engines and engine rebuilds in high demand. Customers need as many engines as Wheeler can supply, from 3512s and 3516s all the way up to Caterpillar's largest engine series, the 3600, which is 60 times larger than the engine in a Ford Mustang and has a footprint the size of a tiny house. These engines also vary in type of combustion, from diesel and natural gas to Dynamic Gas Blending (DGB), and require a substantial amount of work hours to repair and rebuild. For example, the 3512 takes 375 hours to rebuild, while a 3616 takes 800 hours to rebuild. **Wheeler Machinery's** SPEC shop and Power Systems shops are both in Salt Lake City, and our members there also work on these engines, as do our members at the Vernal and Hurricane branches, before returning them to the Salt Lake City headquarters for a Dyno run.

Our members with **Gordon N. Ball, Inc.** are currently repairing washed-out roads along Pleasant Valley Road, including Mix Canyon Road and Brazelton Ranch Road.

With support from OE3 and the efforts of our local Voice of the Engineer (VOTE) volunteers, voters approved Measure P in Vallejo last November. The measure is expected to bring in \$18 million a year for addressing community priorities, like maintaining critical city services and infrastructure. As a result of this funding, our members will start seeing an increase in work on city projects, including road repair and pipe replacement jobs. Passing Measure P was a priority for OE3, as it ensures local work for Operating Engineers. However, those efforts also helped open

the door to negotiations for a city-wide Project Labor Agreement (PLA) between the City of Vallejo and the Napa-Solano Building and Construction Trades Council. The City recently offered a PLA workshop to highlight the agreement and get suggestions for the negotiations. This is great news, as Vallejo has some of the worst roads in the Bay Area. Over 400 lane-miles of local roads, which is more than half of Vallejo's streets, have an official rating of "poor" or "very poor." These ratings are determined by independent experts using the U. S. Army Corps of Engineers' pavement standards. Fortunately, Resolution 22-133 of the City Council approves the use of funds generated by Measure P for priorities, like pothole repairs, pavement maintenance and more, which residents have identified as a priority for such spending. This means more projects for our signatory employers, good work hours for Local 3 members and increased contributions to our members' Pension and Health and Welfare Funds.





Big projects move ahead, thanks to infrastructure funding

Report

Our signatory employers continue to be awarded new projects, as we enter the beginning of another work season, and projects held up by permitting issues at the beginning of the year are now being released. The development of subdivisions in Lincoln, Folsom, Natomas, Woodland and surrounding areas is keeping many of our members with **Goodfellow Bros.**, **DeSilva Gates**, **Teichert**, **Independent**, **D. W. Young Construction**, **Mozingo** and **Marques Pipeline** busy. As the housing market remains strong and several public works projects get ready to begin, our work picture looks great.

Work around the Sacramento International Airport is still booming, with massive tilt-up warehouses going up for several different companies. The airport itself continues to expand, providing work for our members on the new projects. It was recently announced that there will be \$1.3 billion of work at the airport, which will keep our members busy over the next 10 years. This work includes a new, expanded rental car area, ground transportation infrastructure, an exit road for Terminal A and a 5,000 space parking structure for Terminal B. Expect more projects to be announced in the future.

Work along the Delta has been steady. Along the Hwy. 160

corridor, **Foundation** is working with **Asta Construction** on new towers for Pacific Gas and Electric (PG&E). **Dutra** is performing levee repairs and shoulder work. **Goodfellow Bros.** was awarded the \$32 million Fremont Weir and salmon habitat project, which is keeping around 15 operators and apprentices busy. **Weber General Engineering** continues to land several tilt-up projects in West Sacramento. The latest is a \$3.9 million project, which includes grading and paving.

This year's work picture continues to improve, as infrastructure money is released into the Bridge and Highway Fund. Over \$200 million has been released this year to fund work on I-80 and Hwy. 50 in the West Sacramento area, creating many jobs for our members. We are watching these projects, as they come out to bid, and are prepared to dispatch our current members, while our Organizing Department is doing an incredible job of recruiting new members and signing new employers to our agreements.

If you are not currently working, remember to keep your registration up-to-date on the Out-of-Work List. That means renewing your registration every 84 days, if you are an existing member, and every month, if you are a new applicant. Have a great season and be safe.



Unit 12 members clear roadways following severe weather

Report

Over the past several months, much of our state was hammered by severe weather, resulting in rock slides, flooded roads, fallen trees and downed power lines. The damage from these storms made it impossible for many to travel to and from work, or for emergency vehicles to reach their destinations, so our Caltrans members were called upon to clear the roadways and perform some emergency work. These members worked around the clock, often near traffic and in wet conditions, putting their own safety at risk to remove fallen trees, clear flooded storm drains and remove debris from mudslides, so the public could travel safely.

These members are part of bargaining Unit 12, which entered negotiations with the state in February. They are hoping to get a successor agreement in place before their current Memorandum of Understanding (MOU) comes to an end. Economic factors will be their main focus, based on the results of member surveys returned by Unit 12 members, which helped the bargaining team identify their shared priorities. Other concerns, such as workplace safety, will also be addressed by the bargaining team during these negotiations.

Meet new Director of Safety and Training

New Local 3 Director of Safety and Training J. D. Friend is no stranger to Operating Engineers ... or training them! He joined Local 3 in January of 2000 as a mechanic for Holt of California and became involved in the union, after becoming the Job Steward for the shop. As a Job Steward (a position he held for nine years), he helped negotiate contracts and helped his co-workers with grievances and any safety concerns they had; he also enjoyed being mentored and then mentoring other mechanics through Holt's ThinkBIG training program. So, when the Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC) needed a mechanic instructor in 2014, he knew he would be a good fit.

"I had had many good instructors ... mentors, so I wanted to give back," he said.

While at the OE3 JATC, Friend taught the mechanic apprentices, and then in 2017, he became the training center's safety director and curriculum coordinator. He also taught hundreds of classes (OSHA 10 and 30 and Hazmat Refreshers).

Chances are, if you've taken a Hazmat Class or a Hazmat/Hazwoper Refresher Class, it was taught by Friend, who quickly became known as an instructor who could turn boring subject matter into something more interesting and engaging. He was also single-handedly responsible for getting hundreds of operators certified to work on the slew of fire cleanup work throughout Northern California in 2016 and 2017.

In his new role, Friend will continue teaching Refresher courses and assisting the training centers with safety classes, but he will be involved more with Local 3's employees and members on the jobsite, something he said was one of the reasons he took the job.

"I am excited about working with OE3 itself and helping our local thrive," he said. "There's a lot of good things going on here, and I am happy to be a part of it."

Friend will now provide accident investigations for the union, and if a member has any safety concerns, Friend is the one to contact. He will also be dealing with the safety aspects of the union's facilities and employee injuries.

Friend will also be assisting the union's Human Resources Department with onboarding new employees, updating policies, providing employee compliance trainings and hopefully adding his flare to some of these classes!

When asked about his current safety concerns for all Local 3 members and staff, he mentioned the severe weather we've been having.

"Right now, everything points to driving," he said. "We've had some really nasty weather and people are getting more impatient on the roads. I just lost a good friend in a driving accident, so I just want people to take their time and be aware while they are on the roads."


