



## Final quarter meetings update: This Union is YOU

We have just finished the union's final quarter of District/Retiree Meetings, and I want to summarize a few key points from these meetings, in case any of you couldn't attend. For those of you who did attend, I thank you. We had scores of new members sworn-in at every district. To these new members, you will often hear from those who are at the end of their careers, this phrase: "The day I got into Local 3 was one of the best days of my life. I didn't know it at the time, but now, when I look back, I realize how fortunate I was to be a part of this great organization." Congratulations, welcome aboard, and I hope you have a great and prosperous career!

Our members voted and passed the Bylaws Resolution at this round of meetings, and this is the way it should be. Members participate in all of the important decisions and processes of this union. This is a right and a privilege that not every local offers its membership. Some have district councils that vote on their contracts or their bylaws. However, in Local 3, you have a voice in everything we do. You vote on your Bylaws. You vote on your contracts, whenever they come up. You vote every three years, if there's an election for the officers who will run this great Local. That's the ability you have by being a part of this great organization. This union is you. I want to thank you and I want you to remember, always come out to these meetings to vote. An hour-and-a-half meeting once a quarter is not that much time to devote to getting the information you need to be an informed and active member of your union!

Another important element from these meetings was that in Hawaii District 17's Maui Town Hall Meeting, we were able to handdeliver checks from Local 3 and the International Union of Operating Engineers (IUOE) to members who had suffered losses from the Lahaina Fires there. These are donations that our membership gave to help, and the members who received them were so appreciative. This was a really special meeting for all.

No matter which district or state you are located in right now, every report is about how much work is going on and how much work is ahead. While the hours in California may be a bit lower than this time last year, that's only because of the late start due to weather. Hawaii has a \$3 billion project going on at Pearl Harbor right now with about 100 operators on that project alone, and Nevada has tons of highway work all across the state. Hours are way up in Utah, which says a lot about the kind of staff we have there, since Utah is a Rightto-Work (for less) state. Even with no prevailing wage laws in place, this district has 2,800 members, which is significant growth. The two biggest projects in Utah that will be breaking ground next year include a giant rail project and a transmission line that's going from Wyoming to Southern California, with three quarters of it going through Utah. We will need roughly 1,200 operators to fill the seats on these jobs! (If you are looking to move to Utah, there will be

A few other important updates from the round of meetings. We've been working through some of the issues some of you have had with Delta Dental, your dental-care provider. Our members in rural areas are having trouble finding dentists in the network. We have been meeting with Delta Dental regularly to determine where the dentists are located, so that we can get that information to you. We are also working on reducing your dental costs. By the time you receive this, your new coverage will go up \$1,000 for dental work (from \$2,500 to \$3,500 per year).

In other good news: For the last four years, we've been giving our Retirees a \$500 bonus right before Christmas, and I am pleased report that at the end of 2023, just before Christmas, we increased that amount to \$750. We hope to provide more relief to our Retirees at a later time, as we know inflation costs have been affecting them.

Regarding the Pension numbers discussed, the unaudited numbers through November 2023 are at about a 6.5 percent net return, and if the market continues to improve, as it has been doing, we hope that when we certify that number, it will be at the preferred 7.5 percent mark. We have about \$4.9 billion in the Pension Fund and are at around 82 percent funded. Everything is moving in the right direction.

For our active Health and Welfare Funds, we have just under \$500 million in that fund, with about 22 months of reserves. For our Retiree Health and Welfare Fund, we have about \$249 million and just over 20 months of reserves in that Fund. For those of us who have been around awhile, this is just great news. It used to be that every time we had an allocation, part of that allocation had to go to our Fringes to keep the funds solvent. Well, we have not allocated to healthcare in over four years. That's because of you, all that we've sacrificed to get to this point, and it's also because how we've managed those Funds successfully.

There's so much going on right now, that I don't have the space to devote to it all! President Steve Ingersoll will touch on our great membership numbers (reaching the 40,000 membership mark), and we have included in this edition a page dedicated to our Stockton Public Employees who went on strike right after Thanksgiving. Please read through this edition, attend your meetings and never hesitate to call a staff member if you have any questions. You are the UNION. We work for you, but we can't help you, if you don't reach out!



## A growing membership benefits all

For the first time in a long time, after tallying up new applicants and factoring in our existing membership, we've officially exceeded 40,000 members in Local 3! To give you an idea of how big of a deal that is, consider that the International Union of Operating Engineers (IUOE) represents a little more than 400,000 Operating Engineers in locals across the entire United States and Canada. That means Local 3 makes up about 10 percent of all Operating Engineers in both nations! I couldn't be prouder of our membership, our staff and this administration for all of the hard work we've put into growing our union and reaching this achievement.

By growing this membership, we are better able to fulfill Local 3's goal to "improve the economic conditions of its Members, all Employees and working men, women and minors by all lawful means and methods," as stated in Section 1 of our Bylaws. You might say to yourself, "Being part of a growing union is great, but how does that improve my economic conditions, or those of working people in my region, city or

neighborhood?" Let me explain: When we increase our membership, we secure a greater market share. This means a lot of work simply cannot be performed without employing members like you, as there just aren't enough non-union workers with the knowledge and skills needed to perform that work without doing so. As a result, you are able to enjoy a productive career in your chosen trade, and with the kind of financial security you and your family can build your lives

The benefits of growing our membership doesn't just impact our members, however. When non-union firms need to hire new (or keep existing) workers, and union membership is high, they must appeal to workers who have the option to work for employers that offer union wages, Fringe Benefits and better working conditions, all protected by a Collective Bargaining Agreement (CBA). Offering better wages,

> benefits and working conditions to these workers is often the only way non-union employers can hope to compete with signatory employers for the workforce they need... that is, unless they become signatory employers themselves! As our organizers can tell you, this happens often, but even when it doesn't, both union and non-union workers reap the benefits of greater union membership and the pressure it creates on employers to offer a better deal to working people.

Let's continue to grow this union! By doing so, we are not only helping ourselves and bettering the lives of other Operating Engineers, but we are setting better employment standards for our family members, friends and neighbors, whether they are union members or not.





A HIGHLIGHT OF RECENT NEWS ITEMS THAT ARE SPECIFIC TO LOCAL 3 AND THE BROADER LABOR

#### Study confirms: Unions benefit members and nonmembers alike

Another research study, this one published by WorkRise last November, confirmed what union workers (and previous studies) have been saying for decades; unions benefit all workers, including those who are non-union.

The study, "Unions and Nonunion Pay in the United States, 1977-2015," by Patrick Denice and Jake Rosenfeld, involved researching data from a nearly four-decade period of the Current Population Survey. Because union membership declined during that period (from one in five workers to one in 10), researchers are able to identify the impact this change had on all

workers. Furthermore, by controlling for the decline of manufacturing, the rise of automation, increased skill demands, differences in occupations and differences in regional labor markets, the researchers were able to isolate the effect of union strength on the wages of non-union workers. Here are some of the study's findings:

- · Higher union density raises the wages of nonunion workers.
- Wage standards are improved for women workers in occupations and regions where unions have a significant presence.
- Unions increase the pay the most for workers who did not obtain a college degree.

- · If unions had been able to maintain previous membership levels in the construction industry during the period studied, weekly wages for non-union construction workers would be as much as \$231 higher in 2023 dollars.
- · Union decline is the primary driver of wage stagnation and growing inequality.

"Policymakers, labor advocates, workforce developers, and anyone interested in improving wage stagnation and income inequality in the US labor market should promote policies that support workers' rights to collectively bargain," the study recommended in its

conclusion. "By upholding labor standards and worker rights at the local, state and federal level, policymakers can make it easier for workers to organize their workplaces and collectively bargain with their employers."



## Sharing debarment info protects taxpayers

As we approach the end of another legislative cycle and the beginning of a new calendar year, I am pleased to report on the passing of a new labor-compliance-related bill that will be a potential game-changer for construction industry compliance. Assembly Bill (AB) 1121, which passed the Legislature with unanimous, bi-partisan support, is designed to protect tens of billions of dollars in public construction

investments annually. This new law requires all state and local awarding agencies to upload lists of debarred contractors, including details of their violations, to the California Department of Industrial Relations' website every year. ## Without you, California would come to a halt each winter

## Look for important documents in the mail

Happy new year! Here's to good health and happiness for all! Your 2023 1099-R for Pension payments and lump-sum annuity payments, including the details of any federal or state income tax you may have authorized, will be mailed to you by Jan. 31. If you note any discrepancies with your personal records or do not receive your 1099-R, contact the Trust Funds Office at (800) 251-5014 or the Fringe Benefit Service Center at (800) 532-2105 for assistance.

## **Delayed retirement incentive (bonus Pension)**

To encourage participants to keep working and lower long-term costs to the Pension Fund, the Officers and Trustees of Local 3 provide the delayed retirement incentive for participants who are eligible for a service pension. The amount of the incentive, or bonus, the member receives, is based on how long the member delays retirement.

#### **EXAMPLE**

- ▶ 1 year: 10 percent
- ► 2 years: 25 percent
- 3 years: 50 percent
- 4 years: 75 percent
- 5 years: 100 percent
- Each additional year: +20 percent

You can do a rough calculation of your particular situation using this example and plugging in your numbers.

- Age 55 with 30 years of credit (Rule of 85)
- Monthly benefits at Service Pension Retirement Date (SPRD) = \$5,000 per month/\$60,000 per year
- ► Works two more years and retires at 57

(bonus percent) 25 percent X \$60,000 divided by 24 months = \$625 24 months X \$625 = \$15,000

Remember, you must work at least one calendar year past your SPRD and contribute at least 350 hours to qualify for the bonus. The payments will end pursuant to the example above, when you reach your unreduced Social Security retirement age or at death.

The delayed retirement incentive is a real "win-win." The employer gets to keep a top hand (you), the participant gets to not only build his or her Pension but also get a bonus, and the costs are lowered for the Fund!

## **New MOUs prove gratifying for Plumas County**

I would like to wish each of you a happy new year! I hope 2024 is a prosperous year for you.

Members in the Plumas County Public Works Unit and the Plumas County Public Works Mid-Management and Supervisors Unit recently ratified new Memorandums of Understanding (MOUs) that started Jan. 1, 2024. Members are receiving an immediate 10 percent base wage increase with an additional 2 percent beginning in July 2024.

The new MOU contains an increase in medical insurance, with an opt-out from the previous \$200 per month up to \$300 per month. There is also an increase in the safety clothing/boot allowance from \$450 per year up to \$600 per year. Two new longevity steps are being added at 24 and 27 years of service. (These steps are 5 percent increases each.)

This MOU contained zero takeaways by Plumas County and is an 18-month contract. Special thanks to negotiation team members Rob Thorman (Public Works Mid-Management and Supervisors Unit), Joe Buckley and Mark Crews (Public Works Unit) and OE3 Job Steward Jared Morris (Public Works Unit).



## Fresno Irrigation District receives decent four-year contract

After more than five months of negotiations for our members with the Fresno Irrigation District, both sides agreed that we were at impasse. Therefore, we asked for the State Federal Mediator's help. This proved worthwhile, as the mediator helped both sides agree to a very good contract. Below are the main details:

- New employees or employees with less than five year of employment, will receive an increase of \$5 or more an hour for 2024. (The District was having a hard time keeping new employees because of their previous low wage.)
- ► Some classifications received a \$7 an hour increase for the year 2024.
- ► Employees whose pay scale is within the median will receive a 7 percent increase for 2024.
- ► The four-year year term includes a 7 percent increase in 2024, 5 percent in 2025, 5 percent in 2026 and 4 percent in 2027.
- Health insurance increases now include 10 percent more paid by the employer for plus-one and family coverage, bringing the total to 60 percent. (Every OE3 employee already receives 100 percent coverage paid by the employer.)
- ► There will be 2 percent more added to the 401(k), which will now be at 8.5 percent, paid by the employer.
- ► More time has been added to Paid Time Off (PTO).
- ▶ Medical Opt-Out will go from \$250 a month to \$400 a month for employees who opt-out of medical insurance.

I would like to thank negotiation team members Robert Armas and Cody Garcia, along with the senior staff of the Fresno Irrigation District, for all of their hard work during these negotiations.

## Road rage can actually be life-threatening

We've all been frustrated at work, or while driving to and from work. Life seems full of constant annoyances, whether it's the slow driver texting in the fast lane, when we're late, the hotheaded apprentice who isn't teachable, the co-worker who has unnecessarily odd eating habits or even the spouse who nags. We've also heard about how "road rage" is bad for our health. We've probably reassessed our reaction to a situation and noted that we could have, perhaps, reacted differently.

New studies are now showing that one's emotional state is in direct correlation to accident rates on and off the job. (Meaning that the fight you had with your co-worker about how best to get the job done, could actually kill you. Seriously).

According to Virginia Tech Transportation Institute Researchers, a driver who's upset is 10 times more likely to be involved in a crash than a calm driver. The study followed 3,500 drivers as they traveled 3.5 million miles.

"Driving while emotional," the researchers said, "is more dangerous than driving while drowsy, fiddling with the radio or air conditioner, or chatting with passengers."

But this doesn't just happen on the road. Being upset on the job also increases your chance of being involved in a workplace accident.

What can be done? As over-used and cliché as it may sound (enter eye-roll), taking a second, or pausing, to check-in with your emotional state can actually save lives.

According to Richard Hawk, a contributor to *Health and Safety* magazine and a leader in helping the construction industry keep workers safe, there are a few simple things one can do to "get out" of an emotionally charged state:

#### Put things in perspective

Hawk relays a story about a mechanic he worked with who got angry over a bolt he couldn't loosen.

"He told me during the incident investigation that 'it got personal,' meaning he was in an emotional fight with the bolt," wrote Hawk.

"He ended up with stitches in his forehead after the tool he was using (a 'cheater bar') slammed into it."

It's easy to get angry over small things, especially when there are constant work and life pressures, most of us don't get enough sleep at night and everyone is spread thin. However, if we are able to think about how insignificant the frustrating event actually is, we may realize it's not worth the effort in getting upset about it. It's certainly not worth potentially getting into an accident over.

#### Take a break

We tell kids this all the time.

We tell them to walk away from a situation that is bothersome or frustrating, and usually when they return, the emotion has subsided. The same is true for adults. If you notice that your crew is getting overly emotional about a problem at work, or maybe you are the one becoming unhinged, it's best to take a minute and change the scenery. Use the restroom or take a water break. Removing yourself briefly from a trigger and then reassessing it with a co-worker, can often de-escalate a situation before it gets out of control.


#### Give yourself extra time

Again, this is often explained to new drivers, as unseen events can unfold on the highway at any given moment, and it is usually when we are in a rush that these nuisances can really create stress. To avoid flipping off a bad driver, tail-gating or driving in a heightened state of frustration, always give yourself more time to reach your destination than seems necessary. You'll arrive at your job calm and ready to embrace the day, rather than pissed off and overly annoyed. Again, this can be the difference between life or death.

# WHY STOCKTON M.U.D WORKERS WENT ON STRIKE

At the end of November, two bargaining units consisting of 180 OE3 members working for the City of Stockton's Municipal Utilities District (MUD) went out on strike over Unfair Labor Practices (ULPs) by the City. These members are with the Operations and Maintenance and the Trades and Maintenance units, which are responsible for providing the City of Stockton and its residents with water and wastewater services, infrastructure maintenance, vehicle repair and maintenance and flood prevention work, just to name a few. To get a better understanding of why these members voted to strike, Engineers News met up with them on the picket line at three locations; the Stockton City Hall building, the Corporation Yard on Lincoln Street and the Wastewater Treatment Plant on Navy Drive. Here's what they had to say:

"We're looking for improvements on economics, some language changes on pay and an increase for medical insurance contributions on the City's side. We're also seeking more in the Cost of Living Allowance, or COLA, and some increases in standby pay," said Business Agent Mike DeAnda. "Just to give a little bit of background, over 10 years ago the City filed bankruptcy and asked these two bargaining units, along with others in the city, to make reductions and take cuts to basically help finance out of bankruptcy... and the City has not moved anywhere close to restoring that. In the meantime they've become very solvent."

"I've been with the City for 13 years," said Strike Captain Nathan Castanon. "I love my job. I live in Stockton. My tax dollars go to Stockton and I'd like to remain with the City of Stockton, but if you


look at all the comparable cities, Lodi, Manteca,
Tracy, Lathrop, even the County of San
Joaquin, they have higher wages and the
same job titles that we have, and we just
want a part of that."

"We're out here because we deserve a fair contract and we've asked for a fair contract," said Strike Captain Mark Moreno. "We gave up a lot over the last 13 years of this bankruptcy. We went years without a COLA raise to help keep people at work. We're now the fifth or sixth most solvent city in the United States. They have money. They're not giving us a fair contract."

The strike has since ended, but the show of solidarity among the membership, as well as the support they received from within the community during the strike, has brought the City's negotiators back to the table to work out a better deal for these OE3 brothers and sisters.

Director of OE3's Public Employees Division Tim Neep has offered a special thank you to everyone who joined these members on the picket line, which included Business Manager Dan Reding and President Steve Ingersoll, as well as local business owners who provided coffee and donuts, local politicians and elected officials who provided lunch, individuals who provided live music to keep morale up and members Alfredo Medrano and Eric Parsons, who brought smiles to a lot of faces, as they took turns wearing a Grinch costume while on the picket line.

### SMITH CANAL PROJECT PROVIDES SOLUTIONS

At about this exact time last year, Northern California was reeling with record levels of rainfall and flooding. This caused delays in the 2023 work season, as many projects buttoned up until weather complied. Other work was created because of the flooding, such as slide repairs and pothole fixes. (Floods are on the list of disasters prevalent in California, along with fires and earthquakes.)

To combat flood concerns in the Stockton area, a unique project is wrapping up after four seasons of planning and effort, thanks to a small crew of Shimmick Construction operators and pile-drivers out at the Smith Canal. The first-of-its-kind project involved creating a floodwall along the San Joaquin River between Dad's Point and the east side of the Stockton Golf and Country Club. This floodwall also includes a miter gate, which will remain open during normal conditions, but can close during high water and tide events. Therefore, Smith Canal will be isolated from the San Joaquin River during flood events.

For the 8,000 or so properties protected by the Smith-Canal levees, this work acts as a type of flood insurance, all on its own, meaning these homeowners will not be required to purchase flood insurance for their properties any longer. (This project ensures a 100-year flood protection plan.)

Being a part of something so unique with all custom-builts, and working on and around the water has proven a priceless learning experience for Third-step Crane Apprentice Summer Tex. She has managed, in her short career, to gather her crane certifications, and to play a central role in this critical project. She hardly takes credit for this success, however, and instead, points to her crew, and specifically, her Superintendent Shawn Hooker. According to Summer, he has been instrumental in helping her and all of the apprentices, excel on this job. So much so, that she doesn't want the project to come to an end. (The project has a high number of apprentices – eight from the Pile Drivers and six from the Operating Engineers!)

"I learned probably more useful information here than I have anywhere else," said Summer, "And I have worked for better people here than I have anywhere else. Shawn Hooker does more for apprentices than I've ever seen or heard anybody ever do. He wants all the apprentices to learn. And a lot of companies that I've seen and worked for, it's kind of like apprentices just need to stay out of the way, but Shawn wants you to get your hands dirty."

It was actually Summer who contacted *Engineers News* to come and see the project, as she knew it was something different and that the crew was particularly special.













Bringing along apprentices and women in the trades is not just Shawn's philosophy, but also Shimmick's philosophy.

According to Shimmick Construction Superintendent Ryan Turner, who has attended and spoken at several Women in Construction events, encouraging women in this industry is part of Shimmick's philosophy, as well as helping apprentices become journeymen or journeymen to become foremen.

"The apprenticeship we're really big on right now," he said. "We like to push for the apprentices and get them out here to work. It's pretty exciting."

For Superintendent Shawn Hooker, bringing in and properly training apprentices is not just a nice thing to do; it's essential to keep the Trades alive.

"We need a lot more tradespeople," Shawn said. "We need more apprentices. We need people to get involved in recruiting and then we need journeymen to really step up on the projects and encourage apprentices to be involved, to want to be here. It's in all of our best interests for the Trades to continue that generationally."

It's longtime members like Crane Operator Harley Strandberg and Boat Captain Mike McCarthy, who help the apprentices along and bring their experience and expertise to the project, so that it is successful. McCarthy advises apprentices:

"Be on time and don't be late and just bust your tail and make it happen ... Eventually you make mistakes, but you learn from your mistakes. And just keep going; don't be discouraged. Just keep marching on!"

Despite the challenges of this job, such as permitting issues, terrible fog and very hard driving conditions, this part of the project is buttoning up, and this crew has enjoyed almost 1,300 hours with no accidents. Not only that, but this flood season, thousands of Stockton residents can rest a little easier, knowing our work will protect their homes! \*



#### Development projects are booming

Report

In San Francisco, demolition and excavation work has been underway for nine months on the Potrero Power Station development project. As a result, several structures have been removed, while retaining the historic Station A and the iconic 300-foot smokestack. **DeSilva Gates** and **Pacific States Environmental** have operators **Herman Judkins** and **Arnulfo Regalado** performing remediation and sitework. **Mountain Cascade** has Foreman **Taylor Fluharty** and operators **Brent Lund** and **Jose Pena** onsite installing a 52-inch storm and sewer line.

On Third Street, **MWH** Constructors & Webcor Builders Joint Venture (JV) is working on the \$3 billion San Francisco Public Utilities Commission's (SFPUC's) Southeast Wastewater Treatment Plant project, which is being done under a Project Labor Agreement (PLA) that OE3 helped put together. Once completed, the project will ensure the plant can withstand earthquakes and rising sea levels. Harris Hoisting is onsite with tower crane operators Shawn Frazer, Brett Johnson and Joseph Raviotta. DN Tanks is also there with Operator Jo Jo Celestial on a pre-stress wire wrapping machine and Operator James Cook

on a 50-ton rough terrain crane. **Smith-Emery** Inspector **Alan Grimard** is checking the structural steel and welding operations. **Bertco** has Foreman **Jose Venegas** and operators **Jairo Castro**, **Sean Pittman** and **Juan Vazquez** onsite to backfill and grade around new structures. On the headworks side of the project, **Bigge Crane and Rigging** Operator **Michael Hart** is operating a 100-ton hydraulic crane in order to service members with **Cupertino Electric**.

In San Mateo County, our members are working on the ELCO Yards project in Redwood City. This project includes four commercial buildings covering 592,000-square-feet with two residential communities consisting of 500 homes. There will also be underground parking, office space and a restaurant. Bigge Crane and Rigging is onsite with operators Daniel J. Allen, Brett M. Barker, Ronald C. Caddell, Devin A. Scott and Liam A. Byerly. In San Gregorio, Access Limited Construction has Excavator Operator Nicholas T. Vaz using a drill attachment to create a retaining wall that will address storm damage to Stage Road.

The company was awarded a \$2.1 million water tank replacement project for the Hidden Valley Lake Water District. The project, which is being funded by the Water Bond passed by Governor **Gavin Newsom** in 2014, will improve water quality, supply and infrastructure to communities like Hidden Valley that don't have the funding to pay for it themselves. The work involves the building of two new steel tanks and the removal of the old redwood tank. The Hidden Valley Water District hopes to receive more funding in the near future in order to replace four additional redwood tanks, which have surpassed their life

expectancies. The groundbreaking ceremony for this project was attended by Congressman **Mike Thompson** and Lake County Supervisor **Mike Simon**, with both officials giving great speeches on the importance of water improvement projects like this one.

Our members working out of the **Peterson Tractor** shops in Ukiah, Fortuna and the North Bay unanimously ratified a three-year agreement that includes a 13 percent increase over three years. The first year's increase will be 5 percent, followed by a 4 percent increase for the second and third years.


Project will improve native fish habitat

School district approves CWTA


Report

Goodfellow Bros. Apprentice Miguel Castro also spoke on his time as a student within the LUSD, his wish that there had been a program that would have introduced him to union trades earlier in life and what OE3 has given him since becoming a member. Thank you to both of these members for helping convince the Board to pass the CWTA and secure all the work that will come to our members in the future, as a result.

In Dublin, a \$28.8 million parking structure is being built under Alameda County's Project Labor Agreement (PLA) by our members with **KDW Construction**, **Mid-Valley Engineering**, **Landavazo Brothers**, **Castle Contracting**, **J&M** and **Hatton Crane**.

Securing our work through agreements like the ones mentioned above are an example of why it's so important to support OE3's endorsements next year. Uniting behind candidates and ballot measures that support Labor ensures that it is our members and their employers who get the work on these projects. It also makes

sure that non-union employers who underpay their workers and undercut local wage standards are shut out of our work, while strengthening our right to claim our covered work. Have a safe and productive year!

Bridge and Caltrans projects to make this a busy year

Report

Happy new year! Several projects went out to bid late last year, as did some Caltrans asphalt and chip seal projects, with others being awarded. As a result, the 2024 work season looks very promising and our rock, sand and gravel plants will be working steady to produce aggregate to keep our local contractors moving forward.

J. F. Shea has a \$20 million project on I-5 near Weed, a \$30 million project on I-5 near Shasta Lake City and the Evergreen Bridge project outside of Cottonwood. Stimpel-Wiebelhaus Associates has a paving project on Hwy. 96 in Siskiyou County. In Redding, S. T. Rhoades has a two-year project where crews will be working on the Old Alturas Bridge. Viking will be finishing up the Jewett Creek Bridge project in Tehama County. Tullis, Inc.

has paving projects ranging from \$1.5 million to \$29 million throughout our region. **Michels Pipeline** is doing testing and inspection integrity digs throughout the district. At the time of this writing, there are some Caltrans projects in the works that should go to bid soon, including an estimated \$44 million bridge project on Hwy. 96. **Kiewit** has remained busy on the Klamath Dam Removal project, where work should ramp up in the spring.

If you missed our in-district Hazmat Refresher class, there will be classes available in neighboring districts into April. Be sure to renew your registration on the Out-of-Work List every 84 days if you are on the A and B lists, or every month if you are on the C list.

#### Plenty of projects in Roseville

Report

Happy new year! We hope you and your families had a wonderful holiday season! This is the best time of year to upgrade your skills at the Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC). If you are interested in taking journeyman-upgrade classes, please contact the OE3 JATC at (916) 354-2029.

Roseville has a lot of ongoing projects, with many more slated for this year. These will benefit our members and their Pension and Health and Welfare Funds with thousands of work hours. One of these projects is the Roseville Junction. When finished, it will have nine pickleball courts, a bocce ball court, a two-story, indooroutdoor restaurant, a gathering area called Social Connection, which will be made of shipping containers and will include Fieldworks Brewery, and a Hyatt Hotel nearby with a combined 250 rooms.

DeSilva Gates is working on the Roseville Parkway extension project. This job is expected to last through spring



of 2025 and will close the current gap in the parkway between Washington Boulevard and Foothills Boulevard. The work will involve the importing of over 110,000 yards of dirt, which will raise the elevation for the bridge going over Industrial Avenue. At the peak of the project there will be 10 Operating Engineers backfilling and doing finish grade work. DeSilva Gates has completed a \$22 million MSE wall that extended around 780 feet. Lund Construction, Viking Construction and Marques General Engineering, Inc. also worked on the project.

#### 2024 POLITICAL ACTION COMMITTEE (PAC) ELECTION

Recording-Corresponding Secretary Bruce Noel has announced that in accordance with Article X, Section 9 of the Local Union Bylaws, the election of Political Action Committees (PACs) will take place at the first District Meeting of 2024 in each respective District. No Member shall be eligible for election, be elected, or hold the position of PAC Member:

- 1. Unless he or she is a continuous Member in the Parent Local Union for the one (1) year preceding nomination and not suspended for nonpayment of dues during that one year and a registered voter (with proof of current voter registration) in the District where he or she is seeking nomination;
- 2. If he or she is retired, is an Officer of, or is on the payroll of the Local Union or a related entity;
- 3. If he or she is an Owner-Operator or a Contractor;
- 4. No Member shall be nominated unless he or she is present at the meeting, or unless he or she has filed prior to the meeting with the Recording-Corresponding Secretary or to the District Meeting Secretary on the day of the meeting before the meeting commences a statement in writing, signed by him or her, to the effect that he or she is eligible to be a Political Action Committee Member and will accept the nomination if nominated.

### PROOF OF VOTER REGISTRATION FOR POLITICAL ACTION COMMITTEE (PAC) NOMINEES

To be eligible to hold office, all Political Action Committee (PAC) nominees must bring a copy of voter registration proof to the District Meeting at which nominations take place. You can obtain this proof by going to your county Registrar of Voters' or county clerk's office. If you are unable to bring it to the District Meeting, you may fill out a voter registration card at the meeting, before it begins. You may also fill one out online prior to the meeting (and print a copy of it) by finding your state's voter-registration link on our website at www.oe3.org.



Dear brothers and sisters:

As you all know, our local union is large and encompasses four large states. All official union business, including the nomination and election for union-wide offices, bylaws, elections and Political Action Committee (PAC) delegates, will be conducted at locations close to the main district office in your specific home area.

As a result of the large geographic jurisdiction of Local 3, the business manager can, at his discretion, establish subcommittees. Business Manager Dan Reding has currently authorized four subcommittees to be located in Elko, Nevada and Hilo, Kauai and Maui, Hawaii. These subcommittees will have their own PAC to deal with local concerns. Please note: The payment of dues for subcommittee PAC members will be at the discretion of the business manager.

If you are interested in becoming a PAC member, the business manager strongly encourages you to attend your first quarter District or Town Hall meeting (see page 28 for meeting dates and locations), so that you may be nominated and then elected.

## 2024 LOCAL 3 SCHOLARSHIP FOUNDATION CONTEST RULES

The Local 3 Officers, Executive Board and the Scholarship Board of Directors understand that the workplace is rapidly changing, and many jobs require skills that can be attained only with a good education. Local 3 is dedicated to giving our young people the opportunity to succeed by providing them with the chance to further their education and training. For this reason, Local 3 awards annual scholarships to children, stepchildren and foster children of Local 3 members.

Local 3 awards two types of scholarships: Academic Scholarships (winners are judged based on academic qualifications) and Merit Scholarships (winners are selected through a random raffle drawing).

**PLEASE NOTE:** Academic Scholarship applicants who do not win are automatically entered into the Merit Scholarship raffle drawing (at the July Executive Board Meeting). Please do not submit multiple applications.

## All applications must be postmarked on or by March 31, 2024.

#### Who may apply

Children (including stepchildren and foster children) of Local 3 members may apply for the scholarships. The parent of the applicant must be a member for at least one year immediately preceding the date of the application. Grandchildren are only eligible to apply if their grandparent (member) is their legal guardian. Children of deceased members are eligible to apply for the scholarships if the parent of the applicant was a member for at least one year immediately preceding the date of death.

#### Where to get applications

OE3 Academic and Merit Scholarship applications are available at the local's district offices, OE Federal Credit Union branches and online at www.oe3.org.

## How to submit scholarship applications

It is the responsibility of the applicant to see that the application is completed in full and that all of the required items are received on time. If any items are missing, the applicant risks ineligibility.

#### **Academic Scholarships**

Six Academic Scholarships will be awarded to children of Local 3 members.

#### 1<sup>ST</sup> PLACE - \$15,000 TOTAL

Two scholarships of \$6,000 each will be awarded to the first-place female and male applicant, with an additional \$3,000 each for the second, third and fourth years of college, if they remain a full-time student.

#### 2<sup>ND</sup> PLACE - \$12,500 TOTAL

Two scholarships of \$5,000 each will be awarded to the second-place female and male applicant, with an additional \$2,500 each for the second, third and fourth years of college, if they remain a full-time student.

#### 3RD PLACE - \$10,000 TOTAL

Two scholarships of \$4,000 each will be awarded to the third-place female and male applicant, with an additional \$2,000 each for the second, third and fourth years of college, if they remain a full-time student.

These scholarships can only be used for study at an accredited college or university located in the United States and will not impose restrictions of any kind on the course of study. Recipients may accept any other grants or awards that do not rule out scholarship aid from other sources. Winners must submit proof of full-time enrollment to receive payment.

Academic Scholarship applicants must be a graduating high school student who has, or will be, graduated at the end of either the fall semester (beginning in 2023) or the spring semester (beginning in 2024) in public, private or parochial schools. They must plan to attend an accredited college or university anywhere in the United States during the academic year and be able to meet the academic requirements for entrance into the university or college of their choice. Students selected for a scholarship must have achieved not less than a 3.0 ("B") weighted grade point average in their high school work.

#### **Awarding Academic Scholarships**

Upon receipt of the application package, the membership of the parent will be verified. The application will then be submitted for judging to the University of California (UC) Berkeley Scholarship Selection Committee, an independent outside group composed entirely of professional educators.

Apart from verifying the eligibility of the applicant, Local 3 will not indicate in any way that one applicant should be favored over another. The UC Berkeley Scholarship Selection Committee will submit their selected finalists to the Scholarship Foundation's Board of Directors for approval.

Academic Scholarship winners will be notified by Local 3 and posted on www.oe3.org.

#### Requirements for Academic Scholarships

The following items must be submitted together by the applicant (unless it is the policy of the school to submit the Report on Applicant and Official Transcript directly).

- 1. Application filled out by student
- 2. Essay written by student
- Report on applicant filled out by authorized school representative
- Official transcript from school (signed or stamped)
- 5. Letters of recommendation one to three letters from teachers, community leaders, family friends, or others who know the applicant must give information about the applicant's character and ability

**NOTE:** Winners will be contacted for a photograph to be used in Engineers News.

#### **Merit Scholarships**

In addition to the six Academic Scholarships, Local 3's Scholarship Foundation will award 25 Merit Scholarships in the amount of \$2,000. Children (including stepchildren and foster children) of Local 3 members who are currently attending or planning to attend college or trade school full-time in the next year may apply for the scholarship.

#### **Awarding Merit Scholarships**

Upon receipt of the application and required essay, the membership of the parent will be verified. Apart from verifying the eligibility of the applicant, Local 3 will not exercise any choice among the various applicants. The Merit Scholarship winners will not be judged on academic qualifications but will instead be selected through a raffle drawing held at Local 3's July Executive Board meeting. Previous Merit Scholarship winners and applicants may re-apply each year. Applicants need not be present to win; winners will be notified by Local 3 and posted on www.oe3.org. Winners must submit proof of full-time enrollment to receive payment.

**Article XII, Section 3, Elections:** 

- a. The election of Officers and District Members of the Local Union Executive Board shall be held during the month of August by mail referendum vote of the Membership of this Local Union under the supervision of the Election Committee and a firm of Certified Public Accountants, selected by the Executive Board, with such other technical and legal assistance as may be provided.

Each nominee shall be a registered voter in the District in which he or she is nominated, shall have been a Member of the Parent Local of Operating Engineers Local Union No. 3 for five (5) years next preceding his or her nomination and election, and shall not be a candidate or nominator of a candidate for any Office or Position.
- c. The nominee for Committee Member in each District receiving the highest number of votes shall be elected, and, in the event he or she is unable or unwilling to serve, shall be replaced by the nominee with the next highest number of votes, and he or she, under the same circumstances, by the next highest, and so on, until the list of nominees is exhausted.
