Tradeswomen Build Nations Winners Announced

This month's cover story is about a renewable-energy project in eastern Alameda County, where our members are preparing pads for additional and replacement wind turbines in the Altamont Hills. In subsequent months, Engineers News will highlight another wind-energy project located within Pacheco State Park in Fresno District 50. This district recently secured a Project Labor Agreement (PLA) for the Darden Clean Energy job, the world's largest solar and battery storage project, which will create more than 2,000 prevailingwage construction jobs over the next three years, according to the California Energy Commission (CEC). In this month's District Report section, you will find many school projects that involve solar energy, as well as major work on data centers, like Switch, in Nevada District 11, which is powered by 100 percent renewable energy. Do you see a trend in all of this work? It's all related to the renewableenergy sector.

There was a time when our industry was suspicious of environmental concerns, because they often created a lot of red tape that kept our members out of work. Today, that mindset has shifted and renewable-energy projects, like wind farms and solar fields, don't limit jobs, but create them within every aspect of our trade, from the dirtwork for the pads and underground infrastructure, to the crane work lifting turbines into position, and everything in between. Operating Engineers increasingly enjoy the job-creating benefits that renewable energy developments build within our communities and in support of the broader economy. Renewable-energy projects also create affordable energy for communities who need it and provide forward-thinking solutions for barren and often deserted, dilapidated property.

The current presidential administration does not seem to share this idea. New policies have included heightened trade barriers, a rollback of clean energy tax credits and a tightening of permitting procedures. Industry analysts warn that such moves threaten the growth trajectory of domestic wind and solar energy and could destabilize long-term energy supply. Our Political Department has deep connections with Labor allies that have been actively working with renewable energy coalitions to protect this work, make sure it's performed using union labor and to secure more of it. In doing so, we are seeking to increase our market share for this type of work today and tomorrow.

Learn more about this and other Local 3 projects and developments at the upcoming Semi-Annual Event this month, on Sunday, Sept. 21, at the Scottish Rite Center in Sacramento, Calif. You will be receiving a postcard in the mail very soon with all the details. A special collector's item will be free to all members in good standing who attend. Don't miss it!

Also this month, from Sept. 19-21, in Chicago, IL, many of our sister Operating Engineers will be representing Local 3 at the largest gathering of Tradeswomen in the world, the Tradeswomen Build Nations (TWBN) conference. From a pool of more than 50 applicants, the seven women below were chosen by an outside committee, and we will be sharing their experience here and on social media, so stay tuned. Big projects ahead

I look forward to seeing you all at the next Semi-Annual Event on Sunday, Sept. 21, at the Scottish Rite Center in Sacramento, Calif. Your Local 3 staff works on these events months in advance, as there are a lot of moving parts. As usual, the event never disappoints. There's free food, giveaways to union members in good standing, OE3 merchandise available and lots of good conversations to be had with members, apprentices, staff and their families. In his State of the Union Address, Business Manager Dan Reding covers everything related to your union, from the Pension status to the work picture.

Come on out! Speaking of the work picture, one project that your business manager has referred to often in past Semi-Annual Events is the giant Uinta Basin Railway project, which will connect Utah to Colorado. The project had been stalled for environmental reasons, but I am happy to report that the \$3.4 billion rail line, which is projected to employ about 800 Operating Engineers, has been given the green light. In late May, the U.S. Supreme Court unanimously upheld the

line that will connect the Uinta Basin to the national freight network to begin next year. This project is expected to quintuple oil production from the region and boost employment numbers for thousands. Keep an eye out for more about this project here and on our social media accounts.

Another key project that has been in the works for decades is Sites Reservoir, which is located west of Maxwell, in Colusa County, Calif. This \$6.8 billion Sites Reservoir project was also in limbo due to environmental review, but it has recently been cleared to begin by the end of next year, which is great news for Operating Engineers. Officials expect to complete the construction of a dam, roads and other structures around the reservoir within six years.

Local 3 has been heavily involved in the support of both of these projects, which is tied, yet again, to the importance of politics to our

> work. From Supreme Court judges to local city council members, everyone has an opinion about unions, infrastructure funding, collective bargaining rights and Project Labor Agreements (PLAs), so the support we give or withhold from politicians and measures adds up to whether we go to work or not. We cannot stress this enough. So pay attention to the information your union provides to you and make informed choices. It may not be an election year,

but decisions are made every day by politicians we elect, and these decisions play a key role in our livelihoods.

Your Union Voice, Your Union Vote Matters

Unit 12 consists of around 12,000 members and applicants. That is 12,000 potential voices and votes, when it comes to contract negotiations and changes impacting your pocketbook, your working conditions and your benefits. We find ourselves in another fight to protect and move our membership forward through difficult economic times.

The first three letters in UNION are UNI ("You and I"). Together and unified - you and I - can stand and have our voices heard, but that takes membership and participation. When we stand by and don't vote, we allow a small percentage of our brothers and sisters to decide our fate. The more unified, organized and motivated we are, the more we can expect better outcomes when it comes to our wages, benefits and working conditions!

How do we do it? Be a member, participate in the negotiations process, cast your vote and have your voice heard! Remember, a union is only as strong as its membership. Therefore, we unit 12 members (all 12,000) and the entire Local 3 membership (40,000+) have the potential to show our power in numbers as a collective voice. Stand together, stand strong and have your voice (and vote) count! Consider calling your business agent or union office to see what's needed. Attend your union meetings and contract negotiations meetings. Consider becoming a job steward. The more you get involved, the stronger we all are.

Second Quarter 2025 Consolidated Financial Results

The uncertainty and pressures from tariffs have played a huge role in our economy, since the White House declared a national emergency and began imposing high trade tariffs.

Real Gross Domestic Product (GDP) advanced at a 3 percent annualized pace in the second quarter of 2025; however, the drastic jump from a 0.5 percent contraction in the first quarter to 3 percent growth in the second quarter was mostly due to a decrease in imports and an increase in consumer spending (a reflection of the tariff threats). In the first quarter of 2025, businesses stock-piled imported goods, reacting to the government's talks of 30 percent, 40 percent and at one point, 125 percent tariffs, on Chinese imports. As a result, in the second quarter of 2025, imports plunged by 30.3 percent. Consumers reacted the same way businesses did, just one quarter behind. In the second quarter of 2025, consumers panicked and began stockpiling certain goods to avoid higher costs in the future. Motor vehicles and parts were the leading items purchased to avoid higher tariffs.

During this quarter, the U.S. employment rose by 465,000 according to the U.S. Bureau of Labor Statistics. The construction industry added an average of only 7,000 jobs each month this quarter, compared to 15,000 jobs each month in 2024.

Local 3's work picture remained strong in the second quarter of 2025. The May 2025 Year-to-Date (YTD) Pension hours were higher by 14 percent, 8 percent, 6 percent, and 2 percent than in the same

period in 2024 for Nevada, Utah, Hawaii and California, respectively. The overall May 2025 YTD Pension hours were 4.88 percent higher than the same period in 2024.

The receipts and expenditures for the first half of 2025 were \$38.2 million and \$36.0 million, respectively. Total receipts for the first half of 2025 were \$2.6 million higher than in the same period in 2024. This is mostly due to higher dues rates (a result of wage increases), more members' paying dues (39,550 members in June 2025 versus 38,481 members in June 2024) and more work hours (4.88 percent). The expenditure for the first half of 2025 was \$2.4 million higher than in the same period in 2024, which was primarily due to the transfer of funds to the Building Holding Association for a property purchase.

The new tariffs and policies announced by the White House every day continue to create uncertainty for our future. While the Consumer Confidence Index, published by the Conference Board, increased slightly since March 2025, it remained at the same level as during the pandemic in 2020. Rest assured, Local 3 continues to secure the core needs we all believe in, training, steady employment, good wages, strong benefits, safe working conditions and collective bargaining rights for the benefit and well-being of our members. We look forward to the rest of the work season, with members racking up more Pension hours.

Credit for Military Service

If you are unable to work the necessary hours in Covered Employment due to service in the Armed Forces of the United States, you will receive Credited Service, Pension Credit and accrued benefits for the period you retain re-employment rights under federal law.

Military Service After Your Contribution date

After your Contribution Date, if you are absent for Covered Employment due to qualified military service, you will be credited with hours toward the accumulation of Years of Credited Service, Pension Credit, accrued benefits and the prevention of a Break in Service for the period of the military service, provided:

- You were working in covered employment in the jurisdiction of Local 3 during the 90-day period immediately preceding your military
- You had not incurred a One-Year Break in Service at the time you entered qualified military service.
- You retain re-employment rights under the Uniformed Services Employment and Re-employment Rights Act of 1994 (USERRA).
- You satisfy USERRA's advance notice to Employer (or Fund Office) requirement prior to your leave to enter qualified military service.
- Your discharge from military service was under honorable conditions.
- You return to work in Covered Employment in the jurisdiction of Local 3 within the re-employment period required by federal law, as show in the chart below:

LENGTH OF MILITARY SERVICE	<u>re-employment deadline</u>
Less than 31 days	Within one day after discharge (allowing travel time, plus eight hours)
31 through 180 days	—Within 14 days after discharge
181 days or more	—Within 90 days after discharge

Hours for qualified military service are based upon the average hours you worked in a week during the 12-month period immediately preceding your military service or, if shorter, the period of employment immediately preceding the military service but not less than 30 hours per week. For the purposes of determining the amount of your accrued benefits, Contributions will be credited, based on the Employer Contribution rate that would have applied if you had continued to work in Covered Employment instead of entering military service.

No more than five years of qualified military service will be recognized toward the accumulation of Years of Credited Service, Pension Credit, accrued benefits and the prevention of a Break in Service or a Separation from Covered Employment.

Turning age 65 and Medicare

I often get asked, "When I turn 65, what do I do about Medicare? I want to be sure to comply with our OE3 Pensioned Health and Welfare Plan."

A FEW TIPS -

- When you turn 65, the Plan requires you to enroll in both Medicare parts, Part A (hospital) and Part B (doctor), unless you are still on the active Health and Welfare Plan.
- The month after you turn 65 and are on Medicare, your Pensioned Health and Welfare payment will drop from \$500 to \$125 monthly.
- Medicare will become the primary insurance and pay the first 80 percent of medical costs; our Plan will pay 80 percent of the remaining contractual costs.
- Be sure to give your provider both your Medicare card and your OE3 insurance for billing.
- IMPORTANT! Always check with Medicare when you turn 65 - and before enrolling. It helps to make an appointment at your local Social Security office several months before you turn 65 to enroll in Medicare. They will lead you through the process.
- If you neglect to enroll in Medicare in a timely fashion, you will be responsible for the first 80 percent of the Pensioned Health and Welfare contractual medical charges - the ones Medicare would have paid. We want to avoid that at all costs.
- If you are over age 65 and retire but are drawing out your active Health and Welfare hour bank, you should check with Medicare, as they may tell you they consider you "not retired" until that is exhausted. Always check with Medicare.

American Legion Ambulance ratifies two-year CBA

American Legion Ambulance (ALA) negotiation team members Jordan Fisher, Abigail House, Dillon Pardini, Erik Jones and I recently negotiated a new successor Collective Bargaining Agreement (CBA), which affects Emergency Medical Technicians (EMTs) and Paramedics/Medics (EMT-Ps).

Negotiations for successor contracts are always challenging, but even more so, post the pandemic, with the most common challenge being the retention and recruitment of staff. Another hurdle we overcame in this negotiations session was dealing with an abrupt dismissal of the top management personnel. Overall, we prevailed! See details to the right:

Term: Two years (effective July 1, 2025 through June 30, 2027)

Wages for EMTs: Now, employees start 10 percent above minimum wage at Step 0 (first pay step). Steps 1-9 will receive 2 percent more at each step. Steps 10-20 have a new structure of 3 percent between them. Pay steps are now realigned, meaning members will receive wage increases anywhere from 3-7 percent, depending on which step they are at.

Wages for Medics: Now, medics receive 20-25 percent above the EMTs' pay steps, from the bottom of the steps to the top. This means members receive wage increases from 2-8 percent, depending on which step they are at.

Mandated shifts: Prior to this contract, if members volunteered for an overtime shift, they stayed on the mandated overtime list at the current spot they volunteered. Now, members can volunteer for an overtime shift before they are mandated and start at the bottom of the mandate list.

Blackout dates: Late December and early January (Christmas and New Year's) were blackout dates for vacation, meaning no employees could take time off during these periods. Now, these weeks are no longer blackout dates.

Grievances: A specific timeline was negotiated for management to respond to a Step III grievance. Prior to this, management could sit on a grievance indefinitely.

Pershing County Employee Association contract is BIG WIN

The Pershing County Employee Association is represented by Local 3, and I have negotiated three contracts for this unit, since being a Public Employee business agent. Nevada's Pershing County has some mining and agriculture, but revenues have not been the best, during and since the pandemic. We negotiated a meager contract during the pandemic that ended this year. Unfortunately, members have gotten used to cost of living increases falling below the nationwide average, often by 2 percent, and they have continued to stick with their County in these lean times.

This year, a new revenue stream from mining started. Pershing County's management called and asked me not to make a proposal at the first negotiations meeting, which is very unusual. I agreed but did come prepared with a proposal and prepared my new negotiations team. During the start of negotiations, the management team said they appreciated the employees and thanked them for always working with the County in these challenging times. Then, they offered a two-year deal worth over 25 percent! As sly as I could, I put my proposal into my backpack and asked for a caucus. The negotiation team and I talked for about five minutes and accepted the offer. The negotiation team did not get much experience during this particular session, which is unusual, because negotiations usually last much longer. I explained to the team that this is a County government doing right

by its workforce, and it's not common or something to expect next time! I thank this team for their courage in stepping up and being a part of the team.

I must also acknowledge previous Pershing County Employee Association presidents Bruce and Barrie Medeiros, who had to sit at the table during earlier contract negotiations, which were such a struggle. This husband and wife worked in street maintenance and were soon retiring and moving to the East Coast, so they had just held elections for the new officers. Bruce and Barrie have been OE3 members for their entire careers with the County and held positions in the Association as officers for most of that time. They missed this round of negotiations by months and will not see the improvement, but they laid the groundwork. I want to thank them for all the effort and time spent working to improve the lives of their fellow employees.

Remember, serving on a negotiations committee or on an association is voluntary and unpaid, and being a chief steward is time-consuming and difficult but rewarding. You make your association better and stronger, and Barrie and Bruce did just this. Now, all we can do is wait and see what happens during the next round of negotiations!



SacRT members secure a good contract

Sacramento Regional Transit District (SacRT) members recently ratified a new contract with the best benefit being that employees are finally able work to the top of the pay range by moving annually through the steps.

Historically, SacRT representatives would share a job posting with a pay range across a 40 percent spread and then hire someone at the bottom of that range. Then each year, the Cost of Living Adjustment (COLA) would adjust the range up slightly, and the employee would get a raise but always within the bottom of the pay range.

For this contract, SacRT representatives agreed to remove the lower 10 percent of that pay range and create a 10-step system with a 3 percent increase per step. Employees were placed on the step in the range that provides a minimum of a 3 percent raise and will move up steps each year on their anniversary. For example, someone who was at the bottom of the pay range previously will start out with a 10 percent pay increase at Step 1 and will move up 30 percent over 10 years (not counting the COLA increases.)

We were also able to get a 2.5 percent COLA increase each year for 2026 and 2027, with the contract up for negotiations in 2028. Therefore, employees who have not reached step 10, will get 5.5 percent more each year for 2026 and 2027.

Other gains made in this contract include:

- » Up to a 3 percent match into a retirement account
- Reduced probation upon promotion from 12 months down to six months
- Five classifications received a pay-grade increase
- Five additional classifications are receiving a classification/compensation
- » Clarified the on-call and callout procedures and allowed for earning Compensatory Time Off (CTO) and Overtime (OT) (previously it was only
- » Employees previously received a ½-day off available the day before Thanksgiving, Christmas or New Years — employees will now have hours available anytime as part of Floating Holiday hours
- Acting out of class and training pay has increased from 5 percent to 10
- Newly hired employees may negotiate a starting pay step but cannot make more than an existing employee in the same classification
- Established a Bereavement Leave section that provides for five days, paid by employer
- » Created a sick leave incentive, in which employees can earn additional time-off for using limited amounts of sick leave in a year
- » CTO cashout can be paid or placed into a 457 retirement account

Contract negotiations have many hurdles but are nearing finish line

Negotiations for our Public Employee units in the state of Nevada are wrapping up, and we have been able to secure some good contracts. We started the process in January by sending notices to the units with our intent to open negotiations and renew our contracts with them. We let them know we were willing to discuss contract items that either need to be changed or updated, as well as any new items the membership would like to enhance or add. This is the usual process. Membership input and participation are

This time around, however, there seemed to be some hesitation at the negotiation table for fear of finances. Medical costs are on the rise, and the political climate has been filled with uncertainty. Together, we all had to navigate through these areas and get contracts finalized without losing any ground and in a timely manner.

Most units have been experiencing the effects of cost-reduction measures to offset budget restraints, whether it's been hiring freezes, layoffs or past budget deficits that are affecting current budgets. Then came issues regarding higher

retirement costs and the fact that more people are retiring and less people are coming in to replace them.

Medical costs have gone up, sometimes as much as 23 percent or higher, which has felt like an attack on working people, as these costs are just plain unaffordable and cannot

be sustained. Employers continue to ask their employees to somehow pay for it all. We all want our families to be insured, but when the cost of insurance is sometimes as much

per month as a week's paycheck, it's hard to imagine that this rate of increase can continue.

The State recently released the new Public Employees Retirement System (PERS) financials, which, in some cases, has employees pay this benefit through a Cost of Living Adjustment (COLA) reduction, after our July contract dates came in at a rate of 1.625 percent for general unit employees and 4.375 percent for Police and Fire units.

Knowing that before we even started negotiations made for a tough season. Fortunately, we finalized most, came out decently and are still working on a few. Stay tuned for more details.

Another POP class down!

Last month, we finished another 240-hour Probationary Orientation Period (POP) and 40-hour employer referral class at the Operating Engineers Local 3 Journeyman and Apprentice Training Center (OE3 JATC). Nearly 100 students gathered for the group photo, which included Construction Equipment Operators (CEOs), crane operators, Heavy-Duty Repairers (HDRs), gradesetters and drill operators.

In other news, at the time of this writing, electrical work is being done on the new covered dig, which should be completely finished by the time you hold this copy. The covered dig will ensure that we can train on and house equipment year-round on the training property off of Meiss Road. Ongoing work will include moving most of the training facilities, minus the dorm rooms, to this site. Any day you step on the OE3 JATC property is a busy one, as POP classes and Supplemental-Related Training (SRT) continue, along with tours and the ongoing construction of the new training site. 

A perfect Pacific Ocean partnership ~ Dixon Marine and Vortex

In the beautiful coastal area of Half Moon Bay, Calif., a rare partnership has taken place. Dixon Marine Services and Vortex Marine Construction, Inc. have formed a joint-venture to provide suction dredging services along Surfer's Beach.

The work is part of the Surfer's Beach restoration project, recently approved by the San Mateo Harbor District, and if the partnership between these two signatories proves successful, this work may be ongoing every two years.

According to Harbor District General Manager James Pruett, "This is a pilot project to see if it's going to work or how it works."

The harbor has been bogged down for decades, which has caused difficulties for boaters and caused erosion of the shoreline. The 100,00 yards of dredging material (clean sediment) from the harbor

will restore a 1,500-foot stretch of Surfer's Beach shoreline and combat ongoing erosion. (This has never been done before.)

The two crews divide two 12-hour shifts, with Dixon Marine starting at 6 p.m. via a boat ride from Pillar Point Harbor to the open water. Crewmembers operate the cutterhead suction dredge and then return to the shore, where crews with Vortex wait to start their shift at 6 a.m. And so the process continues, with an expected end-date of Oct. 15.

"Hopefully this project will mean more work just like it in the future," said Crane and Dredging Special Rep. Tom Kohlenberg.

Thanks to the unique skillset of these deckhands, deck engineers, captains and levermen, the public will be able to enjoy this coastline, and this work will provide a natural barrier to the Pacific Ocean.

The Mulqueeney Wind Farm is a massive, renewable energy project currently underway in the Altamont Hills of eastern Alameda County, Calif. Work on the project began in April. Since that time, Operating Engineers with Ford Construction have been preparing the vast jobsite for the installation of 19 new wind turbines, all while adhering to strict safety and environmental protocols and battling high winds and dust to meet tight deadlines.

Ford Construction is responsible for moving approximately one million yards of dirt, pioneering roadways and preparing the pads for future wind turbines.

"It's a lot of ripping with the dozer," said Foreman John Curran. "There's a lot of rock and hard material, so right now, we're mostly just doing scraper support and making sure they can get around safely and smoothly."

Nearby, Foreman Makayla Triano is leading another crew of Ford Construction operators, but with a focus on finish work.

"Our scraper operators come through and bulk everything out with the 57s, and then me and my crew come through and make

everything look pretty and get it where it needs to be," he explained.

Safety is a major focus on this project, especially along Patterson Pass Road. This narrow, high-traffic route divides the project into two construction areas and poses daily hazards for workers who must share the road with commuters using the lesser-known corridor to get to and from the Bay Area. That focus on safety isn't confined to the roadway; however, and a full-time safety manager is always on the jobsite, where field crews participate in weekly safety meetings, are provided with daily Job Hazard Analyses (JHAs) and participate in mandatory safety huddles every morning. The use of the appropriate Personal Protective Equipment (PPE) is also strictly enforced, with workers being required to use eye protection and hard hats with chin straps at all times. This is a necessity in the dusty and windy conditions of the Altamont Hills, where traditional hardhats are easily blown away and one strong gust of wind can kick up dust particles and temporarily (and painfully) blind anyone who fails to protect their eyes properly.

Environmental protection is equally important on this project. The site lies on Mulqueeney Ranch, which is a functioning cattle ranch and home to several sensitive species, including burrowing owls and tiger salamanders. To prevent any disturbance to the cattle operations, gate protocols and a 15-mph site speed limit are strictly observed. Preventing any disruption to the local wildlife means biologists monitor ponds and nesting areas that must be surrounded by protection barriers, often made from hay bales, which allows the work to continue.

Another challenge is managing water on the job. With limited onsite resources, much of the water used to control dust must be imported to the jobsite, supplementing water supplied by wells and tank farms. However, all of these challenges are small in comparison

to the positive impact this work will have on the economically important region, which is very much in need of renewable energy infrastructure to meet current and future demands. Operators involved in this work are very much aware of the value their work brings to themselves and their families, as well as their employer and their communities.

"Every day you have a good sense of accomplishment," said Triano. "You can turn around and look at the things you've built and see your daily progress. You can see that you're changing the world... It also keeps everybody working, with lots of overtime and big paychecks!"

"We came out here and this was all just a field, and now it's finished pads and roads," said Curran. "It's cool to see that at the end." *

School upgrades wrap-up, as school year starts

At the Potrero Power Station project on 23rd Street in San Francisco, Mountain Cascade has operators Tyler Fluharty and Michael Stark installing a storm drain. Fontency Engineering is also onsite with Operator Ricardo Zaragoza working on water tie-ins. DeSilva Gates is doing the grading and paving and is working on the new curbs and gutters with Operator Arnulfo Regalado. This 29-acre, \$2 billion project started in 2020 and will be providing work for our members over the next several years.

J. Flores Construction Co. has several five-member crews tackling sewerline breaks and street repairs across San Francisco, all being done under a contract with the San Francisco Public Utilities Commission (SFPUC). Members performing this work include Foreman Tony Belloso and operators David Moreno and Santiago Pena. Work on the University of California San Francisco (UCSF) Hospital expansion at 500 Parnassus Ave. continues with members from McGuire and Hester, Bigge Crane and Rigging and Fontency **Construction**. This includes digging pits for electrical vaults, plumbing equipment and other utilities.

In San Francisco's Sunnydale neighborhood, our members are working on a major \$14 million housing project. McGuire and Hester is handling one half of the project and Cahill Contractors is in charge of the other. The project is still in its early stages, with a few excavator operators performing small utility installations, but it is expected to employ around 15 operators and several apprentices, as the project ramps up.

Operators have been upgrading Parkside Elementary in San Mateo. This work includes replacing blacktop, converting the grass field to turf, erecting shade structures and constructing a new multi-purpose room. **OBS Construction** has Excavator Operator Willie Waters doing the demolition and grading work. Azul Works, Inc. is onsite with Operator James Rosas. Andreini Bros. is onsite with Operator Ivan Ortiz working with the electricians. Griffin Soil, Inc.

is also involved, with members Ramiro Yanez, Kurt Reynolds and Joseph Cattoor improving ground conditions with lime treatment. Nearby, at Highlands Elementary, a similar project is underway. Kier & Wright, Inc. has Party Chief Michael Dangler and Chainman Cory Hiranaga onsite. Robert A. Bothman Construction is also on the project with Foreman Patrick Vandal, Gradesetter Barnabe Cervantes Garcia and operators William Fontana, Frank Adolph and Michael Busler performing the demolition, grading, utilities and landscaping.

Public works projects keep crews busy

In Vacaville, Graniterock is working on a \$2 million road widening project off Foothill Drive. This project will run into the fall, with our members adding turn lanes for easier access to Pleasants Valley Road. Goodfellow Bros. is finishing paving work on southbound Leisure Town Road, which began last fall. Bay Cities Paving and Grading has our members working nights, as they install new storm water pipe to prevent flooding on Hwy. 12 in Suisun.

Azul Works is tackling a \$16 million emergency public works project on Laurel Street in Napa. This work, which involves removing and replacing 8,200 linear feet of 36-inch pipeline, started in May, after another company failed to do it right the first time. JV Lucas Paving, Inc. is also in Napa, with our members working on the Browns Valley Road Rehab/Westview to Freeway project, which involves paving the whole stretch of Browns Valley Road.



In American Canyon, the \$1 million Melvin Road to Donaldson Way Sidewalk project has been awarded to Kerex Engineering. Our members will be installing new sidewalks, curbs and gutters and Reinforced Concrete Pipe (RCP) for drainage. **Kerex Engineering** has a similar project on Broadway in Vallejo between Tennessee Street and Redwood Street.

After being put on hold for several reasons, including a fatality, work is proceeding on the \$30 million diverging diamond project at the Hwy. 37/Fairgrounds Drive Interchange. Ghilotti Construction has two shifts working to get it

Apprenticeship training doesn't stop at learning how to operate equipment, as its safety training is second to none! Apprentice **Chris Chandler** is a great example of this. Chris works for **Argonaut Constructors** and was recently at work when he noticed a transport driver was having a heart attack. Chris remembered his First Aid training and started performing CPR on his co-worker until first responders arrived on the scene. Thanks to Chris' quick thinking and actions, he was able to save his co-worker's life. We offer our deep appreciation for Chris' heroic actions!

In the last election, voters in the City of Petaluma passed Measure M, which provides public funds for school construction and modernization projects in Petaluma. Thanks to the passage of this ballot measure, contractors like **Westpac Construction** have been able to capture projects and provide stable, local work for our members. This includes a \$3.7 million modernization project at Sonoma Mountain Elementary School for the Old Adobe Union School District. The project involves paving parking lots, replacing a storm drain system and constructing new Americans with Disabilities Act (ADA) compliant ramps and access points.

Ghilotti Construction continues to make progress on the \$25 million Hearn Avenue overcrossing project, where our members with the company are currently grading ramps for eastbound traffic and are working on bridge abutments. Members with Stoer & Graff are also onsite, performing pile driving for the next section of the overcrossing. Team Ghilotti recently started work on a \$4.2 million creek restoration project for the City of Santa Rosa, which includes excavation, the placement of fill, compaction, installation of log structures and the placement of natural rock to restore habitat. Terracon Constructors continues to work on a \$4.7 million project for the Sonoma County Water Agency that involves activating an industrial water well and upgrading a

facility on Occidental Road. In Larkspur, **Disney Construction** is working on a \$3.9 million pump station facility rehabilitation project for the City.


Reno and the surrounding region are undergoing major construction and energy development, which is increasing demand for Local 3 operators and providing steady employment for our journeymen and apprentices. This construction and development includes work on a data center at Switch, the Redwood Materials facility and a lithium mine north of Winnemucca. Other, ongoing industrial developments are underway for Apple, Google and Microsoft, as well as airport and casino expansions.

From Elko

Acha Construction continues to work on the S8.5 million tribal school project in Owyhee, at the Meickle Mine in Carlin and at the Carlin maintenance shop. MKD has been awarded a new sidewalk rehabilitation project in Elko, which will continue for the remainder of the summer. Q&D Construction continues to work on the new Spring Creek roundabout and at the Hunter Pit, where our members are producing materials for the project. N. A. Degerstrom has been awarded a project at the Rain Mine just outside of Carlin and is currently in the process of setting up a two-shift operation. The company also continues to work at the Rossi Mine outside of Carlin and the Gold Bar Mine in Eureka. Road & Highway Builders is working on a \$53.6 million project in Ely, which will continue through the remainder of the year, and is also finishing work on the Golconda Pass truck climbing lanes. Sterling Crane is keeping members busy at Nevada Gold Mines (NGM) and is setting the steel and building materials for the new Boys and Girls Club in Elko.

At the time of this writing, gold is \$3,350.70 per troy ounce. We will be holding "Wants and Needs" meetings for upcoming NGM contract negotiations soon, as negotiations will begin at the start of 2026. Members turn old prison into mixed-use community

W. W. Clyde and Geneva Rock Products formed a Joint Venture (JV) called **Innovation Point Partners** to tackle the first phase of a unique, \$2.3 billion. mixed-use development project known as The Point. This development is located at the Point of the Mountain in Draper, from which it takes its name, and was once the site of the old State Prison. The land, which is owned by the State of Utah, covers roughly 600 acres. Thanks to a long-term lease from the State and an investment of \$165 million from the State legislature that will be paid back with interest and revenue from the property, the residents of Utah will have a say in what happens on this land for many years to come.

Members with W. W. Clyde and Geneva Rock Products are building the core infrastructure of The Point, which includes parks, roadways, walkways, underground utilities and more. Superintendent Shane Mecham has been tasked with overseeing the project, while W. W. Clyde Foreman Paul Cole

and Geneva Rock Products Foreman Vicky Atwood are overseeing the day-to-day work, which is expected to employ 25 to 30 Operating Engineers at the project's peak. This project is also a wonderful opportunity for apprentices like Charlotte Underdahl and Kaden Razban, as they will be getting some valuable, real-world work experience on the project. Details about The Point's development plans include:

- Over 3,300 multi-family residential units, including approximately 400 affordable housing units
- 16 acres of parks, including the Central Green, all situated so that every home is within two blocks of a park or a trail
- 6 miles of roads
- 10 miles of sidewalks and trails, including the River-to-Range trail
- More than 2.32 million square feet of office space
- 540 hotel rooms
- A 60,000-square-foot entertainment venue with seating for 2,000 people
- 356,000 square feet of retail space for shopping, restaurants and grocery stores
 - The construction of Convergence Hall, a building that represents the first piece of the Innovation District
 - 100 percent drought-tolerant landscaping
 - 14,000 high-quality, local jobs created
 - 12,650 parking stalls housed in multi-level parking garages

There's lots of work in Eastern Alameda County. About 28 members with **Ford Construction** are working on the \$21.5 million road and underground portion of the Mulqueeny Wind project. Crews are making pads for 19 windmills, and the construction portion will start in July of next year. See this month's cover story for more details.

Pacific Gas and Electric (PG&E) has a lot of gas line work going on. Some of this includes **Underground Construction**, **Inc.'s** work, replacing 700 feet of 36-inch pipe in Fremont. **Michels Pipeline** is replacing 728 feet of 36-inch pipe in Sunol, and **ARB** is replacing 4,000 feet of 12-inch gas line in Pleasanton. **ARB** is also working in Livermore on the \$108 million Aramis Solar Project with **Clark Brothers**, which will employ about 25 Operating Engineers for another year.

In Sunol, **Mitchel Engineering** is working on a \$4.8 million, 12-inch water main replacement job, thanks to the San Francisco Public Utilities Commission's (SFPUC's) Project Labor Agreement (PLA).

Members finish-up Llagas Creek work before fall hits

September is here, and that means the mad dash to wrap-up projects and get ready for winter is right around the corner. One such project that is nearing the finish line is Upper Llagas Creek Phase 2B, where crews with **Graniterock** must be out of the bottom of the creek by October. The Big Sur coast is known for its scenic beauty, as well as its vulnerability to the forces of nature. On March 30, 2024, a major slip-out occurred just south of the Rocky Creek Bridge in Monterey County, undermining the southbound lane and threatening the stability of this stretch of Hwy. 1. Operating Engineers immediately went to work on the Rocky Creek Slip Out Emergency Project, in order to fix the problem and ensure it doesn't happen again.

The \$30 million project, funded through the State Highway Operation and Protection Program (SHOPP), restored two-way traffic and began securing the roadway against future erosion. Caltrans' initial stabilization efforts involved installing horizontal and vertical rock dowels and applying mesh-reinforced shotcrete to the vertical cliff face. This was followed by Teichert crews coming in to construct a permanent viaduct to support the roadway and rebuilding the concrete seawall at the base of the cliff, 620 feet below street level, to prevent further erosion.

Local 3 members played an important part in every phase of the job, while enjoying the spectacular setting for this unique project, complete with views of the Pacific Ocean and the rugged California coastline that visitors come from around the world to see.

"Not too often do you get to be in a work setting like this," said Superintendent Jeremy Young.

Those views come with the unpredictability of coastal weather, which can go from dense fog and high winds one moment, to sunshine and a slight breeze the next. That everchanging environment is taken in stride by Heavy Duty Repairer (HDR) and all-around Operator Larry Tacker. In

fact, it's one of the things that appeals to him most about being in this line of work.

"My favorite part is the ever-changing aspects of your job from day-to-day and hour-to-hour."

For Operator Enrique Maydon, who has been operating an excavator while assisting the Cement Masons with rebar and form board placement, the sense of pride he gets from projects like this are key.

"It's a big job," he said. "Being able to drive by and say, 'I worked on that project,' that's my favorite part."

For Operator Sal Cricchio, who worked non-union prior to becoming an OE3 member, it's the union benefits and the comradery on interesting projects that are most appealing.

"The insurance is very awesome," he said. "They take care of your family, and you work around awesome people and on cool new projects all the time."

On the day *Engineers News* visited, it wasn't just operators with Teichert working on the project. Interstate Concrete Pumping, Inc. had members Adam McReynolds and Logan Hiler onsite, constructing a pump line that would deliver concrete to a spider boom at the base of the cliff in preparation for seawall construction. Meanwhile, Teichert crews prepared the site for a helicopter that was delivering materials and equipment to the crews working at the foot of the cliff.

The work is great for Operating Engineers for a variety of reasons, but at the end of the day, ensuring that one of California's most treasured roadways remains safe and open for travel made this a project of high value to California's coastal communities and the broader region. *
